Here are the proposed responses to the top 2 questions that the Minister may get asked at the ARA speaking engagement.

Many thanks

ICBC Facility

"What is the government's position in terms of the ICBC facility in Burnaby we were supposed to get?" ; or

"We submitted a business case for an Automotive Centre of Excellence to Government in November, which included being provided a facility to conduct the training in - where is that at?"

RESPONSE POINTS:

- Ensuring that those that repair our cars and trucks are receiving the right training is critically important (our ability to safely travel our roadways depends on it).
- There is certainly an opportunity to work with the ARA to ensure the training needs for the automotive repair sector are being met.
- These discussions would need to involve ICBC, the Ministry of Justice (as the Ministry responsible for ICBC), ARA, New Car Dealers Association and other Ministries including Advanced Education and Jobs, Trade and Technology).
- I understand that the ARA has put together a Business Case for a new ARA Centre of Excellence, and that staff from my Ministry have been working closely with staff from the Ministry of Justice to ensure they are aware of the ARA's proposal.
- At the end of the day, we need to make sure that those that are repairing our vehicles are receiving appropriate training that will ensure they repair our vehicles to a high standard, and that this is being done in an effective and efficient manner.
- In terms of the Burnaby facility, these are discussions that need to be had with ICBC, the ARA, Advanced Education, Jobs Trade and Technology.

Joint Industry Review / Supplier Rates

"Last year, we had an independent 3rd party review of the industry, conducted by MNP. What is government doing with that report?"

RESPONSE POINTS:

- I understand that a Steering Committee, with representatives from the senior leadership of the ARA, New Car Dealers, ICBC and Government was established shortly after receiving the MNP report, and are working towards implementing a number of the recommendations provided in the report.
- I am also told there has been strong, positive collaboration between the parties, and a commitment to continue to work together in collaboration.
- Government is keen to hear from industry in terms of thoughts and ideas in terms of how industry and ICBC can work better together.

Request

Reporter asks: "Would it be possible for me to get an interview with Dawn Drummond, Manager, First Nations Relations, MOTI Property Services? As background, the Westbank FN has a Highway Upgrade Agreement with the Province, as represented by the Minister of Transportation, to build the William R. Bennett Bridge and western approach on Hwy 97. The land exchange includes a request from WFN for a piece of land in Fauquier, on the Arrow Lakes in the West Kootenay. Questions for MOTI (Dawn Drummond, if possible) are:

- 1) The Arrow Lakes area is claimed by a few different First Nations groups. When an Exchange of Lands happens, how is it determined which lands will be considered for the Exchange?
- 2) When MOTI is in discussions with a First Nations about an Exchange of Lands, are lands with overlapping claims treated differently in any way? Is there special consideration when the lands have overlapping claims? Are the other First Nations notified of the request of the property requested in the Exchange?
- 3) Specifically in this situation, was MOTI aware of the possible push-back from the other First Nations declaring an interest in the Arrow Lakes area? Has MOTI heard from any of the other First Nations on this particular proposed Exchange? What are they saying?
- 4) If other First Nations and/ or the residents of Fauquier and the Arrow Lakes are opposed to this particular Exchange of Lands, what will happen next?"

Background

Recommendation

Suggested response:

1) The Arrow Lakes area is claimed by a few different First Nations groups. When an Exchange of Lands happens, how is it determined which lands will be considered for the Exchange?

- Each First Nations community identifies their traditional territory boundaries, which often involves overlapping territory boundaries across the province.
- First Nations identify land exchange options within the area they have identified as their traditional territory.

2) When MOTI is in discussions with a First Nations about an Exchange of Lands, are lands with overlapping claims treated differently in any way? Is there special consideration when the lands have overlapping claims? Are the other First Nations notified of the request of the property requested in the Exchange?

- The ministry has an obligation to consult with all First Nations on land decisions, including land exchanges, where traditional territories have been identified. This process is followed for all land exchanges.

3) Specifically in this situation, was MOTI aware of the possible push-back from the other First Nations declaring an interest in the Arrow Lakes area? Has MOTI heard from any of the other First Nations on this particular proposed Exchange? What are they saying?

- The ministry is currently in the process of undertaking provincial consultation on the proposed land exchange in the Arrow Lakes area, to better understand any First Nations concerns and impacts. We look forward to discussions through the consultation process.

4) If other First Nations and/ or the residents of Fauquier and the Arrow Lakes are opposed to this particular Exchange of Lands, what will happen next?"

- The ministry is first looking to better understand any concerns raised from other First Nations and/or residents. Once the consultation process is concluded, input will be considered in determining next steps.

Request

Reporter says "A major washout on Isabella Point Road has now been largely completed and we are hoping to get some stats. There was major shoring up required, so wondering just how many truckloads of rock were needed? Any other details of repairing the bank or roadway would also be appreciated. The other thing is a sharp edge has been left at the top of the bank, so can you find out if any safety railing or other features have yet to be installed or if it will be left as is?"

Background Follow up to inquiries Feb, Apr, June on this repair project that is now complete.

Recommendation Provide background

Suggested response:

During the erosion repair work to the bank at Isabella Point Road, we had a ministry geotechnical engineer work with the maintenance contractor who also had an environmental monitor overseeing the project. The repair used appropriately 135 truckloads of rock that was sourced from a local quarry on Salt Spring Island. The road itself did not require any repair.

There was no roadside barrier at this location prior to the bank erosion incident, but ministry staff are currently undertaking a review to see if barrier or other measures are warranted and will make a determination on completion of this review.

I am a reporter working on a story for Engineering News-Record. I wanted to confirm some details surrounding the recent decision by the province to reexamine options as it relates to the Massey Tunnel and the proposal for a 10-lane bridge.

I wanted to get the names of the two final bidding teams and confirm that they are being paid up to \$2 million each to offset their costs to date. I also wanted to confirm the province has spent \$66 million so far on the estimated \$3.5 billion project.

What is the timeline both for picking someone to lead the technical review and for the technical review itself? When does the province anticipate making a decision on what option to move forward with?

Also, what will a new study be able to determine that hasn't already been looked at before? Supporters of the proposed bridge point out that there are already 14,000 pages of studies and engineering reports on the issue that back up the bridge project.

The review will focus on what level of improvement is needed in the context of regional and provincial planning, growth and vision, as well as which option would be best for the corridor, be it the proposed 10-lane bridge, a smaller bridge or tunnel.

Hello Minister,

I hope this finds you well. I followed Todd Stone's questioning of you during Question Period today regarding the cancellation of the Massey bridge procurement. The former minister had a less-than-desirable record in running the Transportation Ministry from a variety of perspectives, including the deliberate obstruction of the public's right to know the costs and contracting details of major projects. There is mounting evidence of systemic waste and/or corruption in the Transportation Ministry.

I was, however, dumbfounded when you said that you cannot provide bid information. There is no basis in law for that statement. As a former journalist, I hope you can be sympathetic for the public's right to know.

Further, you said: "On this side of the house, we care about public spending..." I am hoping you will put those words into action.

I want to bring to your attention an important decision three years ago by the Office of the Information and Privacy Commissioner, which ordered the release of information about bidders and bids on a City of Vancouver contract.

A link to that decision and a summary are below.

Minister, the previous government released the names of the three groups that were bidding for the Massey bridge project. One of those groups includes SNC-Lavalin, a company that has a horrendous record of corruption around the world. When you announced the cancellation, you said there would be two groups that would receive the \$2 million each in compensation.

There is no basis in law for withholding the names of the two bid groups that are receiving that compensation. I will vigorously defend my right to access that information and it would be poor optics for the NDP, which promised transparency, to resist disclosure.

I am asking for you to please provide me the names of the two bid groups that are receiving compensation for cancellation of the Massey bridge procurement.

The City created a record in response but withheld some information related to the value of each proposal and information that disclosed the term of the previous pay-by-phone parking services contract it awarded because it believed disclosure would be harmful to the financial or economic interests of a public body (s. 17(1)(d) and (f) of FIPPA) and harmful to the business interests of a third party (s. 21(1) of FIPPA). The adjudicator determined that these sections do not apply and ordered the City to disclose the information.

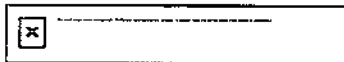

Recommendation

Three bidding teams were invited to participate in the Request for Proposals stage of procurement for the George Massey Tunnel Replacement Project.

They were:

- o Gateway Mobility Solutions includes Canadian firms ACS Infrastructure Canada Inc. and Aecon Concessions and American firms HOCHTIEF PPP Solutions North America,

Inc. and Star America Infrastructure Partners as equity partners as well as Flatiron Constructors Canada, Dragados Canada Inc. and Aecon Infrastructure Management Inc. of the United States as the design build contractors.

- o Pacific Skyway Partners includes Canadian firms Fluor Canada, Ltd. and SNC-Lavalin Capital Inc., and John Laing Investment Limited of the United Kingdom as equity partners as well as SNC-Lavalin Constructors (Pacific) Inc., Fluor Canada, Ltd., and American Bridge Company as the design build contractors.
 - o Lower Mainland Connectors includes Kiewit Canada Development Corp. of Canada, Macquarie Corporate Holdings Pty Ltd. of Australia, and VINCI Concessions of France as equity partners as well as Canadian firms Janin Atlas Inc. and BA Blacktop and Peter Kiewit Infrastructure Co. of the United States as the design build contractors.
- The ministry cannot name the proponents that will receive stipends as a result of the cancellation of procurement, since we are obligated to respect confidentiality.
 - The qualifying bidding teams are entitled to a maximum of \$2 million dollars each for the cancellation. As part of the process, the bidding teams must file claims for this compensation.

The other contracts on the project, for example that for MMM Group, the Owner's Engineer, are "as and when" contracts – meaning that they are only paid for work that the province requires them to do. With work on the 10-lane bridge project winding down while the review is underway, their work is significantly reduced. However, their expertise is still available to the ministry if required.

Geoff Freer will remain in his role as Executive Project Director, albeit in significantly scaled back role as current activities are completed. As the review gets underway and we determine what its needs are in terms of resources and expertise, we'll have a better idea of the work level required over the coming months.
