In preparation for the upcoming tender for the 10-year road maintenance contract on Savary Island, we have prepared a report documenting the poor road conditions that put public safety at risk. The current MoTI classification of Savary roads is wrong and must change in order for the proper maintenance standards to be implemented from here onwards.

In 2017 the Association of the Savary Island Committee undertook an extensive island-wide evaluation of all main and secondary roads in order to assess the problems and come up with solutions that will make the roads safe, and reduce maintenance costs in the long run.

The report includes:

- the negative affects on residents and First Responders (fire and medical)
- history of problems caused by severely under-maintained roads traffic counts justifying reclassification • detailed road evaluations and recommendations for improvements • supporting maps and documentation

Please review the attached report and let us know early in 2018 with whom we can meet to discuss appropriate road classifications for Savary Island roads, and an MoTI commitment to the level of maintenance and/or reconstruction that equates with the reclassifications.

Just a short note to thank you for your generous allowance of time this morning to meet with me and to hear our concerns regarding the safety issues and road conditions of our Savary Island Community. As discussed, I will forward by email our report by the end of this week. I also will drop off at your office a USB Flash Drive with this report on it for your use as you deem appropriate. This report will be broadly distributed to local, regional and provincial MOTI management, The Honourable Nicholas Simons, MLA (Powell River/Sunshine Coast) to your office, and, of course, our Savary Island Community and Association of Savary Island Committee Board (ASIC). If possible, we would very much appreciate the opportunity to meet with the Minister and her staff the last week of January to review our report and our concerns. We would be available from January 22nd onward and would be able to bring a representative of the ASIC Board, the Savary Island Volunteer Fire Department (and First Responders Ambulance Service), and representatives (2) of the ASIC Transportation Sub-Committee who developed this report. Our contingent would total no more than four Savary Island representatives in all.

Safety is the overriding concern for First Responder access (fire and medical) and for public safety on our roads on Savary Island. It has always been the driving factor for our efforts to achieve better road construction and maintenance on our Island. The historical misidentification of road category based on outdated information of our road usage on Savary has led to the perpetual poor road conditions that have become unacceptable to not only First Responders, but to island residents as well.

Subject: Read Island Concerns

Good Morning Lynne,

As per our discussion this morning, here are some highlights from the trip to Read Island last week (December 7th):

- > The brushing that has been completed to date is the standard swaths clearing all the brush and vegetation near the road, it is not completed in a selective manner (i.e. targeting specific species and leaving others)
- Brushing is generally completed on entire road sections, however, on Read Island the subcontractor was asked to target corners and areas with sightline issues where we have road dedication
- There are large sections of roads that are unsurveyed travelled roads (UTRs) where MoTI has no dedication and only looks after the road surface – the land on either side is typically private property
- The plum tree that was cut was located within 1 metre of the road edge, well within the brushing swath – if Emcon had received notification that it was of significance it could have been flagged and protected from cutting
- > I discussed road improvements with Island Timberlands they will be completing some brushing, ditching, and drainage repairs on their private lands adjacent to the road
- > The Ministry has no jurisdiction to request a leave strip along the road where Island Timberlands is conducting logging operations as it is private property
- > The Ministry will be issuing a permit to Island Timberlands for works on the road and will be monitoring the condition of the road over the next year until log hauling is complete
- > Emcon will continue to monitor the subcontractor, as there is still some brushing, ditching, and gravelling to be completed
- > The area where we received complaints that the material was too coarse will be remediated this week

> The section near the elementary school that requires brushing will be completed by hand to address concerns raised by residents

The rest area at the Alexandra Bridge is managed by BC Parks, MOTI has nothing to do with that location. The Executive Assistant for the Minister of Environment is Reamick Lo, she may be able to assist.

The rest area on Hwy 7 is the Johnson Slough Rest Area, this rest area has been closed over the winter months for more than 25 years. History showed its limited use over the winter months did not justify the costs of maintaining it. It is only 15 kms east of Agassiz or 15 kms west of Hope so about a 10-12 min drive either direction where washroom facilities can be easily found.
