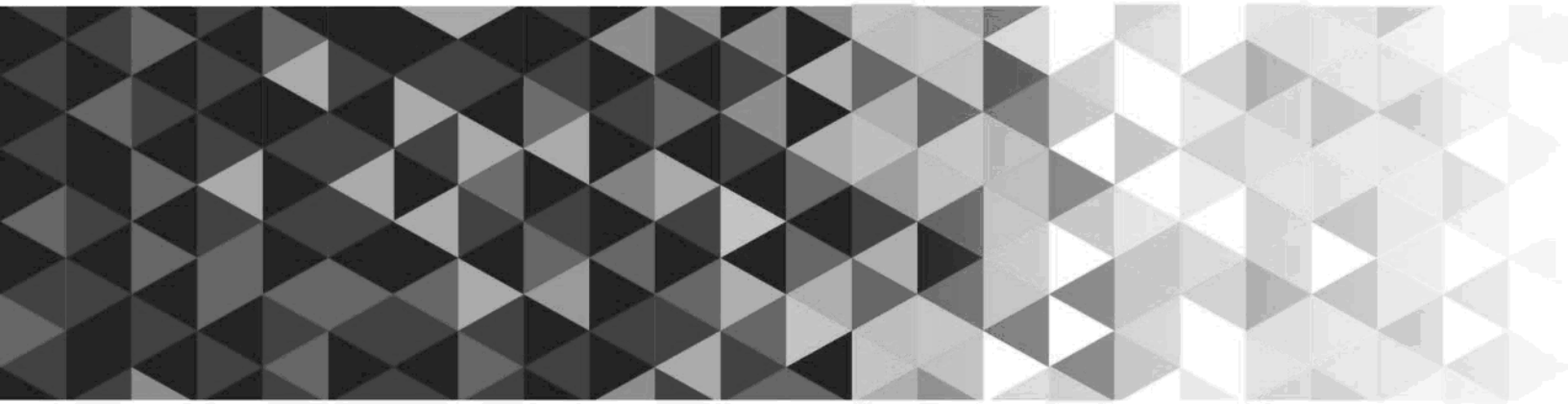

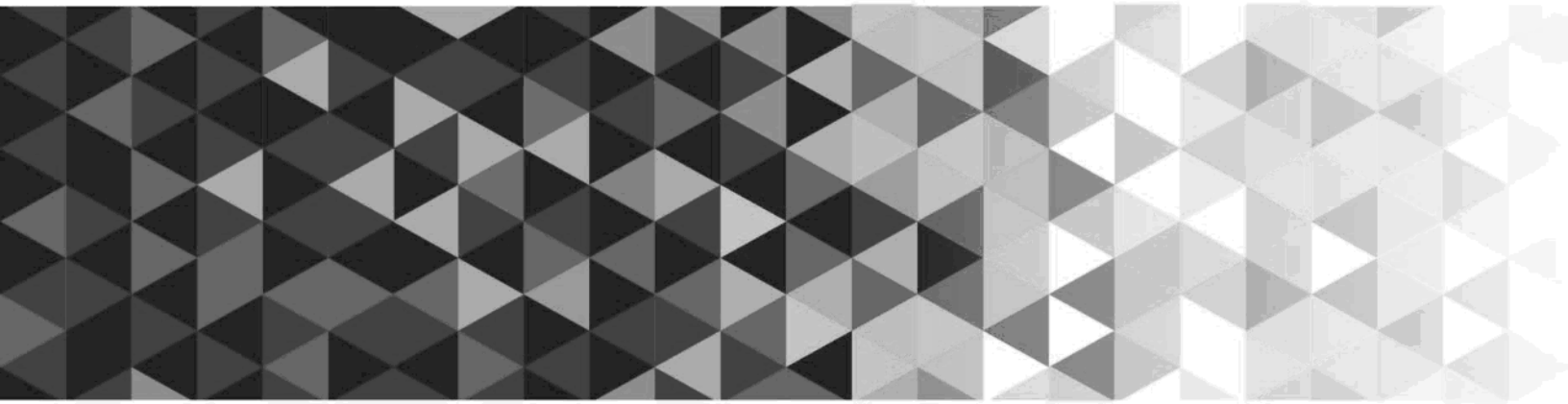

### *A message from Grant Main, Deputy Minister*

Good morning,

You may be aware that on Monday, July 16, Premier John Horgan announced that the provincial government will apply a new Community Benefits Agreement (CBA) to the Pattullo Bridge Replacement project and selected upgrade projects on the Trans-Canada Highway between Kamloops and Alberta, as early adopter projects. A link to the announcement is [here](#).

A Crown Corporation, BC Infrastructure Benefits Inc., has also been established to provide the labour workforce for the construction of select infrastructure projects delivered under the CBA. The new organization is expected to be fully operational in the fall of 2018.

The CBA is the first step towards a broader Community Benefits Framework that is still under development, and it will incorporate community benefit objectives across public sector infrastructure projects. Government's objectives are to create benefits in the form of good paying jobs, increased opportunities for Indigenous and equity groups traditionally under-represented in the skilled workforce, increased apprenticeship and training opportunities and increased access for B.C. residents closest in proximity to the projects. This supports an overall objective to grow the province's skilled workforce for the future and provide long-lasting benefits to British Columbians and their communities.

The application of the CBA will initially apply to select infrastructure projects, as mentioned above, and is only one approach to achieving community benefits. Next steps are to explore approaches to incorporate community benefits on other public sector infrastructure projects through procurement and contracting practices. This is an exciting opportunity to shape the future of infrastructure delivery, and we look forward to sharing more about this initiative as work progresses in the coming months.

I would also be remiss if I did not take this opportunity to extend my sincere appreciation to the team that worked tirelessly on this important policy file, bringing the CBA and the



Community Benefit Framework to this stage. It was a monumental effort, across several departments (and ministries), and everyone did extraordinary work. Thank you!
