Hi Will, James & Lynne this one will need both Minister & Premier QUOTE approvals please.

Work is slated to start on this project on the week of June 11th (date is fluid at this point) so we are planning to issue the NR on June 5th to be able to say ³Next week, construction crews will begin building a new two-lane bridge on Gillespie Road at Roche Cove, which is an important alternative route to Highway 14 during closures.² This is part of the suite of projects for Highway 14 that were announced by the Premier. Therefore, if the Premier and/ or the Minister would like to do a photo op in coordination with this NR (ie. at the site with construction crews) we can help arrange it. Please do let us know.

2 QUOTES for final approval:

³A new bridge at Roche Cove has been a long time coming with more and more traffic coming to our growing region. It's frustrating and inefficient to wait and take turns on the old one-way bridge, and unsafe for the drivers, pedestrians and cyclists who use this crossing,² said Premier John Horgan, MLA for Langford-Juan de Fuca.

³Gillespie Road is an important link for people in Sooke, those accessing parks, lodges and other recreational spots, and is a critical alternate route when the highway is closed. Constructing a new, wider bridge ensures traffic can flow safely and effectively

as people travel to, from and within Sooke,² said Transportation and Infrastructure Minister Claire Trevena.

Outlook:

BC River Forecast Centre - May 22nd, 2018

Ongoing flood risk from this season's snow pack is primarily associated with the remaining mid-to-upper elevation snowpack. In low-to-mid elevation watersheds, snow melt risks have subsided. Except for watersheds draining high mountain terrain, risks from snow melt are expected to last another 1-3 weeks. This primarily includes the Okanagan Lake system, Fraser River, South Thompson River (including Shuswap Lake and Mabel Lake), North Thompson River and Kootenay region. Future risks of flooding beyond that period will largely be the associated with heavy rainfall events.

The River Forecast Centre will continue to monitor snow pack conditions and will provide an updated seasonal flood risk forecast in the June 1st 2018 bulletin, which is scheduled for release on June 7th.

0930 hrs May 22, 2018

The River Forecast Centre is maintaining a High Streamflow Advisory for:

Fraser River including the mainstem from Lytton through Hope and the Fraser Valley
Persistent warmer than normal temperatures across British Columbia for the past three to four weeks has led to a much earlier than normal runoff period for the Fraser River. Hot temperatures and increased snow melt runoff last week worked its way into the Lower Fraser Valley over the weekend, with levels reaching approximately 11,000 m³/s at the Water Survey of Canada gauge at Hope (08MF005) and nearly 6.0 m at the Mission gauge (08MH024) .

Flows are expected to remain elevated through this week. With hot weather forecast over the headwater tributaries in the Upper Fraser and Thompson River basins, increased snowmelt runoff may lead to higher flows along the lower Fraser River into the coming weekend. Current modelling is indicating that flows should remain near current levels, however increases above current levels are possible.

MOE does not plan to open the road until 04:00 tomorrow morning

Traffic Management:

- Highway 1 volumes are light NB
- Queues are clearing on Finlayson Arm Road/Millstream Rd
- Highway 14 has significant volume but operating OK with large platoon; platoon goes back to the 4-lane section but is relatively light back to Langford
- Will be watching queues closely over the next couple hours with regular updates from the scene in order to make the call about:
 - o (1) closing down the PMR detour approx. 3 hours before reopening
 - o (2) reopening the Finlayson Arm road detour in coordination with the shut down of the PMR detour; Finlayson Arm would be operated for both SB and NB at that time so we need to watch volumes carefully
- Expect that after the dinner hours will see another smaller spike in traffic volumes (assume many wanted to wait out the closure and went for dinner)
- We have 6 District staff in the field distributed on both sides of the closure coordinating with other agencies, working with the MC on traffic management and monitoring queues
- We have 2 CVSE staff out on the Detour route also assisting with some traffic control duties
- Working on a plan to switch out/rotate staff as this continues through the night
- RCMP have been requested to provide additional presence on detours

- A crash has caused a full closure of the Malahat at Goldstream Park, which is causing considerable delays for travellers.
- The RCMP are the lead regarding the nature of the crash and the Ministry of Environment is the lead on the fuel spill, who have indicated the route may remain closed until approximately 10 p.m. while the investigation is ongoing.
- We recognize the inconvenience to travellers when our provincial roads and highways are closed during these investigations and would like to thank everyone for their patience and understanding.
- Ministry of Transportation and Infrastructure staff and our maintenance contractor crews are working closely to support all the agencies involved. We are also offering assistance to people in the traffic queues by providing water, bringing portable toilets to the site, letting folks know about estimated wait times and the current detour routes, and checking on anyone with possible health issues.
- The Pacific Marine Route is the current detour for traffic in both directions but drivers are advised to watch for traffic control personnel who will be assisting at the single lane bridge locations. The travel time between Langford and Duncan is currently estimated at 3 hours.
- BC Ferries has also called in additional staff to accommodate the unforeseen traffic volume at the Brentwood Bay-Mill Bay crossing, and is providing three extra round trip sailings (leaving Brentwood at 7:30, 8:40 and 9:50; leaving Mill Bay at 8:05, 9:15 and 10:25 p.m.).
- Another BC Ferries option is to travel from Swartz Bay to Fulford Harbour on Salt Spring Island, then from Vesuvius to Crofton.
- Travellers should continue checking www.DriveBC.ca or @DriveBC on Twitter for the latest traffic advisories and information regarding this closure of Highway 1 and possible times for re-opening.

If asked: What happened to traffic using Finlayson Arm?

- *This route became quickly overloaded it was taking an additional 3 hours due to the number vehicles trying to use it and it was also not available to commercial vehicles and vehicles hauling trailers. Now that traffic control personnel have been deployed, the Pacific Marine Route is the current detour available.*

If asked: What about building a bridge as an alternative route?

- *The 2007 review took a comprehensive look at building a bridge and connecting Brentwood Bay to Mill Bay.*
- *The bridge options ranged in length from 1.4 to 4 kilometres, and a crossing of that size would be upwards of \$1 billion for the bridge alone.*
- *The many logistical challenges include seismic considerations, requirements for shipping, approvals by Coast Guard and Navigable Waters Canada, and the connecting road infrastructure that would be needed on the Saanich Peninsula.*
- *There would be significant environmental challenges as well including parkland, the watershed for the Greater Victoria water supply, and disruption of sensitive ecosystems.*
- *First Nations¹ interests and archeological impacts would also need to be considered.*
- *Ministry staff have also heard from many in the community that bypassing the Village would negatively affect those businesses that rely on tourist traffic.*
- *As a result, we need to and will focus in this study on more immediate improvements that can be accomplished through work on the existing alignments such as the upgrade through the Malahat Village that is on track to be finished later this summer.*
- *In the long term, the ministry intends to continue to work towards 4-laning the route.*

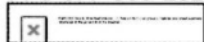

As you know, the Ministry worked very closely with BC Ferries for several months to negotiate an agreement that would enable government's ferry fare relief commitments which went into effect on April 1st, 2018. This included freezing fares on the three Major routes, reducing the fares on all other routes by 15 percent and reinstating the 100% discount on seniors' passenger fares on travel Monday through Thursday. To achieve these reductions, government increased the subsidy to BC Ferries by \$59 million over two years, the highest single increase in more than a decade.

As part of those discussions BC Ferries indicated the current fuel rebates of 2.9 percent on the Major and Minor routes and the 1.9 percent on the Northern Routes should be eliminated. While the fuel deferral account is a separate mechanism to even out the volatility of fuel prices, BC Ferries volunteered to pay down the fuel deferral account as part of its contribution towards the ferry fare relief initiatives, delaying the elimination of the fuel rebate.

During the last week, I was surprised to learn that BC Ferries was going to announce publicly the removal of the fuel rebate, less than two months after government's fare reduction strategy was put into place. While I understand the pressure on the fuel account, typically BC Ferries provides sufficient notice to government prior to taking actions that will impact the cost of fares. This lack of notice does not allow government an opportunity to determine whether it can provide additional funding to offset the impact on ferry users.

I am extremely disappointed that when I requested a two week delay in the announcement, Mark Collins, President and Chief Executive Officer, would not consider my request. While I appreciate it is fully in BC Ferries purview to make decisions about the fuel rebates and surcharges, I am very concerned the Company considers one week sufficient notice to government of this type of action. Obviously, the company has been aware of its circumstances for some time and it is difficult for me to understand why more notice couldn't have been provided and, in addition, there seems to be no willingness to delay the announcement by two weeks.

I would ask you, as Chair of BC Ferries, to request the CEO to reconsider his position and allow our senior officials to work through a solution to this situation. Our government is committed to fare affordability and to uphold the public interest of the citizens and ferry users of this province.

Outlook:

The Interior situation has stabilized a bit today and some water levels have receded slightly in some areas. Conditions may still decline with bands of precipitation across southern BC forecast for later today. Temperatures will start to increase 6-8 degrees over seasonal again over the weekend with freezing levels rising to 3000m or higher. River flows are expected to exceed the 1 in 100 return period along the Kettle and Granby Rivers in the next 48 hours which has significantly impacted Grand Forks.

- Boundary - including West Kettle River, Kettle River, Grandby River and surrounding tributaries
- Salmon River near Salmon Arm Ministry is closely monitoring the Salmon River Bridge on the TCH in Salmon Arm, as water levels are currently at the stringers. Hwy 3 Flood waters receded overnight, allowing for H3 to reopen at noon today. Water levels remain stable. Engineers reassessed the site and based on forecast river level have recommended additional work to be done to raise the rail grade a little higher. This is minor overall and we will be undertaking this work tonight and early tomorrow.

H33 at 8 Mile Corner MC has been remove debris all day but in the last few hours, the culvert that was running clear has been partially blocked. This has caused the creek to begin backing up and is rising about 2 feet per hour. There is about 5 feet before the highway will be overtopped and we will have close. Cariboo District

Barnes Lake Road (Ashcroft Area) road is closed due to flooding and an overwhelmed culvert. System feeds the dammed Barnes Lake which is already at capacity. District is working with EOC to try and redirect flows to help prevent more widespread flooding.

We still have a temporary bridge at the site for SLAT in addition to the 2 temporary pipes in the 2-lane section. The new site noted on Hwy 33 remains stable and we are monitoring, but no immediate threat. However, we are keeping at SLAT for safety.

The site in Peachland on Highway 97 is developing as a concern. As noted earlier, a slide uphill on municipal infrastructure impacted the storm drain system and water is now forcing its way to the surface on the Highway. Municipal efforts to fix have so far been unsuccessful and MAY require a 6m excavation of the highway to reach their storm drain system. This will have a major impact so all efforts are being taken to avoid. Staff are meeting at the site today to discuss all options.

Further to what Mark has stated below, I offer the following:

One of the Salish was unavailable until end of April due to Salish critical warranty. Raven is coming back online today and besides its regular load we will utilize it as much as possible. I don't want to get too deep in the weeds but the reason we could not get another Salish into play before this stems from crewing and route clearances. The system has complexities (believe me we work hard to try and reduce the complexities for our customers) but overall we must ensure we remain safe and not create other knock on effects. The following is the plans for Raven:

Raven plans include sailing out of TSA Friday, Sat, Sun, Mon and Thu for next two weekends and schedule tactics as follows:

- Friday: Raven on Rte 9A sailing times to minimize changes of booked and reserved customers travelling for weekends, adding a Sturdies stop mid-afternoon
- Saturday: cancelling Rte 9A sailing times, Raven does Rte 9 sailings starting at TSA and Eagle does Rte 5 sailings but starting at Sturdies supports day tripper to/from SWB
- Sunday: Raven on Rte 9A with extra Sturdies stop; Eagle stays on Rte 9; Mayne does Rte 5; cancel Rte 5A which has lot of DG and done by Quinitsa (will take traffic on non-DG legs) supports heavy return traffic from SGI and SSI to the mainland
- Mon and Thu the Raven will do the Rte 9 schedule starting TSA at 1010 and then do another trip TSA-STB-VB after that
- Tues and Wed no Rte 9A service existed; we have no crew for these days;

General scheduling approach:

The sailing schedules are different for each of Mon-Thu, Fri, Sat and Sun and account for about 1/3 of all online sailing information to the customers. The disruption spanned two seasons Off Peak and Shoulder losing a ship required all schedules to be rebuilt, twice. The strategy for service recovery was to put more focus on weekday service on commuters & day trippers into Victoria, utilize thru-fare more and weekend service more onto Vancouver traffic while changing as few sailing times as possible. The Quinitsa was brought down to provide DG service and to supplement weekend service to/from SWB.

We have populated and posted schedules until the end of May 16th online. We have taken steps to bolster our call center as much as we can to try and keep up with the customer inquiries.

Again, we recognize the inconvenience and impacts that arise when disruptions occur to the system and we continue to do all we can to have viable alternative plans and recovery as quickly as we can safely.

Please be assured we are doing everything we can to minimize the impact but we do not have spare ships, as you know. That being said, the Quinitsa, although small, has been redeployed to the southern gulf Islands to provide everything we can.

We anticipate the service will be disrupted until the Cumberland can be returned to service. We are pulling out all the stops to make that as soon as possible.

This jointly from Eva Hage and me.

Our FACs are privileged, even obligated, to take concerns of our communities to BCF. In most cases, these are received and dealt with satisfactorily at the working level. Occasionally, the need is such that issues have to be escalated to a higher level. Just rarely do we feel a compelling need to bring specific concerns to your attention.

This is such a time.

With the Cumberland out of service, a number of adjustments have had to be made. Some have gone well, considering the circumstances. Others, not so well.

This message is about just one of the ~~C~~enot so well'

adjustments: cutting out the AM Route 9 sailings. That made sense, was probably unavoidable, when the Raven was engaged on Route 17. However, the Raven is now back, scheduled for shoulder season weekend service on Route 9. The Eagle is providing AM and early PM service on Route 5, and late PM service on Route 9.

Our point is that cutting Route 9 service effectively in half, backstopped by through-fare service, may seem like providing reasonable service to all. But it's not. While it's damaging to all the islands, it's catastrophic for Galiano. Route 9 is their lifeline, much more so than for the other islands. People simply aren't prepared to visit the island, when the 55 minute sailing becomes a 4-hour, minimum, trip with uncertain connections through Swartz Bay. Starting too early and arriving too late. Hotel and B&B bookings are being cancelled at substantial financial loss to island businesses. New bookings have evaporated. Trips to town for medical, business purposes, flight connections or picking up goods for the island are now having to be cancelled, or people have to leave the night before, paying for overnight accommodation, or fly, assuming they don't need their car. The impact is far greater than we believe was anticipated by the BCF team.

We have suggested using the Raven fully on Route 9, on the winter schedule, and the Eagle on Route 5, in place of the Cumberland. That would entail moving the Eagle, with its crew domiciled on board, to Swartz Bay, and the Raven to Long Harbour, with its crew domiciled on board. We were told when these ships were ordered, addition of the crew quarters meant these ships could go work anywhere they were needed. Now is the time to utilize that capacity, as Galiano is literally in a crisis situation. We've been advised that BCF is prevented from doing this by a shortage of trained crew on the mainland side. Yet there was full crew coverage on the Raven last summer. Even extending the number of days the existing watch can work would help. We suggest this is a time to treat this as the extraordinary situation that it is, and to find a way to get through those challenges, given the extensive resources BCF has at hand. We expect BCF probably has better ways of staffing those vessels, perhaps including some Swartz Bay staff. We don't care how you do it. But we care

deeply that you do it.

And soon. We're told that it's hoped the Cumberland will be back by May 18. Not promised. Not committed. Hoped. So far, BCF has missed at least three hoped-for return dates, leading us to have no confidence the 18th date will be met. We're talking about two and a half weeks and apparently, quite possibly longer, with tourism season ramping up. That's too long.

An option previously said to be considered by BCF staff, operating a rescue boat shadowing the Cumberland, might be a viable, if odd, solution warranting consideration in light of the length of the outage and the resulting community damage.

We've attached a few of the Galiano comments from Facebook, messages to BCF, observations of FAC members and conversations on-island. The mood there has moved from disappointment to frustration to fear (financial survival) to anger.

As your advisors, we urge you to have a second look at bringing the Raven up to full capacity and delivering some much needed hope to Galiano, after a very difficult, seemingly hopeless, ten days. The situation there is desperate.
