### **Pattullo Bridge Replacement Project moves forward**

VANCOUVER – The Province has selected three pre-qualified bidding teams to participate in the competitive selection process to design and construct the new toll-free Pattullo Bridge that will deliver a safer crossing and easier connections into Surrey and New Westminster.

"The existing Pattullo Bridge is nearing the end of its useful life," said Minister of Transportation and Infrastructure, Claire Trevena. "The selection of the three teams gets us closer to breaking ground on this project that will improve safety and reliability for residents, commercial vehicles, cyclists and pedestrians."

The three bidding teams are:

The \$1.377 billion Pattullo Bridge Replacement Project will provide improvements for everyone using the bridge and create thousands of jobs and opportunities for British Columbians.

The new four-lane crossing will replace the existing Pattullo Bridge and will have wider lanes and better connections to road networks on either side of the bridge which will help traffic flow more efficiently. It will provide a safer connection for commuters, commercial vehicles and first responders. The new bridge also features dedicated pedestrian and cyclist lanes separated from traffic by a barrier on both sides of the bridge.

The project will be funded and owned by the Province of British Columbia. The project will be delivered by the Transportation Investment Corporation, a Crown corporation of the Province of B.C. that will provide oversight and management of major project delivery.

The RFP for the project will be posted on the project website.

#### **Quick Facts:**

- The approved budget of \$1.377 billion represents the full cost to complete the project, including procurement, project management, construction, removal of the existing bridge and interest during construction.
- The Province will use a design-build-finance model to build the Pattullo Bridge replacement.
- The bridge will have wider lanes, which will allow traffic to flow more safely and efficiently and improved connections to road networks on either side of the bridge.
- It is expected to open in 2023.
- The new Pattullo Bridge will be delivered under the Province's Community Benefit Agreement.

- Safety is our top priority, and we will have the road reopened as soon as it is safe to do so.
- Drilling and blasting has occurred at the site over the past few days and continues today.
- This is a very complex and active rockfall site and geotechnical experts remain on site trying to stabilize the slope to allow for the safe reopening of the highway.
- There are currently 10 rock scalers, a rock hammer and 2 excavators on site, along with off highway rock trucks hauling material off site following the blasts.
- The ministry will be determining road opening options based on the progress that is made today.
- An alternate route for light vehicles (5 tons or less) is available on the 201 Forest Service Road, which is accessed off Highway 33 near McCulloch Road in Kelowna, and via Warren Avenue/Carmi Avenue in Penticton.
- The road is in good driving condition. Road maintenance vehicles will be actively working on the 201 Forest Service Road to ensure continued safe road conditions.
- Drivers using this route can expect up to an additional 90 minutes travel time. The speed limit along the 201 Forest Service Road is 50 km/h, and people must drive with caution along this route, which does not typically experience a high volume of traffic.
- Travel using other alternate unmaintained routes is not recommended and is being discouraged for safety reasons.
- Larger vehicles and commercial trucks must detour via Highway 97C, Highway 5A and Highway 3A to Highway 3.

### **Broadway Subway project launched with procurement step**

VANCOUVER – The Broadway Subway is moving forward with an invitation to bidders to submit their qualifications to design, build and finance the project.

As part of the competitive procurement process, a request for qualifications (RFQ) has been released on BC Bid to identify a contractor to design, build and finance the Broadway Subway project. The RFQ will close in April 2019. The ministry will then select up to three respondent teams to participate in the subsequent phase of the competitive selection process, which is the request for proposal stage.

Additionally, early work is now underway to prepare for subway construction starting in 2020. Current activities involve installing trolley wire poles and upgrading intersection signals and lampposts on routes adjacent to the corridor. This work will enable future trolley bus detours and keep people moving during construction of the Broadway Subway.

The project will be delivered under the Community Benefits Agreement (CBA) announced by the provincial government last summer. The agreement generates benefits to the surrounding community by providing opportunities for local workers, Indigenous people, apprentices and other groups.

The Transportation Investment Corporation is delivering the project on behalf of the Province. TI Corp is a Crown Corporation with the legislative authority to deliver major transportation projects, similar to its role on the Port Mann

Bridge project. With tolls now removed on the Port Mann Bridge, TI Corp will be providing oversight and management of the delivery of other major projects across the province.

Sixty local and regional governments and First Nations communities have been approved to receive their share of approximately \$1.5 million in provincial emergency preparedness funding to support evacuation route planning.

Since the September 2017 Budget update, communities and governments throughout British Columbia have received more than \$17 million through the Community Emergency Preparedness Fund (CEPF). Now, another 60 applicants are receiving up to \$25,000 each, specifically for evacuation route planning. The successful applicants are in every corner of B.C.

"We can't predict exactly when a disaster may hit, but we can help our partners prepare so that if people have to be evacuated, they're doing so in the safest, best way possible," said Mike Farnworth, Minister of Public Safety and Solicitor General. "Investing in communities and people is top of mind, and this is another step toward ensuring people's safety in the event of a large-scale emergency situation."

Funding for the evacuation route planning component of the CEPF was announced at the Union of British Columbia Municipalities' (UBCM) convention in September 2017. This funding is part of a \$33.5-million plan designed to help communities prepare for, and respond to, disasters.

"The programs and projects announced today will help make our cities and towns more resilient," said Jennifer Rice, Parliamentary Secretary for Emergency Preparedness. "On the heels of two of the worst flood and wildfire seasons in our

province's history, we need to work together to help our communities prepare for emergencies so they are better positioned to respond and recover."

The CEPF is a suite of programs designed to enhance the resiliency of local governments and their residents. The Province provides the funding, which is administered by UBCM and divided into five streams:

- Flood Risk Assessment, Flood Mapping and Flood Mitigation Planning
- Emergency Social Services
- Emergency Operations Centres and Training
- Structural Flood Mitigation
- Evacuation Routes

The next deadline to apply for funding from this program is Oct. 25, 2019, regarding Structural Flood Mitigation Intake 2.

**VICTORIA** - Just last week, John Horgan's BC NDP government restored 2,700 sailings on 10 routes that the BC Liberals had cut. In yesterday's question period, the BC Liberals criticized the new sailings, supposedly on environmental

grounds – while simultaneously making the case for more tanker traffic from the Kinder Morgan pipeline.
