Hi Jim,  
well here we go; new contractor, same people, same service! I wonder if you are aware that Mainroad have a worker going around with a small chain saw on an extension pole pruning branches off of roadside trees that are theoretically "liable to rip the mirrors off the snowplough"? Thompson Road is well on the way to looking like a Parisian Boulevard! Well, not quite, perhaps, but I, and<sup>s.22</sup> recently noticed a lot of branches by the side of the road, and two distinct piles at the edges of my property. (I'm not referring to<sup>s.22</sup> brush fence, which has an entirely different and intentional purpose.) This road had already been well attended to by the hydro trimmers in the last few weeks, so we were a little surprised to see this. The hydro crews, (Davey), chip their trimmings, and as it was all now looking quite messy, I called Hugh to ask when they would clean-up. They have no intention of doing so. Hugh says the branches will rot down by the time he gets a truck and/or a chipper. I said that might be thirty years or so! Anyway, as<sup>s.22</sup> points out, we are supposed to be following Firesmart rules around here, and this seems utterly irresponsible, and frankly a bit of a slap in the face to neighbourhoods that try to maintain some semblance of aesthetic care, whether on the trails or residential streets. Hydro informs residents of their intentions. Mainroad not at all, and there are alders at the very end of Thompson that I would have insisted were not touched had I known of their intentions as they discourage walkers from entering the area of my septic tanks. One pile of branches is across a legal easement that crosses my property. I believe that Mainroad should be held responsible for cleaning up a mess created by them. In fact, I think some clarification of their contract responsibilities overall would be in order.

I realize there are more many important issues that consume your time, but Mainroad perhaps needs a nudge from someone with a little more clout than a solitary resident.

Please let me know what you think about this.

### **BC TAXI SYSTEM 'A REGULATORY FAILURE'**

It was, it is and it will be a regulatory failure.

#### **How non-owner taxi drivers will benefit from these amendments.**

Modernizing Taxi Regulation 2018 and amendment of PT Act will not improve taxi service.

PTB after Dr. Dan Hara's report allowed existing Taxi Companies one-time opportunity to increase their number of taxis by 15%

Just by increasing number of taxis service will not improve, the reasons are:-

Some of the taxis before implementing new 15% increase are without drivers and parked in taxi companies' lots and some in owners' driveway.

**YVR issued 54 temporary taxi permits** to existing 19 companies last summer and later on made them permanent. These taxi companies sold them and those taxis started serving YVR

passengers not their own city passengers; in other words shortage of taxis in their respective towns.

After getting 54 taxis these taxi companies never applied to PTB to amend their condition of license and started operating at YVR without paying any fee to city of Richmond & PTB.

In November 2018 monthly meeting YVR approved 28 Taxis to Garden City Cabs to be operational December 2018.

In October & November monthly meetings YVR announced that it will issue 115 more taxis (pickup rights) to existing companies, meaning thereby defeating the purpose of 15% more taxis in Metro Vancouver as recommended by Dr. Dan Hara.

**His report and recommendations are incomplete, ineffective without considering YVR taxi shortage, supply and how taxi system works at YVR.**

Next year there will be 722 taxi serving YVR, it is 1/3 of total taxis 2500 in Metro Vancouver.

In 'Select Standing Committee on Crown Corporation' Jan 8-10, 2018 no one appeared from YVR knowing that he will be unable to answer sharp questions of committee members and in written submission no sensible input to improve the taxi service at YVR, rather YVR is interested to increase its revenue. No effective input Dr. Dan Hara.

## **HOW MUCH MONEY YVR MAKING FROM TAXIS**

### **YVR 'NOT FOR PROFIT'?**

With existing taxis 579 + 28+115 new total 722 and monthly fee of \$400 per taxi and yearly revenue of \$3,465,600 but there is not enough parking for 722 taxis and no proper lunchroom & washroom facility for drivers of these taxis.

In the recent past YVR in the name of night time taxi shortage imposed condition that every taxi have to make 30 trips between 10pm - 5am; knowing well that there are not enough flights and passengers between that time period.

If any taxi is unable to make 30 trips then that taxi's pickup rights will be revoked and that will be allotted to some other taxi company and no new taxi pickup right to that taxi company.

There is transponder on every taxi's windshield and scanners one at the entrance of tunnel and other at the exit.

To mark their presence taxi operators go through the tunnel so that scanner read transponder installed on the wind shield of taxi and their trip is recorded.

To record trip taxi operators drive through the tunnel without picking any passengers, by doing that they increase the total number of trips and when total number of trips reach 820,000 and according to condition imposes by YVR \$ 1 per trip condition kick in early and drivers have to pay \$400 monthly fee per taxi plus for every trip empty or with passenger. In year 2018 YVR collected \$54000 from "fake trips".

One third of GVRD taxis have YVR pickup rights, but in summer time when YVR is busy then non-Airport taxis are allowed to pick passengers and then no taxi model year, driver training and violation of PTB imposed conditions.

In year 2019 PTB will be getting \$225,000 from 2500 taxis in GVRD whereas YVR from 722 taxis \$ 3,465,600.

Out of 2500 taxis in Metro Vancouver 1/3 will be serving YVR not their respective towns. When calculating taxis make sure how many serve YVR, town or both.

**Forming policy without including need and problems of taxi drivers serving YVR; service in Metro Vancouver cannot be improved.**

**YVR is prime fare ground for taxi drivers, ignoring, not studying and making improvements without knowledge of YVR taxi system is glaring example of taxi regulatory failure.**

## **MODERNISING TAXI**

PTB approved 15% taxi to existing taxi companies and after that YVR approved more taxis to existing taxis companies and 28 to Garden City Cabs Company and 115 to existing taxi Companies. So defeating purpose of improvement in taxi service initiated by ministry. Out of newly issued in GVRD 15% taxi 28+115 will be serving YVR defeating the purpose of this increase and shortage of taxis in towns.

## **YVR taxi Drivers Tags**

YVR is charging \$89.60 for tag from every taxi drivers who intend to pick passengers from YVR and from 1500 drivers approximately \$134,400. The tag issued is just basic one with no security feature and amount charges by YVR is unreasonable and fee for Canadian Passport is less as compare to YVR Taxi Tag.

### **YVR MONTHLY TAXI MEETINGS**

No doubt YVR ground transportation conduct meeting with taxi companies every month. The participants in these meetings are multi taxi owners and managers of taxi companies and they go there; just sit and listen to sermon of YVR ground transportation Manager Sat Gill. These taxi companies' representatives have clear instruction of taxi companies not to say anything which annoys YVR.

One recent example of <sup>s.22</sup> Director of Pacific Cabs; who highlighted in November 2018 monthly meeting the above faulty money extorting system imposed by YVR and not enough parking for 722 taxis i

s.22

YVR has clearly directed **non-owner taxi drivers** that they cannot attend meetings write directly to YVR and talk to media; if they have any concerns / problem inform their respective company manager then he will write to YVR. These managers rarely put forward drivers' concerns to YVR airport authority.

To improve service at YVR it's better to study YVR taxi system; without improving it will directly affect the Metro Vancouver taxi system. No recommendations by Dr. Dan Hara in his report regarding YVR taxi system. **Without studying YVR taxi system and effectively implementing those recommendations the money spent on entire study so far is waste.**

### **PTB and its conduct regarding YVR.**

In the past PTB has been relinquishing it powers in favour of YVR, that YVR can make its own rule most of the time they are against natural justice and conditions imposed by YVR unreasonable. When pointed out to PTB then got reply that taxi companies have agreement with YVR and they can do it.

There was condition that any taxi service agreement; copy of that will be submitted to PTB so that genuineness and reasonableness of that agreement can be ascertained by PTB. But in one

of the weekly bulletin PTB abandoned that condition that there is no need to provide copy of contract between parties to PTB.

PTB or other Regulatory authority must have access to YVR taxi trip data.

YVR should not be allowed to form its own regulatory system in any case it is allowed then all the rules and policies must be subject to approval of ministry or PTB and published on PTB website.

## **CURBSIDE STAFF**

There is no curbside staff on both arrival levels between 1am to 8am to call taxis from taxi holding area, guide the passengers and instruct the taxi drivers. No training is provided to Curbside staff, only training given to them how to suspend drivers. Some of the staff do not have driving license and try to control traffic. They can't differentiate between YVR and Non-YVR taxi.

## **PICKUP BY Non-YVR taxis**

It is common that Non-YVR taxis after dropping passengers at departures and goes directly to arrivals and pick passengers by choice and charge metre rate to flat-rate zones. Whenever this is reported to YVR then get the same reply that they have no jurisdiction over non-airport taxis.

If there is any complaint against any taxi operator then YVR without asking any expiation from driver suspends him. There must be one complaint redressal system controlled by BC taxi regulatory authority.

## **Who has jurisdiction over YVR taxi System:-**

### **Provincial or Federal Government?**

Hon. Michael de Jong as health minister BC directed Worksafe to inspect Lunch room and washroom facility of YVR taxi holding area. Inspector of Worksafe gave detailed report that condition of that facility is very poor. Then YVR took a turn and said that we are governed by federal laws. When federal authorities raise these concerns then YVR take the plea that they have entered an agreement with that service provider or Federal Government as the case may be.

This is the last chance to curtail the unreasonable powers acquired suo motu by YVR.

*Jan Broocke, director of the Passenger Transportation Board, which oversees the licensing of taxis in B.C., said YVR can negotiate a new pickup contract on its own as long as the companies bidding on the contract already have pickup licences at the airport.*

*You asked if YVR Airport Ground Transportation is authorized to suspend taxi drivers and, if so, under what provisions of Law?*

*A. The Passenger Transportation Branch does not regulate YVR Airport Ground Transportation. YVR Airport Ground Transportation regulates the affairs of the Airport, including the suspension of taxi drivers who are in non-compliance. I would suggest that you contact Sat Gill, Manager for YVR Ground Transportation at 604-276-7738 and get clarification with respect to their authority for suspending taxi drivers.*

*Please note that the only legislation we enforce is the Passenger Transportation Act and Regulations.*

### Question 1

- In the reworking of Admirals Road, why was there a left hand turn allowed at Seenupin Lane and no consideration for a left hand turn from Admirals Road onto Lekwammen Drive leading into the Songhees Retirement Park?

We want to provide a 4<sup>th</sup> leg to hallowell but that is Songhees land, so they would need to reorganize their internal leased lands to allow for the improvement. Lekwammen would then get a left turn access right at the signal (Cemetary Rd and Lekwammen merge together to become the standard realignment 4<sup>th</sup> leg across from Hallowell). However, MoTI doesn't have jurisdiction to force it, and it must be a partnership agreement between Songhees and MoTI and View Royal (Hallowell leg is View Royal road).

- Is it possible to approach the Ministry of Transportation and request that this situation be investigated with a possible solution or at least a workable work around?

Reviewing any further upgrade concepts at the Hallowell intersection would need to be supported and driven by the Songhees Nation as the majority of the work is on their land. Lekwammen is their road and the retirement park is entirely on their lands. There isn't much the Ministry has jurisdiction over in this situation as it has to be the Songhees wanting the improvements to occur.

### Question 2

- Can the Ministry of Transportation be approached and request that a road sign be erected by the entrance to Lekwammen Road advising motorists traveling on Admirals Road not to block the intersection of Lekwammen Road as vehicles travelling in both directions on Admirals Road are impeding the ability of residents who live on Lekwammen Road (Songhees Retirement Park) to exit and enter onto Lekwammen Road."

We can definitely install a sign and then use paint/thermoplastic to mark the area if it continues to be an issue. However, as you can see in the attached picture, there already is a sign. We are only able to effectively request that the area is not blocked for traffic which is northbound on Admirals.

Question 1

- In the reworking of Admirals Road, why was there a left hand turn allowed at Seenupin Lane and no consideration for a left hand turn from Admirals Road onto Lekwammen Drive leading into the Songhees Retirement Park?

We want to provide a 4<sup>th</sup> leg to hallowell but that is Songhees land, so they would need to reorganize their internal leased lands to allow for the improvement. Lekwammen would then get a left turn access right at the signal (Cemetary Rd and Lekwammen merge together to become the standard realignment 4<sup>th</sup> leg across from Hallowell). However, MoTI doesn't have jurisdiction to force it, and it must be a partnership agreement between Songhees and MoTI and View Royal (Hallowell leg is View Royal road).

- Is it possible to approach the Ministry of Transportation and request that this situation be investigated with a possible solution or at least a workable work around?

Reviewing any further upgrade concepts at the Hallowell intersection would need to be supported and driven by the Songhees Nation as the majority of the work is on their land. Lekwammen is their road and the retirement park is entirely on their lands. There isn't much the Ministry has jurisdiction over in this situation as it has to be the Songhees wanting the improvements to occur.

Question 2

- Can the Ministry of Transportation be approached and request that a road sign be erected by the entrance to Lekwammen Road advising motorists traveling on Admirals Road not to block the intersection of Lekwammen Road as vehicles travelling in both directions on Admirals Road are impeding the ability of residents who live on Lekwammen Road (Songhees Retirement Park) to exit and enter onto Lekwammen Road."

We can definitely install a sign and then use paint/thermoplastic to mark the area if it continues to be an issue. However, as you can see in the attached picture, there already is a sign. We are only able to effectively request that the area is not blocked for traffic which is northbound on Admirals.

I have copied below part of the response – for your interest and information.

“...Thank you for your email regarding the BC Highway Cameras on Highway 28 (Gold River Highway). Outages with these cameras are of concern to us as we know how much residents and other highway users rely on seeing weather and road conditions in advance of driving. We do have challenges with two camera locations on Highway 28 and are continuing to work on a solution to these issues. Due of the lack of local available power sources, cell networks, or telephone wire line to deliver images to the Ministry servers, out of necessity we rely on solar power and satellite communications at these locations. Unfortunately during the winter months the sun is lower on the horizon and is unable to consistently recharge the current systems over extended periods of time. We are looking into a new and more efficient battery and solar technologies that will hopefully carry the camera system through extended low solar power days. Additionally, satellite communications are often affected by heavy precipitation and cloud cover--this can result in intermittent “Transmission Delayed” notifications as you see for the Gold River Highway camera. In general these intermittent communications outages don’t last long –it’s usually a brief time before the connection is re-established and we start to see updated images.

The Crest Lake camera in particular has had more than its fair share of troubles over the last couple of years; the most frustrating have had to do with vandalism and theft of the solar charging components. After some upgrades we are confident now that we’ve installed extra security and hardened the cabinets, they are a sufficient deterrent to that type of activity. In terms of maintenance, our electrical folks have visited the camera location several times this year, once to swap out batteries and other times to recharge the existing batteries. Unfortunately the batteries get drained within a week or two and the charging system can’t get enough solar energy to recharge on its own. We continue to seek a viable option to power the camera so we can reliably delivering images through all the seasons and types of weather. I do appreciate your concerns but I would like to assure you that we have, and will continue to work to improve our camera network and its reliability....”

Your MLA, Ben Stewart, shared your letter and requested that we respond to you.

We appreciate you taking the time to share your concerns. Safety on our highways, particularly during the winter, is one of our top priorities.

I'm sorry to hear of your experience last February when travelling on the Coquihalla Highway. I've spoken with local staff to better understand the circumstances surrounding the incident that you've described.

It is my understanding that the road was compact with slippery sections. Earlier that week, there was a heavy snowfall event that affected the area. During that storm, there was a collision between two commercial vehicles on Larson Hill that closed the highway for several hours. While the storm happened, the contractor was unable to clear snow, and as a result there were some areas of the highway that developed compact snow.

Temperatures following the storm dropped quickly and prevented them from being able to remove the compact with chemicals.

We do require our contractor to post information about road conditions, but I recognize the value our web-cameras provide as motorists are planning their trips. I've brought the issue of web-camera reliability to the attention of our local staff who will work with our IT program lead to determine if upgrades to the connectivity are required at these locations.

Thank you again for taking the time to write and I am sorry for the delay in responding.

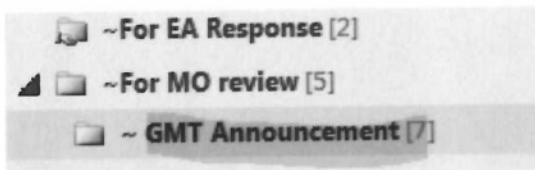

Dear Mr. Beale,

As we start a new year and reach a mid-point in our winter season, we would like to provide you with an update on our winter operations and the ongoing work CN is doing to ensure we have the capacity to meet the growth we see across our business.

CN remains very focused on ensuring we have the track capacity, trained operating crews, cars and locomotives necessary to move this year's grain crop as well as all the other commodities and products that need to move on our network. Our decision to invest a record \$3.5 billion in our network in 2018, with a particular focus on the corridor between Winnipeg and Edmonton and the corridors to the ports of Vancouver and Prince Rupert illustrate our commitment to ensure that we have fully addressed the challenges we experienced last winter. Our President and CEO, Jean-Jacques Ruest has already indicated that we will invest another record amount in capital expenditures for 2019. We look forward to sharing the details of our capital spending plans with you in the coming weeks. These investments will help enhance the capacity and resiliency of our network and allow us to move more Canadian resources and goods to market.

I am pleased to report that to date, our winter operations have generally been strong. We have seen some significant increases in traffic volume which have caused short-term challenges in some regions however, we have been able to work through these and overall have been able to meet the goals established in our Winter Plan and our Grain Plan. CN consulted widely with our customers, the farm community and our supply chain partners to develop our Grain Plan and Winter Plan and continue to seek input and update the plans as we move forward. We will be sharing with you CN's latest updates of the plans in the coming days.

As you are aware, the demand for the movement of crude by rail has grown significantly in recent months. CN has been very clear that while we welcome the increase in crude traffic, we are only adding additional crude business when we have the necessary capacity in place. We are not adding crude at the expense of our existing long-term customers. We also continue to move forward with our CanaPux solid bitumen project and are hopeful that we will soon be in a position to proceed with a pilot project. We believe there is great potential in the process we have developed to turn bitumen into a solid product that is safe, stable and floats. With over 30% of our traffic being trans-border with the United-States, we were pleased with the successful conclusion of the trade negotiations and continue to closely follow the ratification of the USMCA agreement and the impact of the tariffs on aluminum and steel to our customers both in Canada and internationally. We are encouraged by our grain movement to this point in the crop year. We have been exceeding the commitments set out in our Grain Plan to move 4000 cars a week in winter and 5500 the balance of the year

on a consistent basis and in spite of the late harvest in Alberta and parts of Saskatchewan, we were able to move record levels of grain in fall 2018.

Here is some info for you. I hope this helps. You can also contact the Senior Project manager, Mike Dinney, directly. He is in the global directory.

- As you are likely aware, the region experienced significant rainfall last week.
- Unfortunately, the heavy rainfall was combined with a pump malfunction at the site. This combination created some water pooling for portions of the work area.
- Over the past few days, the project contractor has been draining the water. The drainage has occurred during daylight hours only so that the water quality of the site discharge could be safely and accurately monitored.
- Environmental staff have been on site and confirm turbidity levels at the outlet to the nearby Colquitz River are within federal and provincial guidelines and adhere to the strict environmental conditions agreed upon. Data provided by the contractor for the period of January 3 to 6, show that turbidity measured at the outfall from the project was within federal/provincial guidelines. There were three brief instances on Saturday, January 5, when turbidity levels briefly exceeded contract agreements. When this occurred, the outfall drainage rate was immediately adjusted to adhere to project guidelines. During the entire process, environmental monitors were on-site to oversee the proceedings.
- Guidelines allow for turbid water (within limits) to be discharged when there is more than 25 mm of rain in 24 hours. According to Environment Canada, The storm on January 3, saw 57.6 mm of rain in 24 hours.
- When environmental conditions are breached, regulatory agencies have the power to levy fines for not following guidelines. The ministry is not aware of any active investigations concerning the contractor or any fines that have been issued.

- Ministry staff will continue to monitor the site to ensure all environmental conditions are being met. This will include auditing of the contractors' environmental performance.

They agreed that the water table is very high in this section which cannot easily be changed. She asked Mainroad North Island to source an alternate aggregate material for this road and they are currently in the process of doing that. The material will be spread and compacted on Sprout road as a "trial" in hopes that we will see an improvement in the overall condition of the road as well as a reduction in the frequency of grading required. s.22 is aware that this work is best performed in a drier season (spring or summer). 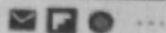

His question is can the statutory minimum be raised so that the fine will be more effective in reducing the number of cars that do not stop for a parked school bus.

Is there information on what the statutory minimum is and also a process to amend it.

The intersection of Lougheed Highway and Pitt River Rd is under the City of Coquitlam's jurisdiction with TransLink contributing operational, maintenance and rehabilitation monies under the Major Road Network Agreement. Port of Vancouver is the lead on this project, and the Ministry is not directly involved, but continue to track progress through the Gateway Transportation Collaboration Forum (GTCF).

Please see some bullets below:

- In November 2017, the Port of Vancouver submitted an application for funding to the National Trade Corridors Fund for design work to raise Pitt River Road and Colony Farm Road to create overpasses of the existing CP rail corridor and Lougheed Highway.
- This would also allow for a new 5 kilometre long section of rail track that would pass beneath these two crossings permitting trains to travel in both directions along the CP Rail line in the city of Coquitlam. The Port received funding for this design work in May 2018 and is the lead on the project. The design work is ongoing (note that we have not confirmed current status of the work with Port of Vancouver as of sending this email).
- The funding partners are the Port of Vancouver, CP Rail and Canada, with a project delivery governance model also including input from BC Housing, City of Port Coquitlam, Metro Vancouver and the Kwikwetlem First Nation.
- The affected parts of the Lougheed Highway and Pitt River Road are both components of TransLink's Major Road Network, and operated and maintained by the City of Coquitlam. The TransLink portion of Lougheed Highway ends to the west of Colony Farm Rd. where it becomes provincial Highway 7.
- These grade-separation projects were identified in the Fraser River Trade Area Study, a study led by the Ministry of Transportation and Infrastructure and conducted on the behalf of the Gateway Transportation Collaboration Forum (which includes the Ministry, Transport Canada, Port of Vancouver, Greater Vancouver Gateway Council and TransLink).
- The Ministry of Transportation and Infrastructure was not a partner in this funding application, and is not involved in project delivery, but supports the efforts of the Gateway Transportation Collaboration Forum and its members to implement projects that benefit the transportation trade network and improve safety and reliability of the network accessing Port of Vancouver.

As to Ministry long term plans for Pitt River Rd/Lougheed Highway, given it is a TransLink intersection, our role is monitoring progress of this port initiative and considering any downstream effects on our portion of Lougheed Highway/Highway 7.
