Charly we want to present to Minister Trevena the critical road infrastructure deficits in the North Peace and their impact on the residents, industries and economic development of the region. We will absolutely demonstrate and show those to Minister Trevena when we have the opportunity for a tour, but unfortunately, spring will be too late to affect the 2019/20 budget cycle and the region is facing serious challenges that cannot wait for the 2020/21 budget cycle. Good morning Charly. I wanted to follow up on this today as there has been a significant slide in the North Peace over the weekend which has taken out the Old Fort Road and isolated 40-100 residents (I am not clear on the exact numbers). This is in addition to the Farrell Creek slide which happened in July and continues to cost industry thousands of dollars a week as it is not capable of supporting heavy loads. There are two additional slides on the key Upper Halfway corridor that are also a significant risk to slide soon as they have moved significantly over the summer.

These areas are in the heart of the North Peace and directly in the path of the LNG Canada announcement this morning. They are already negatively affecting residents and industry and we have not been able to open up any meaningful dialogue with the Minister about MoTI's plans.

We are running out of time to host a meaningful tour for the Minister and the issues keep piling up. Is there any chance of getting the Minister up for this tour in October?

I wanted to follow up on this today as there has been a significant slide in the North Peace over the weekend which has taken out the Old Fort Road and isolated 40-100 residents (I am not clear on the exact numbers). This is in addition to the Farrell Creek slide which happened in July and continues to cost industry thousands

of dollars a week as it is not capable of supporting heavy loads. There are two additional slides on the key Upper Halfway corridor that are also a significant risk to slide soon as they have moved significantly over the summer.

These areas are in the heart of the North Peace and directly in the path of the LNG Canada announcement this morning. They are already negatively affecting residents and industry and we have not been able to open up any meaningful dialogue with the Minister about MoTI's plans.
