Dear Minister Trevena:

I write to express my opposition to the proposed introduction of the serving of wine and beer on any B.C. Ferry. Our Ferry system is the envy of most of the world and for good reason. The Ferry corporation "runs a good ship" as the expression goes. Also, it is extremely successful and forward thinking. The ferry system is not in need of the apparent and assumed stimulus of alcohol notwithstanding the Corporations assertion that many of its customers have expressed the wish to have access to wine and beer.

There is an irrationality to adding drivers to the highway who have just consumed one or two (or more . . . it will be possible) drinks and sharing the road with 300 hundred or more cars embarking at the same time.

Another consideration is the change in the atmosphere in the Pacific Buffet. This "refuge" area serves as a gathering place for people seeking separation from the crowded passenger areas. It serves as a work area, a reading room, a conversation place, a great family dinner spot, an area frequented by young people including sport teams, etc., etc. The very real possibility exists that each of these attributes will be negatively impacted as the demand for seating will be increased by those who are attracted to the Buffet in order to consume alcohol.

The resulting increase in the sale of B.C. wines and the added revenue for the Ferry Corporation plus added tax for the Province do not justify the move in this direction. We are better than this.

I urge you to give the whole idea a "sober" second thought.

WEEKLY ISSUES REPORT – April 23, 2019

NEW: Alcohol aboard BC Ferries

BC Ferries will be piloting the sale of Beer and Wine onboard our vessels in the Pacific Buffet. This pilot project is an initial small-scale implementation that is intended to prove the viability and scalability of providing this offering to customers. This pilot approach enables the company to manage the risk of a new idea, gather feedback from employees and customers, and identify any deficiencies before rolling this out to other vessels.

Key Messages

s.13

- **BC Ferries will launch a pilot project which will take place on a limited number of ferries sailing between Tsawwassen and Swartz Bay. There will be a two-drink maximum and strict limitations on the specific locations where beer and wine can be purchased and consumed.**
- **I recently spoke with BC Ferries CEO, Mark Collins, and reiterated the government's position that passenger safety is our top concern. He assured me that staff are undergoing training to identify signs of intoxication and will require two pieces of ID to verify age.**
