- The Container Trucking Act and Regulation provides the Commissioner with the powers and responsibility for the ongoing management of container trucking licence and truck tag system (including managing the addition and removal of truck tags, and management of the I/O list).
- The Commissioner has initiated the review of the truck tag policy in consultation with stakeholders. Government supports the Commissioner's review of the truck tag policy, which will consider opportunities to make improvements to the policy as warranted.
- I understand the Commissioner has provided an invitation to make submissions on the truck tag policy (until December 14<sup>th</sup>) so I would encourage BC Trucking Association to provide your submission on these issues directly to the Commissioner.

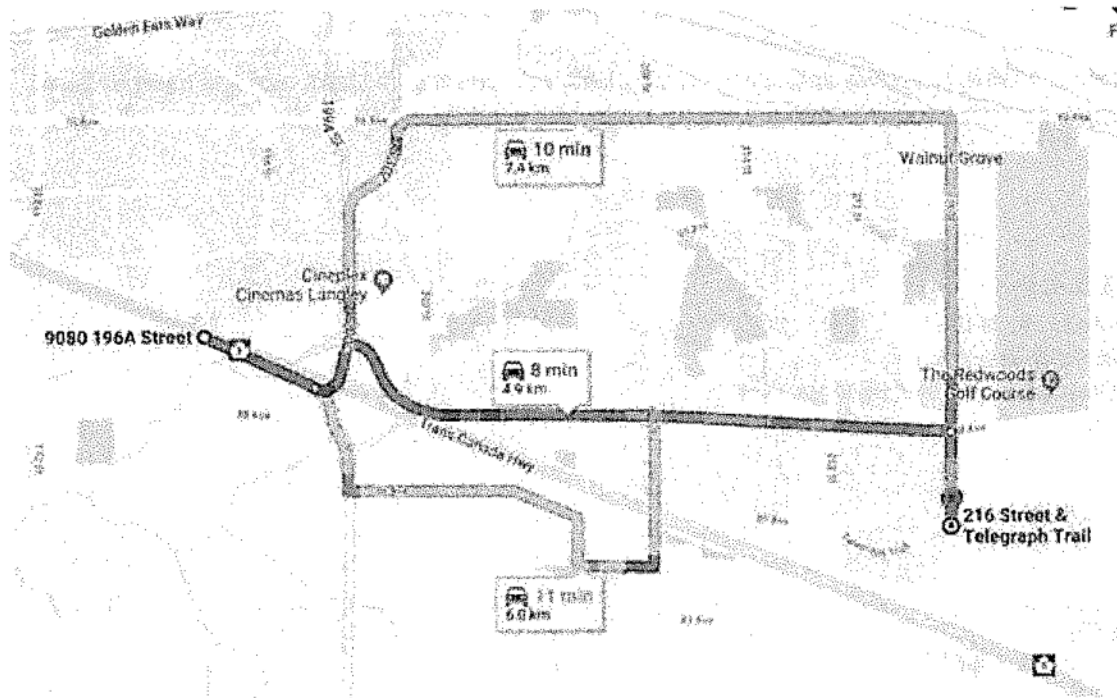

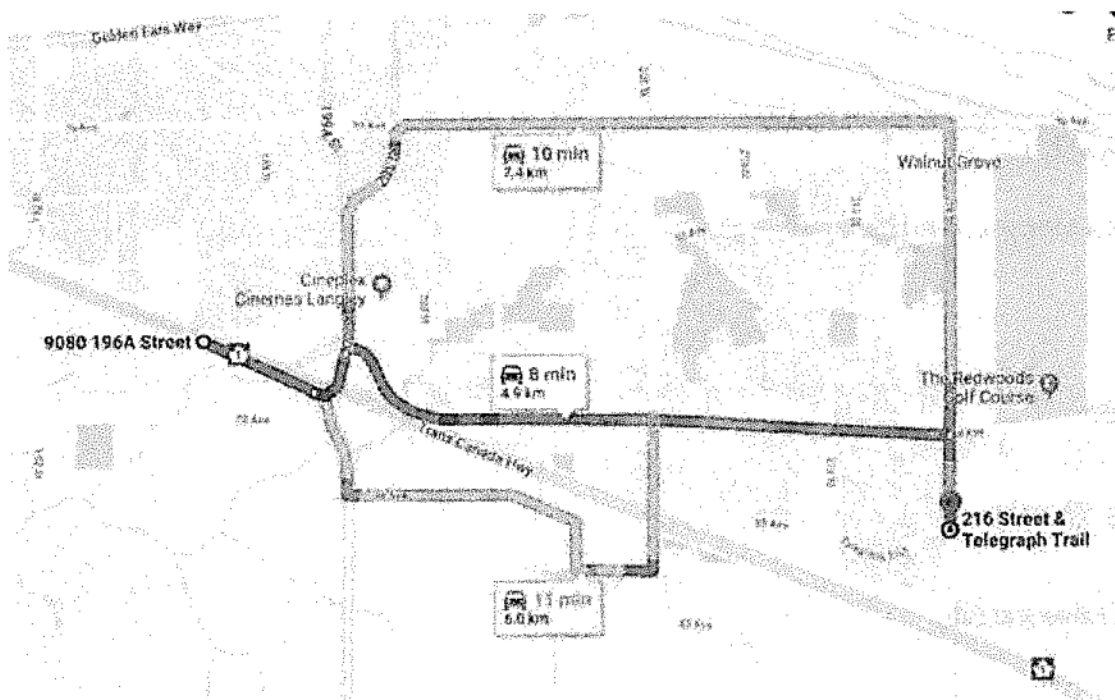
