s.22 is indeed correct, we are waiting on BC Hydro to complete the service connection and we continue to make them aware of the pressing concerns of getting it completed as soon as possible. They unfortunately had some design issues to overcome that has delayed them these past couple weeks, but the work is now with their line crew to complete the physical installation which includes a new transformer as you indicated. We are optimistic that they will complete the connection next week, but they have warned us that storm outages may delay their crews if repairs are required with the winds forecasted this weekend.

It is a priority and we continue to press Hydro to complete these works as soon as possible.

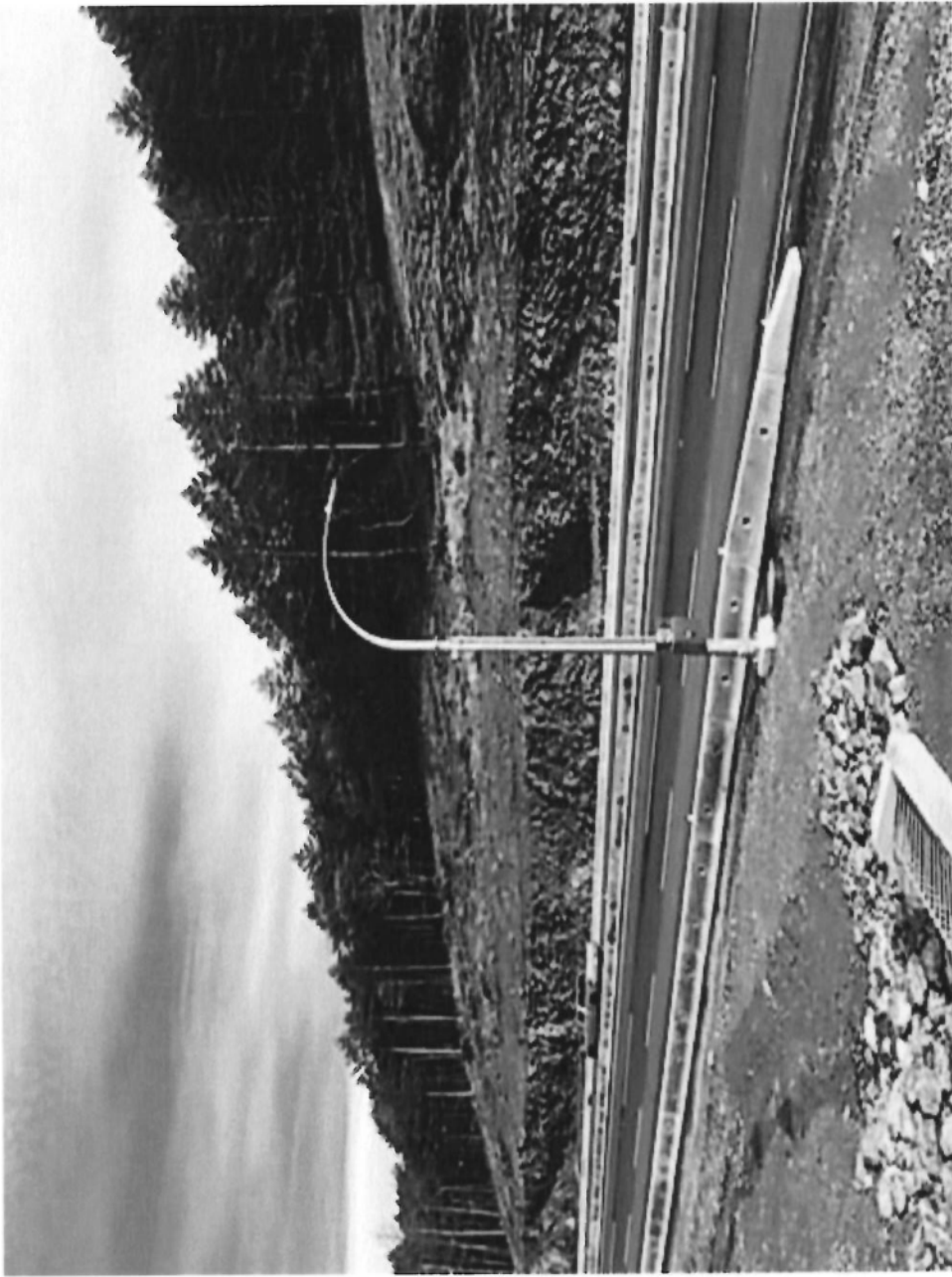

We've noticed all the comments regarding the paving and shoulders along Heriot Bay Road, but we'd like to express our concerns with North Gowland Road and Leishman Road accessing the Copper Bluffs area. Our area consists of approximately 30 full time residents including Upshur Road. I'm not sure if you are familiar with this area and our poor road conditions, but would encourage you to take the drive. Leishman and Upshur are maintained (supposedly) by Highways Dept, although with the transition to Mainland September 1st, these roads have still seen no servicing. We appreciate that Mainland is undertaking a new venture on Quadra, and we do hope the outcome will provide better than Emcon, but 9+ weeks later residents here are quite dismayed. Our access to this populated area of Copper Bluffs is of course the N. Gowland Rd which if I understand correctly is owned and maintained by Timber West. We (the residents) wish there was some way the government could take over the managing of this road, as it has become extremely tough on vehicles. As our area is growing s.22 it would certainly be appreciated to have that road better managed than it presently is.
