 Following the open house last June and the public engagement period, Ministry staff received positive feedback regarding improvements to Highway 14 – particularly more passing lanes and possible realignments to straighten some of the curvier sections.

- The open house was held on June 19, 2018, at the Edward Milne Community School to provide an opportunity for the public to ask questions and provide feedback on future improvement priorities along the corridor.
- Approximately 143 people attended the open house, and during the engagement period (June 19-July 15, 2018) over 700 feedback submissions were received.
- A summary report and open house materials are available online on the project website
 at: www.gov.bc.ca/highway14
- The section between Connie Road and Gillespie Road was one of the areas identified for future improvements at the open house.
- As such, the project team developed a concept alignment and then began engagement with potentially impacted property owners in January 2019.
- Owners have been shown a <u>concept alignment for</u>
 <u>a future plan</u> the alignment has not been
 confirmed and could shift slightly in locations (in a range of +/- 20m).
- Staff have continued discussing safety and reliability improvements on Highway 14 with local First Nations along with local governments and businesses.
- At this time, funding has not yet been secured for future improvement projects.

If asked about number of properties/cost/other details:

- I can't go into any details all property negotiations are confidential. What I can say is that any land purchases or rights-of-way required for the project are made at fair market value and the Ministry strives to reach consensual agreements.
- As well, these early conversations are for a concept alignment that has not been confirmed and could shift slightly in locations (in a range of +/- 20m).

If asked about expropriation:

- As with all our projects, any land purchases or rightsof-way required for the project are made at fair market value and the Ministry strives to reach consensual agreements.
- Expropriation is the last resort and only occurs when negotiations are unsuccessful. On average, expropriations make up a very small portion of the Ministry's total acquisitions.

If asked about the Mayor's awareness:

 Staff provided the municipality with an update in late February and have requested a follow up meeting.

If asked about Highway 14 being a priority:

- Highway 14 is an essential corridor and we want to make it as safe as possible – not just for people in cars, but for people who take transit and people who bike and walk.
- This stretch of road is a pivotal transportation link for one of the fastest growing communities in B.C.
- Last year, we committed \$10 million in immediate upgrades to kick off the first of multiple phases of safety, transit and congestion improvements. This summer the final two projects of those upgrades will be completed.
- The ministry continues to explore further upgrades for the corridor.

"Keeping people and goods moving safely and efficiently in all corners of our province is our top priority," said Minister of Transportation and Infrastructure Claire Trevena. "Paulson Bridge is more than 55-years old. Significantly rehabilitating the bridge and providing other key safety upgrades will ensure it remains reliable for many years to come."

The Paulson Bridge crosses over McRae Creek and the Kettle Valley Rail Trail on the Crowsnest Highway, approximately 50 kilometres west of Castlegar. The bridge was originally built in 1962. Along with deck resurfacing, this rehabilitation project will include:

- replacement of deck joints and bridge deck overhangs;
- installation of new concrete roadside barriers;
- improvements to roadway drainage; and
