### Tag Policy Bullets

- s.22 of the UTA (United Truckers Association – non-union) contacted the Commissioner on January 25 seeking an update on the operation of the newly introduced tag policy
- The UTA long maintained that the previous tag policy did not allow I/O's to move freely to available work (and good companies)
- The UTA had previously raised concerns that the new policy would not allow Independent Operators to move to new companies at their discretion because it is up to the Commissioner to issue new truck tags (which need to be vacant for an I/O to be hired)
- The UTA was concerned that the process of issuing new tags would be slow
- The UTA has been concerned about consolidation in the industry with larger companies growing at the expense of smaller companies
- The Commissioner advised the UTA that since the 1<sup>st</sup> of January (when new policy came into effect), the Commissioner had issued 40 tags to four companies
- Of those 40 tags issued, 15 tags were awarded to one company. Those 15 tags are for I/O's places as requested by the company

- Only five companies have applied to date. One company's application was insufficient
- It took a week for the Commissioner to issue the tags
- To date only seven I/O's have sought to move companies in order to fill the 40 tags issued
- In order for a company to get new tags they must demonstrate that there is available work for the new drivers they plan to hire
- If a company chooses to hire I/O's, they must hire I/O's that are on the Commissioner's I/O list (list represents pre-existing I/O's...no new I/O's in industry allowed at moment in order to protect existing driver's work)
- Of the 4 companies awarded tags, three were mid-sized companies (approx. 20 truck fleets) and one was a large company
- No small companies have applied for tags as of yet. The size of the company is not a determining factor when issuing tags

#### Request

Reporter asks: I am emailing you in regards to construction for the McKenzie Interchange project. We have spoken with a man who lives nearby on Burnside Rd West who says his house, and some of his neighbours' homes as well, have cracks on the walls as a result of the frequent intense drilling. He also says several door frames and window frames have shifted.

Is this something the Ministry of Transportation is aware of? Are there any steps put in place for residents affected by the construction?

#### Background

#### Recommendation

#### Suggested response:

The ministry is aware of and has been in discussions with a resident who has raised concerns about damage potentially related to blasting on the McKenzie interchange project.

For any claims related to an issue with a highway or construction project, the ministry has a process for submitting a claim for assessment. In order for a claim to be payable by the Province, there must be proof that there was negligence on the part of the ministry and/or contractor. More information on the claims process is available online at:

For every project that involves drilling and blasting, pre-blast and post-blast condition surveys are undertaken of all wells, structures, roads, and municipal services within a pre-specified distance of all significant vibration sources to determine "before and after" conditions. As well, before blasting begins, a blasting plan is reviewed which sets maximum vibration levels allowed, based on the distance to nearby structures. The contractor is also obligated to use continuous caution to protect vehicles, utilities and buildings by monitoring vibrations throughout blasting activity.

Derrick,

Thank you again for keeping me in the loop about this. I am hearing quite a lot from constituents on this though and would like to be able to provide them with some answers. I note it has also now been highlighted in the local paper.

The first question is how much is the repair going to cost, and why are we investing in a repair that's going to take months to complete when the overpass is already on the list for a re-build/expansion? Why not delay the repair and expedite the replacement of the overpass instead of spending the money twice?

The second concern is why is this repair affecting the schedule for the KGB/Nikomekl Bailey Bridge replacement?

I've spoken with city staff who are disappointed the repair is being undertaken rather than a replacement of the 152 overpass, but that the province was not prepared/able to fund the replacement.

It is my understanding that the province is aware of the urgent need for work on the 32<sup>nd</sup> Ave interchange/152<sup>nd</sup> overpass and Hwy 99. I also understand this combined project is the city of Surrey's #1 priority. It would seem only prudent given the unfortunate incident with the 152 overpass that this project now be expedited.

I look forward to your response.

FYI, folks – you will remember the incident last month where a truck struck the overpass. The attached IB is scheduled for tomorrow am regarding repairs starting in the coming weeks.

Still to be finalized with the contractor is the traffic flow/closure schedule, which tentatively is:

- For 152<sup>nd</sup> – On 152<sup>nd</sup> Street, should be able to maintain the single lane southbound (how it is now) during construction. On Highway 99, at times there will be a nighttime reduction to one lane in each direction using a diversion for northbound traffic through the median to use one of the southbound lanes.
- For Bailey – traffic will continue to use the adjacent 2-lane structure.

Hi –

As mentioned at this afternoon's mtg, here is the statement we sent to CHEK today on royal bay ferry service

We're aware of BC Ferries' exploratory concept of a commuter passenger ferry between downtown Victoria and the West Shore. These preliminary discussions are being led by BC Ferries, which, as an independent organization, is free to pursue new business ideas and concepts as they choose. It's too early to comment on the feasibility of a commuter ferry service, or on what level of support from the provincial government a service like this would require. We look forward to hearing more from BC Ferries on this potential service.

What I will reiterate is our government's priority to reduce congestion and facilitate safe, efficient travel in the Capital Regional District. We are acutely aware of the traffic bottlenecks and frustration for people getting around the region, particularly between Victoria and the western communities. We are in the process of consulting with local communities and First Nations on the best ways to move forward with a holistic vision for transit and transportation that will result in shorter commutes and less painful travel for residents across the CRD. In the meantime, our government is accelerating safety projects on Highway 14 and its alternate routes – so everyone, whether drivers, cyclists, pedestrians or transit users, can move through this corridor as quickly and safely as possible.
