I am writing you to express my frustration over some issues at the Vesuvius ferry terminal. I have written to BC ferries and been told to expect a response in 5-6 weeks. I have complained to management in person and this has gone on for years. s.22

Over the years we have seen an increase yearly in ferry traffic and this summer has been busier than ever, and there is now a smaller boat on this route.

Some days there are 2 or 3 sailing waits, leaving people in their cars on the road for 2 –3 hours. Although many people would believe we are seeing an increase in sales, this is not the case. There are several things that are causing a very negative experience for s.22 ferry travellers. The road is constantly blocked with traffic s.22 have to drive on the wrong side of the road with no safe pull outs s.22

Ferries are doing their best to control traffic, but they are not professional flaggers and I watch them getting many complaints from drivers. If there was an emergency the road is very unsafe.

Another very big issue is the bathroom situation. The ferry has 2 port-a-pottys that are on the bottom of the ferry dock. A far walk from the ferry parking lot, and at least 1 time per week they are out of order. I was told this is because they do not get pumped out enough and they get full very fast and have to be closed. s.22 s.22

s.22 .Could a bathroom trailer be hired for the summer, I see these at large festivals and events .

The terminal has no recycling facilities, the only garbage can is at the bottom of the ferry dock. This is a long way from the parking lot.<sup>s.22</sup>

Ferries to handle everyone's garbage also. Garbage removal on Salt Spring is very costly<sup>s.22</sup>

Ferries provides doggie poop bags in the parking lot for people to responsibly pick up their dog messes. Yet again the empty bags are in ferry parking lot and the garbage can is down at the bottom of the dock. Which makes many people just drop of their dog poop in our parking lot. We could go after these people and make a fuss, but being in the hospitality industry and trying to promote Salt Spring as a destination, this would be a negative experience for our guests to the island. I even have seen the BC ferry workers bring in their own garbage can and put it in the upper lot to solve this problem.

I keep being told that BC Ferries is doing all they can and they do not have a bigger boat for this route, they proudly declared at our last meeting on Salt Spring that they are running more sailings on time and that is important to them. This smaller boat is faster and loads and unloads very quickly. Even thought the boat is only 8 cars less than the Bowen Queen, I watched overloads all winter. So why when we get thousands of more people in the summer travelling have they not come up with a better solution. Last summer was very busy and saw the same overload situation.

There is so much construction on the island, so many more commuters and commercial traffic is very busy. Perhaps for the busy months a barge could be hired and that would bring the commercial traffic and dangerous cargo over. They could use the same dock and work around the ferry schedule. Another idea talked about at the last meeting would be just letting the ferry load up and go back and forth as a shuttle service. The situation right now is not working, we are making Salt Spring undesirable because people are having such a negative BC Ferry experience.

Legislative Assembly for North Saanich and the Islands, I want to express my sincere support for the **Community Hub at Meadowlane** on Salt Spring Island for funding under the "Investing in Infrastructure Program - British Columbia - Community, Culture and Recreation Infrastructure" program.

The Community Hub is a facility that will provide shared space for community groups, clubs and island residents to gather, recreate, play, learn and engage in music, art and cultural activities. No place like this exists on Salt Spring. With large and fully functional meeting space(s), support facilities like fully accessible washrooms, ample parking, a kitchen and storage for materials and supplies, community groups will finally have a place to meet and offer their programs and services. #### Improvements to Highway 17 to support safe, efficient travels in Central Saanich

SAANICHTON – Investing in modern transportation infrastructure is critical to connecting communities, helping businesses compete, and creating a strong economy and middle class.

Jonathan Wilkinson, federal Minister of Fisheries, Oceans and the Canadian Coast Guard, on behalf of François-Philippe Champagne, Minister of Infrastructure and Communities; and Lisa Beare, British Columbia's Minister of Tourism, Arts and Culture, on behalf of Claire Trevena, B.C.'s Minister of Transportation and Infrastructure, have announced funding for a project to improve the Highway 17 corridor and create a new overpass at Keating Cross Road in Central Saanich.

The project involves a new flyover overpass from the Patricia Bay Highway (Highway 17) northbound to Keating Cross Road westbound, eliminating the left turn across highway traffic onto Keating Cross Road. The project will also include a realigned southbound on-ramp to Victoria.

These upgrades will allow vehicles to travel this busy corridor more safely and efficiently, helping keep local businesses competitive and promote regional economic growth.

The Government of Canada is investing more than \$16 million in this project through the New Building Canada Fund, Provincial-Territorial Infrastructure Component—National and Regional Projects, while the District of Central Saanich is contributing \$2.5 million. The provincial government's contribution for the project is pending Treasury Board approval.
