Hello William,

Catharine Read, Chair of the PT Board, asked me to share the attached information on taxi modernization statistics. We will make them public in final form when we post the Board's Weekly Bulletin on our website tomorrow afternoon (Jan. 23).

Some highlights:

- Overall number of taxis approved in BC increased 12.5%
- Overall number of taxis approved as wheelchair accessible increased 21.5%
- Number of taxis approved are based on applications received from taxi companies and Board policies allowing applicants to request an increase of up to 15%
- Generally, the number of taxis approved are closer to 15% in urban areas than in other parts of the province.
