Hello Dave,

I hope the information below helps.

### Background

This is a complex issue with many conversations between staff at BC Transit and the City of Kelowna over a period of time. A new facility was identified in the 2012 Transit Future Plan. From 2012 to about 2016 there was limited funding available for expansion across the province. Since 2016 there has been significant expansion in many of our systems. Also we did not have the Federal Funding contribution available until 2016. Each year we go to council to review the three year proposed expansion plans, so what the councilor is saying is why wasn't this brought up three years ago to avoid the deferral.

### Addressing facility capacity issues

The existing Operations and Maintenance Centre is beyond capacity. Before additional vehicles can be added to the system, a new facility must be constructed.

### Messaging:

A new facility was identified in the 2012 Transit Future Plan endorsed by the City of Kelowna and other partners. These projects can take time to develop as it requires significant investment and planning to ensure the facility is located at an appropriate location to avoid driving buses long distances to the start of their route empty. As mentioned, the local governments are key funding partners, and we are working together to create a plan to support future expansion plans.

Hello GCPE Team,

Here is our messaging about the reports of the Kelowna facility being at capacity. Let me know if you have any questions.

Messaging:

BC Transit, the City of Kelowna, and our other local government partners work together in the Kelowna Regional Transit System to provide transit services that meet the needs of customers. The system has seen a 15 per cent growth in ridership in the last two years, and in order to maintain ridership and attract new riders we will need to continue improving service. In September there will be 6,050 service hours added to the system largely to expand service on the Westside.

We're pleased to see that local governments in the region want expanded service, and BC Transit will work with them to achieve their goals. We mutually recognize that the size of the facility has now reached capacity and is a constraint on future growth, which is why we're actively looking at options. This includes short term and long term possibilities. Kelowna and BC Transit recently approved funding to prepare a facility infrastructure strategy and investment plan. Once this strategy is complete BC Transit and Kelowna will work towards advancing an application for the long term facility solution that would aim to seek federal funding through the Investing in Canada Infrastructure Program.

As the local governments are an important funding partner in any new facility development we will need to continue working together to ensure we are in alignment to achieve shared goals for the local transit system. We are committed to working in partnership to find a solution that allows the Kelowna Transit System to continue to grow now and into the future.

Hi to all – here is the summary from our weekly call with BC Ferries communications – thanks!

- FYI - Cable ferry issue – Waiting for engineering report on cause of plastic stripping from cable – BC Ferries may go with a different cable, still TBD. The report on this will be done by late Sept, and BC Ferries will be consulting with community members before a final decision is made.
- FYI – Grand Fondo race Sept 7 – will impact Horseshoe Bay ferry terminal – BC Ferries to do a media advisory on Sept 5 letting people know about detours
- Sept 6 - BC Ferries shoreline clean-up summary news release – highlighting the beach clean-ups that have been done recently by staff and executive. Video of the shoreline cleanups to be posted on the same day/ social media push.
- FYI – 2 Island Class Vessels are in Romania – they will arrive in B.C. in December – will go into service next summer
- Mid Sept – BC Ferries to do more public engagement on the future of the Horseshoe Bay terminal.
- Mid-Late Sept – Beer & wine pilot update - BC Ferries is planning a news release to go out to media in September – announcing license for the beer & wine pilot. They will probably “launch” this in late October or November. Inspections are underway now. One drink per customer.
- FYI – Sept 20 – Mark Collins to speak at the Nanaimo Chamber of Commerce (Vision of BC Ferries, key priorities, accomplishments, CleanTech, electrification, LNG)
- Nov 22 – BC Ferries will issue NR releasing 2<sup>nd</sup> quarter financial results

Dear MLA,

I am in favour of HUB Cycling's position on modernizing the Motor Vehicle Act to create a new Road Safety Act which is inclusive and promotes safety for all road users, including the most vulnerable.

I urge that BC's new Road Safety Act include:

- A safe passing distance for people on bikes of 1.5m of space similar to Europe and many US states and Canadian provinces
- Granting power to municipalities to enable a default speed limit of 30k/h on neighbourhood streets
- Increased fines for opening car doors on people cycling, harassment of people on bikes, theft or tampering with bicycles, aggressive driving and negligence leading to injury or death of people on bikes
- Clarity on restricted speeds, weights and motor size of e-bikes allowed on cycling infrastructure

These laws will help ensure our most vulnerable road users remain safe in BC, and encourage more people to use active transportation to get around.

- Western Pacific Marine and the BCGEU are currently to appear before the LRB, August 21.
- WPM is seeking 100% essential service designation for the ferry routes owing to their key importance to the health and safety of the public.
- WPM has indicated that we will accept the appointment of an interest arbitrator, to again protect the public from service interruption.
- If WPM is not successful, the BCGEU may serve 72 hour strike notice.
- The latter outcome could unfortunately see service interruption or cessation, as early as August 26th.

The purpose of my reaching out to the MLA is purely to advise.

Hi Melanie,

I emailed my DM and this is what he had to say...

**The essential services process is regulated by the Labour Relations Board. We have given them direction to start the process based on provisions in the Labour Relations Code. Basically they are aware that this dispute if it goes to a strike or lockout could impact the public. So they ask the Minister to direct them to designate essential services under the Code. I sent them that letter/direction a few weeks back. They then contact the union and the employer to begin the process to determine if there actually could be an impact on the public by a strike/lockout and if so how much – and then they mediate and adjudicate the necessary staffing levels to be provided by the union to ensure no harm to health, safety or welfare of the public.**

**In the health context, this usually relates to for example how many operating rooms to keep open at VGH (e.g., no elective surgery) and how many nurses should be there to staff those open rooms notwithstanding a strike. This is a very simple example.**

**In a bus dispute, generally the parties agree that the service is NOT essential at all to health, safety or welfare because there are alternatives – cabs, walk, bike, car.**

**In other public transport cases, the question about essentiality may be different. If no ferry to Sechelt, there are no groceries so there should be one ferry a day and X staff need to be there.**

**Each case is different. The public can write in but ultimately it is up to the union and employer to make the case and the LRB to mediate and adjudicate it and issue a decision. What is essential varies by industry, service, and situation – and there is no list of what is essential.**

Another update on the above. We are moving forward with the BC Ferries applications to licence the Swartz Bay – Tsawwassen routes. After considering the results of the public input we will add terms and conditions to the licence to restrict passengers to one drink per sailing, in the first 65 minutes of the 1.5 hour crossing, with the purchase of a buffet meal. This is less than the two drink limit that BCF proposed but takes into consideration the input received from the Canadian Institute for Substance Use Research and MADD.

We expect to issue the AIP letter towards the end of next week. From there timing of final licence issuance will depend on how quickly BCF is ready to move. GCPE is aware on our end and working on communications.

Just a couple of updated messages for you on the Baynes Sound Connector:

- The plastic shedding has stopped. We have measures in place to detect and mitigate the delamination early on.
- Our President & CEO Mark Collins is spearheading a shoreline cleanup with our employees on Denman Island on Tuesday, August 20, to pick up any plastic, if found. We also had a team out on BC Day long weekend to pick up any plastic they found.
- The reefs we put in when we upgraded the terminals as habitat compensation are clean. There is no plastic on them. We survey them every couple of years and happened to be doing a survey of them recently while this issue was happening, and confirmed they are clean.
- We are sending out an underwater camera in an ROV to check for plastic underwater. We will do multiple crossings to cover as much area as we can and – if needed – have divers pick up any plastic should it be found.

Sure, here are some bullet points:

- BC Ferries has experienced issues with select area of the plastic coating on the cables of the cable ferry delaminating.
- This is a manufacturer's defect and should not be occurring.
- This situation was exasperated recently when a free-floating prawn trap and net got caught up in one of the cables.
- Since the prawn trap incident, we have been closely monitoring the cables and we have not seen any further plastic shedding. We continue to monitor the situation.
- BC Ferries is working with engineering experts to rectify the situation. We are looking at all options, including cables without coatings.
- The plastic coating on the cables is supposed to extend the life of the cables and dampen noise.
- BC Ferries is committed to the environment and will find a solution to this problem.
- In the meantime, we are coordinating, and participating in, a number of shoreline cleanup activities, including one planned for August 20 on Denman Island.
- We thank everyone who has participated in cleaning up debris on the beaches.

Hello,

Please be advised of this newly discovered **privacy** incident, for which the **Ministry of Transportation and Infrastructure** appears to be the responsible party.

The incident was reported by **Melanie Sanderson** from **Minister's Office**.

As reported, a bag containing four FOI packages was misplaced and could not be located. The FOI packages contain emails that discuss concerns addressed by citizens including traffic issues and shuttle services. The emails contain citizens first and last names and email addresses, and one citizens' address and phone number. Further review is underway to determine if additional personal or confidential information is contained in the packages.
