New Funding to Improve BC Transit Services

A total of \$6 million over 3 years is added to the budget of the Ministry of Transportation and Infrastructure for increased transit services. Along with funding added in previous years, this new allocation will help support a 2018/19 service expansion by BC Transit of over 40,000 additional hours in more than 20 communities for both conventional and custom transit.

Maintaining BC's Transportation Network

Budget 2018 provides the Ministry of Transportation and Infrastructure a further \$36 million over three years for the maintenance of BC's vast network of bridges and roads. Continued investment is important to ensuring roads are safe, reliable, cleared of snow and debris and the efficient movement of goods and people throughout the province, providing related economic benefits to all communities.

Making Travel on Coastal Ferries more Affordable

Budget 2018 includes incremental funding in the Ministry of Transportation and Infrastructure's budget to address government's commitment to freeze planned ferry fare increases, reduce fares on the minor routes and reinstate the seniors 100% discount Monday to Thursday. Final costs and service contract amendments are subject to negotiations with BC Ferries, but these fare relief initiatives will be in effect April 1, 2018.

Can you vet this also and let us know what would be palatable.

- *Freezing Fares on Major Coastal Routes:* For these three routes (Swartz Bay-Tsawwassen, Duke Point-Tsawwassen, and Horseshoe Bay-Departure Bay),

the BC Ferries contract will be amended to address the cost of eliminating fare increases of up to 1.9% that would have taken effect on April 1, 2018 and April 1, 2019. The increase would have applied to both vehicles and passengers.

- *15% Fare Reduction on Non-Major Routes:* About half of all passenger traffic occurs on routes other than between southern Vancouver Island and the Lower Mainland, mainly to/from the Gulf Islands, the mid-coast/Northern Vancouver Island, and to Haida Gwaii. As of April 1, 2018, fares on these routes will be reduced by 15%. For a car and driver traveling between Prince Rupert and Haida Gwaii, for example, this reduction saves the traveller \$53 on a single round trip fare.
- *Restoration of Seniors Discount:* In 2014, the weekday (Monday to Thursday) senior's discount on passenger fares was reduced from 100% to 50%. As of April 1, 2018, the 100% seniors discount will be restored. ^{s.13}

Q. Is punishment on ride hailing reserved for drivers, or are the companies or passengers liable for fines as well?

It is the driver, not the app companies, that are operating illegally and are subject to provincial penalties and fines of \$1,150. Municipalities may have business licensing requirements that apply to the companies, as well as the driver.

Q. How long has illegal ride hailing been an issue in B.C.?

The investigation and enforcement of illegal commercial passenger transportation, whether through apps, social media, Craigslist, or at curbside has always been part of the PT Branch's mandate. The first app-based service investigated was UberBlack in 2012. The PT Branch has been actively investigating the current group of unlicensed ride hailing services for the past year.

Q. How long have the six identified companies been operating?

The PT Branch has been actively investigating the current group of unlicensed ride hailing services for the past year.

Q. Who is the ministry trying to reach with the news release? Specifically drivers, the companies, passengers, etc?

The ministry would like to remind passengers that when they hail a ride in a vehicle through these apps, they are choosing to take a trip in a vehicle that has not been licensed to operate legally in B.C.

This is about passenger safety. The ministry wants to ensure that passengers are aware of the risks related to this industry. When they choose an unlicensed service provider, they are choosing to ride in a vehicle that has not had a government approved safety inspection and with a driver who may not have had a background check or a valid British Columbia drivers licence.

The drivers operating through these apps need to know that they are assuming all of the risk. They are subject to provincial and municipal fines and penalties as well they may be incur additional penalties for not disclosing the commercial use of their vehicles to their insurance company or lease company.

The Mayor said that he would like to see the speed limit through that stretch of highway changed from 60 KM an hour to 70 KM an hour, as he says that would be a more “realistic” speed and he thinks it should be changed accordingly. He also mentioned that the “ministry is already looking into this”. Reporter wants to know – is this true? Is the ministry considering changing the speed limit through this section?

Question – Do you have the collision stats (serious collisions – fatalities/ injuries) for the Sea to Sky Highway?
Specifically, looking for the last 5 years of data. 2013, 2014, 2015, 2016, and 2017 (if it's in).

RESPONSE:

Provided Background

After the \$600-million Sea-to-Sky Highway Improvement Project was completed in 2009, the number of collisions has gone down with a significant drop in serious collisions. These improvements have made this vital route a much safer and more reliable connection to the communities of Squamish, Whistler, Pemberton and more. Public safety has improved significantly, with more passing lanes, smoother curves, better sightlines, centre median barrier, reflective pavement markings and more effective intersections. It's important to also note that since then, traffic on the highway has increased by 24 per cent with an average of 19,000 vehicle trips made every single day.

- Prior to construction of the Sea to Sky Highway (2003 - 2007) = 470 serious collisions which is an average of 94 serious collisions per year with about 2.8 fatal collisions per year.
- During construction (Jan 2008 - Dec 2009) = 125 serious collisions which is an average of 63 serious collisions per year with about 2 fatal collisions per year.
- Post construction (Jan 1, 2010 - Dec. 31, 2016) = 504 serious collisions which is an average of 72 serious collisions per year with about 2 fatal collisions per year.

(Note: the ministry's collision information is based on police reported/attended collisions only. Other minor collisions that are not reported by police are not included. Fatal collisions are reported on an incident basis and not number of victims involved.)

The Ministry continues to make safety and efficiency upgrades to improve safety and mobility for motorists on this corridor, including \$1.1 million invested in 2017. These improvements included:

- o 1.4 km of median barrier between Lions Bay Avenue and Brunswick Beach Road,
- o 1 km of shoulder widening at Britannia Hill,
- o Flashing warning light at Mamquam Forest Service Road, and
- o Shoulder stabilization at Nairn Falls Hill.

Recommendation

- The safety of motorists on our highways is our number one priority.
- The ministry has received the request from the municipality to look into whether a higher speed limit would be appropriate for Highway 99 through Lions Bay.
- The ministry has agreed to look into it, and will begin with an engineering assessment of the highway and associated structures.
- We expect this work to begin sometime this year, but there is no timeline for completion.

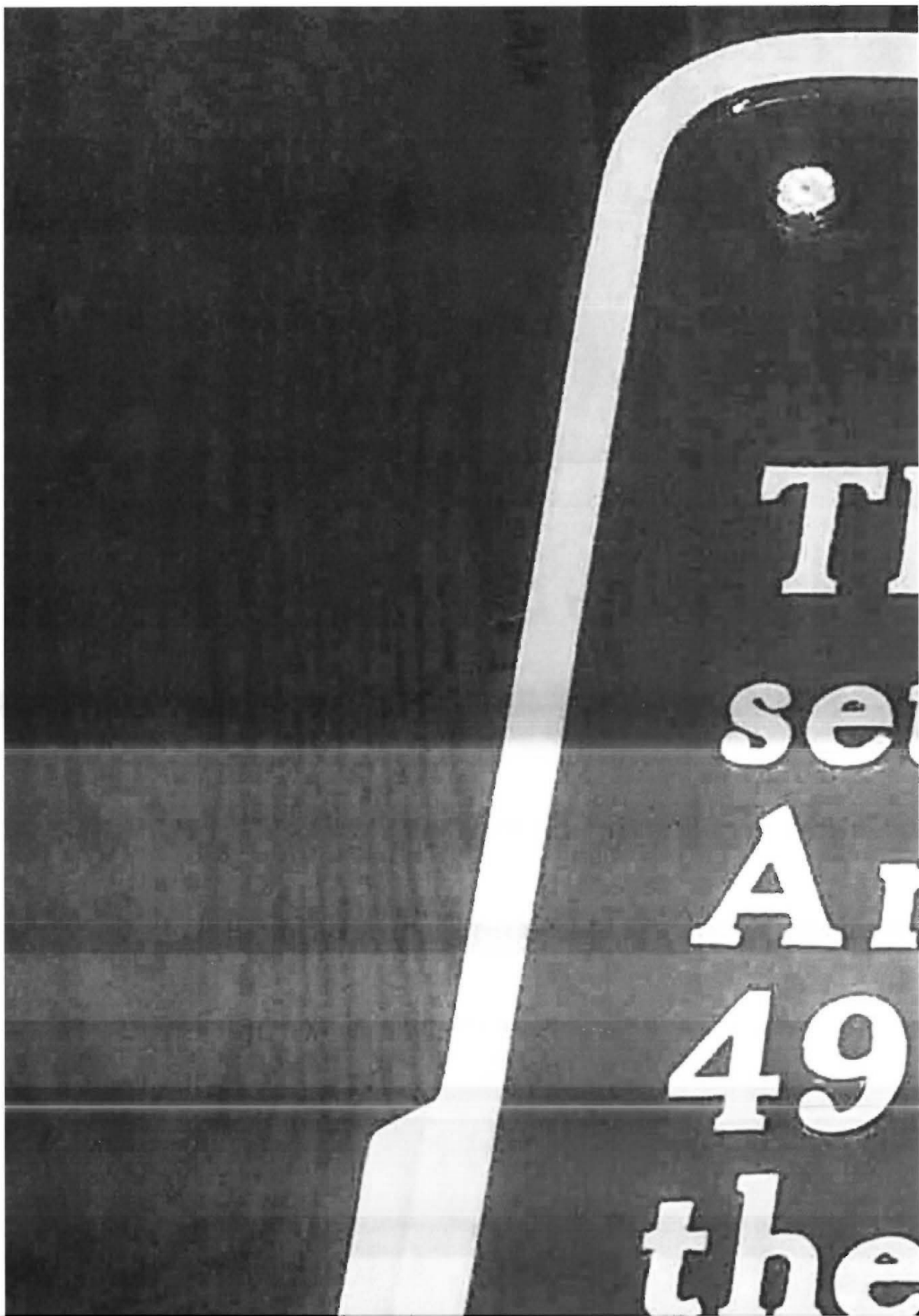

- What is B.C.'s current policy on this?
- How does the federal policy influence B.C.'s policy?

Background

Recommendation

The Council of Ministers of Transportation and Highway Safety discussed both Autonomous and Connected Vehicles, as well as Zero Emission Vehicles at their January 29th meeting.

Autonomous and Connected Vehicles (AVs)

The Province was a contributing participant in the development of the report: *The Future of Automated Vehicles in Canada*, that was presented to the Council of Ministers of Transportation and Highway Safety on January 29, 2018.

This report outlines some of the issues, such as protecting road safety and privacy issues, that need to be addressed to ensure a smooth integration of connected and automated vehicle technologies. It also outlines the next steps to be taken in this work:

- Develop a National Policy Framework to ensure the safe deployment of AVs on public roads;
- Continue to work closely with jurisdictions and international partners; and
- Continue to promote and invest in industry and academia to test and evaluate AV technology

British Columbia will continue work with the federal government and the other provinces to ensure that a national AV strategy is developed that will meet the needs of the Province. This work will take into consideration the findings of *The Future of Automated Vehicles in Canada* report <http://comt.ca/reports/autovehicle2018.pdf> as well as the findings of the federal Senate report *Driving Change: Technology and the future of automated vehicle*. The Senate report is available at: https://sencanada.ca/content/sen/committee/421/TRCM/Reports/COM_RPT_TRCM_AutomatedVehicles_e.pdf

The work to date has been focused on establishing a national strategy and policy to ensure that any regulations or policies are not made in isolation. Autonomous and Connect vehicle technology is rapidly advancing and the Province will continue to monitor new technologies as they develop.
