## PERMIT TO CONSTRUCT, USE AND MAINTAIN WORKS UPON THE RIGHT-OF-WAY OF A PROVINCIAL PUBLIC HIGHWAY

PURSUANT TO TRANSPORTATION ACT AND/OR THE INDUSTRIAL ROADS ACT AND/OR THE MOTOR VEHICLE ACT AND/OR AS DEFINED IN THE NISGA'A FINAL AGREEMENT AND THE NISGA'A FINAL AGREEMENT ACT.

("The Permittee")

#### WHEREAS:

- A. The Minister has the authority to grant permits for the auxiliary use of highway right of way, which authority is pursuant to both the Transportation Act and the Industrial Roads Act, the Motor Vehicle Act, as defined in the Nisga'a Final Agreement and the Nisga'a Final Agreement Act:
- B. The Permittee has requested the Minister to issue a permit pursuant to this authority for the following purpose:

The installation, operation, and maintenance of 10 new poles and related anchors (37L21, 37L22, 37L23, 37L24, 37L25, 37L26, 37L27, 37L28, 37L29, 37L29A) within Hwy 31, located between Hanson Road and the village of Ainsworth, as shown on drawings (Revision 4) attached.

C. The Minister is prepared to issue a permit on certain terms and conditions;

ACCORDINGLY, the Minister hereby grants to the Permittee a permit for the Use (as hereinafter defined) of highway right of way on the following terms and conditions:

- 1. That the construction of the said works is carried out in conformity with all legislation applicable to the Permittee or specifications by regulatory bodies having jurisdiction over the Permittee, and that the Regional Director, Transportation of the Province of British Columbia, or any person appointed by the Regional Director, Transportation shall have free access to all parts of the works for the purpose of satisfying himself that the works are being carried out in accordance with such legislation or regulatory specifications as aforementioned.
- That before opening up any highway or interfering with any public works, written notice of intention to do so must be given to the District Official at least seven clear days before the work is begun.
- That the construction of the said works shall be commenced on or before the June 7, 2019 and shall be prosecuted with due diligence and shall be completed on or before the December 7, 2019.
- 4. That where the work for which consent is hereby granted comes in contact with any bridge, culvert, ditch or other existing work, such existing work must be properly maintained and supported in such manner as not to interfere with its proper function during the construction of the new work, and on the completion of the new work the bridge, culvert, ditch, or other existing work interfered with shall be completely restored to its original good condition.
- That when necessary all excavations, materials, or other obstructions are to be efficiently fenced, lit, and watched, and at all times every possible precaution is to be taken to ensure the safety of the public.

6. The Permittee shall indemnify and save harmless the Ministry, its agents and employees, from and against all claims, liabilities, demands, losses, damages, costs and expenses, fines, penalties, assessments and levies made against or incurred, suffered or sustained by the Ministry, its agents and employees, or any of them at any time or times, whether before or after the expiration or termination of this permit, where the same or any of them are based upon or arise out of or from anything done or omitted to be done by the Permittee, its employees, agents or Subcontractors, in connection with the permit.

- 7. That after receiving notice in writing on the intention on the part of the Provincial Government to construct, extend, alter, or improve any public work, the Fermittee being responsible for the maintenance of the works for which consent is hereby granted shall co-operate with the District Official, and within three (3) months from receipt of notice all works shall be completed in moving or altering such work to such new position or in such manner as may be necessitated by the construction, extension, alteration, or improvement proposed to be carried out by the Provincial Government. The cost of all such work to be borne by the Permittee except in the case of cost sharing arrangement on pole relocations (refer to circular).
- 8. That while reasonable care will be taken on the part of the Provincial Government to do as little damage as possible to any private work in the carrying-out of the construction, extension, alteration, improvement, repair, or maintenance of public work adjacent thereto, the Provincial Government can accept no responsibility of any kind for such damage.
- 9. That this permit shall be in force only during such time as the said works are operated and maintained by the applicants or their assignees or successors in conformity with all legislation applicable to the Permittee or specifications by regulatory bodies having jurisdiction over the Permittee.
- The poles and other structures comprised in this permit shall be placed and maintained in such position within the limits of the public highway right-of-way as may be approved by the Regional Director, Transportation of the Ministry of Transportation and Infrastructure in writing.
- That these works shall be identified by the permit number in a manner satisfactory to the Regional Director, Transportation or his assistants at the expense of the Permittee. In the case of pole-lines, the permit number shall be scribed on the poles, and for underground work the location shall be marked with concrete blocks having their permit number marked thereon, the concrete blocks not to be less than 30 cm. by 30 cm. by 15 cm.
- As a condition of this permit, the permittee unconditionally agrees with the Ministry of Transportation and Infrastructure that the permittee is the prime contractor or will appoint a qualified prime contractor, as described in Section 118 of the Workers Compensation Act, for the purposes of the work described by this permit, at the work location described in this permit, and that the permittee or designated prime contractor will observe and perform all of the duties and obligations which fall to be discharged by the prime contractor pursuant to the Workers Compensation Act and the Occupational Health and Safety Regulation.
- 13. The permittee is advised and acknowledges that the following hazards may be present at the work location and need to be considered in co-ordinating site safety: overhead hazards, particularly electrical or telecommunications lines; buried utilities, particularly electrical, telecommunication, and gas lines; traffic, danger trees, falling rocks, and sharp or infectious litter.
- Any works within the Ministry right-of-way that fall within the scope of "engineering" under the Engineers and Geoscientists Act will be performed by a Professional Engineer, and shall comply with this Ministry's "Engineer of Record and Field Review Guidelines". The Guidelines can be viewed on the Ministry's website at <a href="http://www2.gov.bc.ca/assets/gov/driving-and-transportation/transportation-infrastructure/engineering-standards-and-guidelines/technical-circulars/2009/t06-09.pdf">http://www2.gov.bc.ca/assets/gov/driving-and-transportation-infrastructure/engineering-standards-and-guidelines/technical-circulars/2009/t06-09.pdf</a>
- 15. The permittee is responsible for preventing the introduction and spread of noxious weeds on the highway right-of-way as defined by the British Columbia Weed Control Act and Weed Control Regulation.
- 16. Please be advised that the Ministry of Transportation and Infrastructure annually implements and enforces its Seasonal Load Restriction Program. This Program will limit the axle weight of various vehicles at certain times of the year. Check with the local Ministry office to see how this permit may be affected by the Program.
- 17. Only rubber-tired equipment may be used on pavement or on shoulders of paved highways. Machines with steel tracks or flat steel pads must use swamp pads or rubber tires to protect the road surface. When heavy rubber-tired equipment is turning on the paved surface, care must be taken to prevent scarring.
- 18. Roadways, ditches, and right-of-way to be restored to their previous condition or better, to that which existed prior to the work(s), and to the satisfaction of the District Manager Transportation or his/her representative.
- 19. Any excavations outside of the road prism but within highway right-of-way shall be backfilled and compacted.
- 20. Shoulders must be restored to a well compacted, stable and free draining surface maintaining the existing crossfall. Shoulders must be compacted using industry standard equipment. If there is not sufficient moisture present in the material, the surface will be watered before compaction. Material must meet the following standards:
  - a) Base course aggregate: 25mm well-graded material (Section 202.05, Table 202-C, Standard Specifications for Highway Construction)
  - b) Surfacing: 25mm high fines surfacing (Section 202.05, Table 202-B, Standard Specifications for Highway Construction)

c) Asphalt surfacing: as specified for permanent patching

- d) All granular or other material must be removed from paved surfaces after shoulder restoration has been completed
- 21. The Permittee shall ensure that the ditches and back slopes shall be neatly sloped, finished and trimmed as per the Ministry's Standard Specifications for Highway Construction manual, Sections 201.37 and 201.38. Back slopes will be 1.5:1 or flatter, except in sand or similar material which shall be 2:1 or flatter or otherwise specified by the Ministry representative. All embankment fill slopes shall be 2:1 or flatter, with the exception of slopes qualifying for roadside barrier.
- Pole lines, ground anchors, stub poles and related facilities must be located and installed in such a manner that they do not interfere with right-of-way maintenance, must be consistent with Ministry "Clear Zone" standards and must not be concealed by vegetation. The Clear Zone is defined as the roadside border area immediately adjacent to the roadway clear of fixed object hazards which may be traversed by errant vehicles. The Clear Zone is measured from the outer edge of the traveled lane, including any paved shoulder width. Clear Zone setback requirements are specified in the BC MOT Utility Policy Manual and in the BC Supplement to TAC (Transportation Association of Canada) Geometric Design Guide.
- All work on Highways' right-of-way shall be during regular hours of operation, Monday to Friday, 8:00 4:30, except statutory holidays.
- 24. The Permittee shall obtain and maintain during the term of this permit and at the Permittee's own expense, liability insurance against third party claims arising as a result of the works consented to in this permit from the Permittee working within Ministry right-of-way. Such liability insurance shall have coverage limits of not less than TWO MILLION DOLLARS (\$2,000,000.00) for bodily injury, including death and property damage and shall be endorsed as follows:

"It is understood and agreed that Her Majesty the Queen in Right of the Province of British Columbia as represented by the Minister of Transportation, together with the employees, agents and servants of the Minister, hereinafter referred to as the Additional Named Insured as an Additional Named Insured." The policy shall contain a cross liability clause and a clause giving notice of cancellation or material alteration to the Minister.

- 25. The Permittee is responsible for all costs of maintenance or remedial work required as a result of these works for a period of two (2) years
- That if the Permittee violates any of the conditions of this Permit, the Permittee shall remedy the violation as expeditiously as possible in accordance with any direction which the Minister may give. In the event of a default, the Minister shall give notice to the Permittee requiring that the default be rectified within a reasonable period, having regard to all the circumstances. Failing rectification within the period of notice, the Minister may, but shall not be obligated to, remedy the default and the reasonable cost and expenses thereof shall be recoverable against the Permittee.

Without actually viewing the site in the field I can't give you definitive criteria. However, we agree that the concrete barrier could work to relax the clear zone requirements, and the tow of slope setback would likely not apply if that means the poles would be outside highway right of way. So, I suggest you give it a go with a design, and I will take a look at it. If things look really hairy, then we may need a design or assurance from a geotech professional to ensure that installation will not have a detrimental impact to the highway.

I did check to see if this area was near an avalanche path and it doesn't appear to be, based on the data source I used. So that's good.

Hopefully this helps a bit.

I am working on a project right now to move a section of our 37L down along Highway 31 near Coffee Creek. This would reroute a 700m section between 37L21 and 37L29 (Near the intersection of Hansen Rd and Highway 31). The image below shows the existing in purple and the proposed in red.

I have an initial design started but I want to ensure I adhere to all the MOTI requirements. My understanding is that all structures must be located at least 2m beyond the toe of embankment fills or top edge of cuts. They also must be located outside of the Clear Zone distance. This distance is dependent on speed limit of the highway along with the Design Classification. Might you be able to help me with these for Highway 31? Google Earth only shows construction speed zones and I am unsure where to find the design classification, I am leaning towards it likely being a RLU. There is also a note that offset requirements do not apply when an approved guardrail or other suitable and approved protection is installed. This section of highway does have a concrete barrier, would this work as an approved protection? Any help or guidance you could give would be greatly appreciated.

## PERMIT TO CONSTRUCT, USE AND MAINTAIN WORKS UPON THE RIGHT-OF-WAY OF A PROVINCIAL PUBLIC HIGHWAY

PURSUANT TO TRANSPORTATION ACT AND/OR THE INDUSTRIAL ROADS ACT AND/OR THE MOTOR VEHICLE ACT AND/OR AS DEFINED IN THE NISGA'A FINAL AGREEMENT AND THE NISGA'A FINAL AGREEMENT ACT.

**BETWEEN:** 

The Minister of Transportation and Infrastructure

West Kootenay District 310 Ward Street 4th Floor Nelson, BC V1L 5S4

("The Minister")

AND:

FortisBC Ashley Vecchio 1290 Esplanade Avenue Trail, British Columbia V1R 4T2

("The Permittee")

#### WHEREAS:

- A. The Minister has the authority to grant permits for the auxiliary use of highway right of way, which authority is pursuant to both the Transportation Act and the Industrial Roads Act, the Motor Vehicle Act, as defined in the Nisga'a Final Agreement and the Nisga'a Final Agreement Act;
- B. The Permittee has requested the Minister to issue a permit pursuant to this authority for the following purpose:

The installation, operation, and maintenance of 7 new poles and related anchors (37L22, 37L23, 37L24, 37L25, 37L27, 37L28, 37L29) and 3 existing poles and anchors (37L21, 37L26, 37L29A) within Hwy 31, located between Hanson Road and the village of Ainsworth, as shown on drawings attached.

C. The Minister is prepared to issue a permit on certain terms and conditions;

ACCORDINGLY, the Minister hereby grants to the Permittee a permit for the Use (as hereinafter defined) of highway right of way on the following terms and conditions:

- 1. That the construction of the said works is carried out in conformity with all legislation applicable to the Permittee or specifications by regulatory bodies having jurisdiction over the Permittee, and that the Regional Director, Transportation of the Province of British Columbia, or any person appointed by the Regional Director, Transportation shall have free access to all parts of the works for the purpose of satisfying himself that the works are being carried out in accordance with such legislation or regulatory specifications as aforementioned.
- That before opening up any highway or interfering with any public works, written notice of intention to do so must be given to the District Official at least seven clear days before the work is begun.
- That the construction of the said works shall be commenced on or before the January 28, 2019 and shall be prosecuted with due diligence and shall be completed on or before the June 28, 2019.
- 4. That where the work for which consent is hereby granted comes in contact with any bridge, culvert, ditch or other existing work, such existing work must be properly maintained and supported in such manner as not to interfere with its proper function during the construction of the new work, and on the completion of the new work the bridge, culvert, ditch, or other existing work interfered with shall be completely restored to its original good condition.
- That when necessary all excavations, materials, or other obstructions are to be efficiently fenced, lit, and watched, and at all

times every possible precaution is to be taken to ensure the safety of the public.

- 6. The Permittee shall indemnify and save harmless the Ministry, its agents and employees, from and against all claims, liabilities, demands, losses, damages, costs and expenses, fines, penalties, assessments and levies made against or incurred, suffered or sustained by the Ministry, its agents and employees, or any of them at any time or times, whether before or after the expiration or termination of this permit, where the same or any of them are based upon or arise out of or from anything done or omitted to be done by the Permittee, its employees, agents or Subcontractors, in connection with the permit.
- 7. That after receiving notice in writing on the intention on the part of the Provincial Government to construct, extend, alter, or improve any public work, the Permittee being responsible for the maintenance of the works for which consent is hereby granted shall co-operate with the District Official, and within three (3) months from receipt of notice all works shall be completed in moving or altering such work to such new position or in such manner as may be necessitated by the construction, extension, alteration, or improvement proposed to be carried out by the Provincial Government. The cost of all such work to be borne by the Permittee except in the case of cost sharing arrangement on pole relocations (refer to circular).
- 8. That while reasonable care will be taken on the part of the Provincial Government to do as little damage as possible to any private work in the carrying-out of the construction, extension, alteration, improvement, repair, or maintenance of public work adjacent thereto, the Provincial Government can accept no responsibility of any kind for such damage.
- 9. That this permit shall be in force only during such time as the said works are operated and maintained by the applicants or their assignees or successors in conformity with all legislation applicable to the Permittee or specifications by regulatory bodies having jurisdiction over the Permittee.
- 10. The poles and other structures comprised in this permit shall be placed and maintained in such position within the limits of the public highway right-of-way as may be approved by the Regional Director, Transportation of the Ministry of Transportation and Infrastructure in writing.
- 11. That these works shall be identified by the permit number in a manner satisfactory to the Regional Director, Transportation or his assistants at the expense of the Permittee. In the case of pole-lines, the permit number shall be scribed on the poles, and for underground work the location shall be marked with concrete blocks having their permit number marked thereon, the concrete blocks not to be less than 30 cm. by 30 cm. by 15 cm.
- As a condition of this permit, the permittee unconditionally agrees with the Ministry of Transportation and Infrastructure that the permittee is the prime contractor or will appoint a qualified prime contractor, as described in Section 118 of the Workers Compensation Act, for the purposes of the work described by this permit, at the work location described in this permit, and that the permittee or designated prime contractor will observe and perform all of the duties and obligations which fall to be discharged by the prime contractor pursuant to the Workers Compensation Act and the Occupational Health and Safety Regulation.
- 13. The permittee is advised and acknowledges that the following hazards may be present at the work location and need to be considered in co-ordinating site safety: overhead hazards, particularly electrical or telecommunications lines; buried utilities, particularly electrical, telecommunication, and gas lines; traffic, danger trees, falling rocks, and sharp or infectious litter.
- 14. Any works within the Ministry right-of-way that fall within the scope of "engineering" under the Engineers and Geoscientists Act will be performed by a Professional Engineer, and shall comply with this Ministry's "Engineer of Record and Field Review Guidelines". The Guidelines can be viewed on the Ministry's website at <a href="http://www2.gov.bc.ca/assets/gov/driving-and-transportation/transportation-infrastructure/engineering-standards-and-quidelines/technical-circulars/2009/t06-09.pdf">http://www2.gov.bc.ca/assets/gov/driving-and-transportation-infrastructure/engineering-standards-and-quidelines/technical-circulars/2009/t06-09.pdf</a>
- 15. The permittee is responsible for preventing the introduction and spread of noxious weeds on the highway right-of-way as defined by the British Columbia Weed Control Act and Weed Control Regulation.
- 16. Please be advised that the Ministry of Transportation and Infrastructure annually implements and enforces its Seasonal Load Restriction Program. This Program will limit the axle weight of various vehicles at certain times of the year. Check with the local Ministry office to see how this permit may be affected by the Program.
- 17. Only rubber-tired equipment may be used on pavement or on shoulders of paved highways. Machines with steel tracks or flat steel pads must use swamp pads or rubber tires to protect the road surface. When heavy rubber-tired equipment is turning on the paved surface, care must be taken to prevent scarring.
- 18. Roadways, ditches, and right-of-way to be restored to their previous condition or better, to that which existed prior to the work(s), and to the satisfaction of the District Manager Transportation or his/her representative.
- Any excavations outside of the road prism but within highway right-of-way shall be backfilled and compacted.
- 20. Shoulders must be restored to a well compacted, stable and free draining surface maintaining the existing crossfall. Shoulders must be compacted using industry standard equipment. If there is not sufficient moisture present in the material, the surface will be watered before compaction. Material must meet the following standards:
  - a) Base course aggregate: 25mm well-graded material (Section 202.05, Table 202-C, Standard Specifications for Highway Construction)

- b) Surfacing: 25mm high fines surfacing (Section 202.05, Table 202-B, Standard Specifications for Highway Construction)
- c) Asphalt surfacing: as specified for permanent patching
- d) All granular or other material must be removed from paved surfaces after shoulder restoration has been completed
- 21. The Permittee shall ensure that the ditches and back slopes shall be neatly sloped, finished and trimmed as per the Ministry's Standard Specifications for Highway Construction manual, Sections 201.37 and 201.38. Back slopes will be 1.5:1 or flatter, except in sand or similar material which shall be 2:1 or flatter or otherwise specified by the Ministry representative. All embankment fill slopes shall be 2:1 or flatter, with the exception of slopes qualifying for roadside barrier.
- 22. Pole lines, ground anchors, stub poles and related facilities must be located and installed in such a manner that they do not interfere with right-of-way maintenance, must be consistent with Ministry "Clear Zone" standards and must not be concealed by vegetation. The Clear Zone is defined as the roadside border area immediately adjacent to the roadway clear of fixed object hazards which may be traversed by errant vehicles. The Clear Zone is measured from the outer edge of the traveled lane, including any paved shoulder width. Clear Zone setback requirements are specified in the BC MOT Utility Policy Manual and in the BC Supplement to TAC (Transportation Association of Canada) Geometric Design Guide.
- All work on Highways' right-of-way shall be during regular hours of operation, Monday to Friday, 8:00 4:30, except statutory holidays.
- 24. The Permittee shall obtain and maintain during the term of this permit and at the Permittee's own expense, liability insurance against third party claims arising as a result of the works consented to in this permit from the Permittee working within Ministry right-of-way. Such liability insurance shall have coverage limits of not less than TWO MILLION DOLLARS (\$2,000,000.00) for bodily injury, including death and property damage and shall be endorsed as follows:

"It is understood and agreed that Her Majesty the Queen in Right of the Province of British Columbia as represented by the Minister of Transportation, together with the employees, agents and servants of the Minister, hereinafter referred to as the Additional Named Insured as an Additional Named Insured." The policy shall contain a cross liability clause and a clause giving notice of cancellation or material alteration to the Minister.

- 25. The Permittee is responsible for all costs of maintenance or remedial work required as a result of these works for a period of two (2) years
- 26. That if the Permittee violates any of the conditions of this Permit, the Permittee shall remedy the violation as expeditiously as possible in accordance with any direction which the Minister may give. In the event of a default, the Minister shall give notice to the Permittee requiring that the default be rectified within a reasonable period, having regard to all the circumstances. Failing rectification within the period of notice, the Minister may, but shall not be obligated to, remedy the default and the reasonable cost and expenses thereof shall be recoverable against the Permittee.

# PERMIT TO CONSTRUCT, USE AND MAINTAIN WORKS UPON THE RIGHT-OF-WAY OF A PROVINCIAL PUBLIC HIGHWAY

PURSUANT TO TRANSPORTATION ACT AND/OR THE INDUSTRIAL ROADS ACT AND/OR THE MOTOR VEHICLE ACT AND/OR AS DEFINED IN THE NISGA'A FINAL AGREEMENT AND THE NISGA'A FINAL AGREEMENT ACT.

("The Minister")

AND:

("The Permittee")

#### WHEREAS:

- A. The Minister has the authority to grant permits for the auxiliary use of highway right of way, which authority is pursuant to both the Transportation Act and the Industrial Roads Act, the Motor Vehicle Act, as defined in the Nisga'a Final Agreement and the Nisga'a Final Agreement Act;
- B. The Permittee has requested the Minister to issue a permit pursuant to this authority for the following purpose:

The installation, operation, and maintenance of 38L across Hwy 31, Riondel Rd, and Walkers Landing Rd, located as shown on drawing 38L Rehab 2018.

Brushing: May 1, 2018 - June 4, 2018 Rehab: June 4, 2018 - July 13, 2018

C. The Minister is prepared to issue a permit on certain terms and conditions;

ACCORDINGLY, the Minister hereby grants to the Permittee a permit for the Use (as hereinafter defined) of highway right of way on the following terms and conditions:

- 1. That the construction of the said works is carried out in conformity with all legislation applicable to the Permittee or specifications by regulatory bodies having jurisdiction over the Permittee, and that the Regional Director, Transportation of the Province of British Columbia, or any person appointed by the Regional Director, Transportation shall have free access to all parts of the works for the purpose of satisfying himself that the works are being carried out in accordance with such legislation or regulatory specifications as aforementioned.
- 2. That before opening up any highway or interfering with any public works, written notice of intention to do so must be given to the District Official at least seven clear days before the work is begun.
- That the construction of the said works shall be commenced on or before the May 1, 2018 and shall be prosecuted with due diligence and shall be completed on or before the July 13, 2018.

4. That where the work for which consent is hereby granted comes in contact with any bridge, culvert, ditch or other existing work, such existing work must be properly maintained and supported in such manner as not to interfere with its proper function during the construction of the new work, and on the completion of the new work the bridge, culvert, ditch, or other existing work interfered with shall be completely restored to its original good condition.

- 5. The Permittee shall indemnify and save harmless the Ministry, its agents and employees, from and against all claims, liabilities, demands, losses, damages, costs and expenses, fines, penalties, assessments and levies made against or incurred, suffered or sustained by the Ministry, its agents and employees, or any of them at any time or times, whether before or after the expiration or termination of this permit, where the same or any of them are based upon or arise out of or from anything done or omitted to be done by the Permittee, its employees, agents or Subcontractors, in connection with the permit.
- 6. That after receiving notice in writing on the intention on the part of the Provincial Government to construct, extend, after, or improve any public work, the Permittee being responsible for the maintenance of the works for which consent is hereby granted shall co-operate with the District Official, and within three (3) months from receipt of notice all works shall be completed in moving or altering such work to such new position or in such manner as may be necessitated by the construction, extension, alteration, or improvement proposed to be carried out by the Provincial Government. The cost of all such work to be borne by the Permittee except in the case of cost sharing arrangement on pole relocations (refer to circular).
- 7. That while reasonable care will be taken on the part of the Provincial Government to do as little damage as possible to any private work in the carrying-out of the construction, extension, alteration, improvement, repair, or maintenance of public work adjacent thereto, the Provincial Government can accept no responsibility of any kind for such damage.
- 8. That this permit shall be in force only during such time as the said works are operated and maintained by the applicants or their assignees or successors in conformity with all legislation applicable to the Permittee or specifications by regulatory bodies having jurisdiction over the Permittee.
- The poles and other structures comprised in this permit shall be placed and maintained in such position within the limits of the
  public highway right-of-way as may be approved by the Regional Director, Transportation of the Ministry of Transportation and
  Infrastructure in writing.
- As a condition of this permit, the permittee unconditionally agrees with the Ministry of Transportation and Infrastructure that the permittee is the prime contractor or will appoint a qualified prime contractor, as described in Section 118 of the Workers Compensation Act, for the purposes of the work described by this permit, at the work location described in this permit, and that the permittee or designated prime contractor will observe and perform all of the duties and obligations which fall to be discharged by the prime contractor pursuant to the Workers Compensation Act and the Occupational Health and Safety Regulation.
- The permittee is advised and acknowledges that the following hazards may be present at the work location and need to be considered in co-ordinating site safety: overhead hazards, particularly electrical or telecommunications lines; buried utilities, particularly electrical, telecommunication, and gas tines; traffic, danger trees, falling rocks, and sharp or infectious litter.
- 12. Any works within the Ministry right-of-way that fall within the scope of "engineering" under the Engineers and Geoscientists Act will be performed by a Professional Engineer, and shall comply with this Ministry's "Engineer of Record and Field Review Guidelines". The Guidelines can be viewed on the Ministry's website at http://www2.gov.bc.ca/assets/gov/driving-and-transportation-infrastructure/engineering-standards-and-guidelines/technical-circulars/2009/t06-09.pdf
- 13. The permittee is responsible for preventing the introduction and spread of noxious weeds on the highway right-of-way as defined by the British Columbia Weed Control Act and Weed Control Regulation.
