- The Lake Country Planning Study was identified as a priority area for further review in the Central Okanagan Planning Study (COPS).
- The technical findings of COPS, combined with a request from the District of Lake Country at the 2017 UBCM meeting resulted in a planning study getting underway to look at medium and long term options for the Highway 97 Corridor between Duck Lake and Lodge Road.
- The study includes the Glenmore/Beaver Lake Intersection, which is currently experiencing significant congestion and delays, especially during peak hours.

Work to date includes:

- A technical assessments to better understand the needs of the corridor.
- A world café style workshop in June 2019 to collect feedback from the public on the current conditions of the highway and to get their input on potential improvements.
- Following the workshop, development of 2 interim and 3 long-term options to improve highway 97 through Lake Country.

- An open house is planned for February 5<sup>th</sup> to collect feedback on these options, prior to identifying a preferred interim and long term option. The meeting will collect feedback through a paper feedback form as well as online via the PlaceSpeak public engagement platform.
- GCPE has been working closely with the team on the open house and materials.
- This is the first BC Government public engagement to use the PlaceSpeak public engagement platform, which is designed to be more interactive and provide more meaningful data and input to the project team.
- The final planning report is expected to be completed in late Spring 2020 and Ministry staff will report back to the community at that time to wrap up the planning work.

The team has pulled out some statistics below, the focus on the information provided is on IWMB, as this is where the significant change in patrol services is highlighted in the current contract.

## November 1, 2018 to October 31, 2019

195 incident entries at IWMB and its surrounding area (Cassiar Tunnel to Lynn Valley Rd)

- There were 110 events (65 minor events, 45 major events) that occurred within the current maintenance contracts enhanced hours (9:00am to 3:00pm, and 6:30pm to 11:00pm on weekdays - and 6:00am to 11:00pm on weekends and statutory holidays)
  - 39 events took place on weekends
  - Incident entry average duration time: 29:04 minutes \*Improvement of ~11
     Minutes from the last round of contracts

The greater impact to response times is generally for minor incidents (stalls, flat tires etc.) this is represented by the fact that in many cases the length of major events is not dictated by the lack of the presence of a maintenance contractor responding unit but other factors e.g. waiting on specialised alternative responding units.

If you're interested we can speak next week and I can walk through the information with you as well.

Evening MLA Ma, Ashok indicated you were inquiring with regards to some additional info on the enhanced towing services in the current maintenance contract. I understand he previously provided a summary. Since then we have been tracking the number of times the new units have been used in the enhanced hours and can offer the following comments:

- The enhancements in the current contract for indent response on the North Shore feature:
  - Extended hours where we now have additional patrol (tow) vehicles stationed around the Ironworkers and Lions Gate Bridge.
  - Type of patrol vehicles is now specified (regular 1 ton wrecker, a flat deck truck, or a heavy wrecker).
- As indicated in the previous table provided in Ashok's email, the enhanced service focuses on the IWMB, specifically:
  - Under the old contract, 32.5 hours per week of enhanced patrols.
  - Under the new contract, 114 hours per week (with an additional hour during a week in which there is a stat holiday) of enhanced patrols.
- Of the total number of incidents that units have responded to, 68% have occurred during the new expanded hours.
  - This is important as the previous alternative during this time period would have been to call in units from the maintenance contractors yard or available subcontractors.
- Another feature of the new contract are the specific requirements for the type of units.
  - Of the incidents responded to 80% were responded to by units capable of towing (flat deck, heavy wrecker).
