Hi Rob. PHAC assessed the crew member and stand by that assessment. They didn't call for the ambulance or have anything to do with that decision. Not sure who made that call. However, since that happened and the crew member went to the hospital, the crew member entered into the Provincial health care system. We don't have a window on the privacy of a patient information in the provincial health care system. We are arranging a teleconference for later this afternoon that will include ILWU, GCT, BCMEA and federal partners to ensure decisions are not being made on fear, assumptions or misinformation. Marko will let us know who to invite from ILWU since you are out of town.

Subject: Harbour Air: Request for Pandemic Carrier Status

Dear Minister Trevena,

As we have discussed before, Harbour Air is a significant part of the transportation framework of our Province. We service a multitude of communities that would be even more isolated without our service. As we move through the evolution of the COVID-19 pandemic, one of the challenges is maintaining that service throughout the coast and specifically to more remote areas.

Air Carriers, large and small are facing very tough decisions to stem the financial losses caused by this situation. Our loads have depleted to the point that we are considering stopping service to a number of communities. While the service is not completely empty, the passenger loads are not big enough to break even. What this means is that for the people who do require to travel for medical or other reasons for services such as blood deliveries, our coastal communities are at risk of losing service altogether.

In the B.C. Government naming us to be a Pandemic Carrier for the Province, and supporting emergency service status, we can work together to ensure that these communities are not left to fend for themselves.

We have the fleet size and lift capacity to assist in this coastwide if needed. This can be in freight or passenger services. Moving medical, or other support supplies to any of our coastal communities.

How we view this happening is we would be set up in the Provinces Emergency Operations Centre response system. We would also agree to maintain a certain level of scheduled service capacity to communities we currently service. With further discussion we could also add more destinations if needed. In maintaining an agreed to level of service, we would be looking to claim our Government standing order charter rates, less any revenue generated from the passenger or freight traffic utilizing that service.

Emergency supply services would also be at the Government standing order rate. Together in this we would be able to maintain service and be able to portray some normal status to the general public in this time of extreme uncertainty. As confidence grows in the community, and travel starts to rebound, the reliance on the Government support would diminish and eventually stop.

We look forward to discussing this further with the appropriate people in government in very short order before we are forced to make these unfortunate schedule decisions that will have a huge impact on our communities.

The info below is flowing to your teams via Deborah Bowman and David Crebo. I thought I would send it to you directly this once so you can see the type of info which is flowing. The situation the ferry system faces mirrors that of other transportation system, declines across the board in the 40% range. We are making what capacity matching decreases we can within the terms of the CFSC. In addition and as you may know, we have given the required 90 day notice to MOTI (via Deborah Bowman) for reducing designated minor routes back to contract while at the same time asking the Province to waive the 90 day period to allow the reductions immediately.

We are also preparing a Section 42 application to the BC Ferry Commissioner for temporary reduction in service across the system. This is preparatory work and we have not yet decided to file. We will let you know in advance of any filing.

Items to Note for Yesterday's Traffic:

- New Majors Traffic (Routes 1,2,3 & 30) fell 48% for Passengers, and 30% for vehicles yesterday compared to the previous year. Traffic declines across the New Majors and Minors continue to increase.
- Traffic on the Minor Routes is now seeing very similar results to the declines seen on the Majors, with YOY declines of 48% for passengers and 36% for vehicles yesterday.

Good morning,

As I know you are all acutely aware and can appreciate, the progression of the virus in B.C. is a rapidly evolving situation. The purpose of this message is to provide you with an update focused on our ministry's role, some of our actions to date, and how we can safely manage the workplace as we in the ministry play our vital part in managing through this challenging and complex event. Given the dynamic nature of these events, I will provide you regular updates with the latest information.

I would like to start by thanking all of you in the ministry who are already acting tirelessly supporting the provincial response. Please be assured your health and safety, and that of your families and communities, is paramount in how we will approach

through this difficult period – while continuing to provide the critical services Columbians rely on.

I will try not to duplicate important information readily available through existing sources that are being updated on a regular basis and reflect the expert advice from public health and human resource experts – my focus will be on ministry and information.

With respect to our workplaces and our approach to key ministry activities, co-ordinating Public Service's measures, here are guidelines we will be following:

- **Public Health Requirements:** First and foremost to protect yourselves and others (to avoid the risk of being repetitive) please be vigilant in practicing effective prevention through physical distancing, hand washing and adhering to all other measures, advisories, and orders communicated by Dr. Bonnie Henry, B.C.'s Provincial Health Officer (PHO), the BC Centre for Disease Control, and the BC Ministry of Health. This includes requirements for various circumstances for self-isolation, staying home if you are sick, travel advisories, and guidance and orders on events and gatherings. To support a safe work environment, workplace cleaning services are being increased to help protect the health of our staff and the public.
- **Working from Home:** Consistent with the approach across the Public Service, we support working from home where we can fulfil critical operational requirements. Accordingly, over the last few days each Department has been undertaking an assessment of its business and program area requirements to determine where working remotely is supported as needed, and which functions require staff in the workplace.

Departmental ADM's will be responsible for making those determinations with their respective work-unit supervisors. As such, I would ask that you reach out to your supervisor for guidance and discuss options specific to your work unit. We are focused on taking a 'common-sense', reasoned approach in all our decisions and hope you appreciate the variations across work units.

I also recognize there will be important personal circumstances for individuals that we are committed to supporting. In those situations, again we will take a common-sense approach. For example, if someone at home is vulnerable or requires your care for any number of reasons (e.g. health, spring-break, suspension of schools, etc.), please talk to your supervisor so accommodations can be made.

To our front-line staff who are essential for maintaining safety across our transportation system, your well being is our first concern, and we will be implementing enhanced safety procedures for you. More details on what exactly that looks like will be coming out soon. Again, almost certainly vary by the needs and business requirements of a specific unit.

- **Internal meetings** should be kept to small numbers of people where social distancing is possible. Generally speaking, let's look to carry out meetings over the phone or video where practical.
- **For gatherings including public events, conferences, external meetings and House Calls**, we have compiled a detailed list that covers the next few months. Decisions will be made on a case-by-case basis whether those activities will be cancelled, can be postponed, scheduled, be deferred, or conducted through other means. The advice and direction will be provided as it becomes available.

professionals will be the basis for those decisions. These kinds of events should be discussed with your supervisor and ADM.

- **Travel** should only occur if it is essential in carrying out a critical activity. If it can be deferred without compromising ministry responsibilities, or can be completed remotely, that should be the first option. Again, if in doubt please consult with your supervisor. As to the actions and role of the ministry in this time of COVID-19, the following are some of key activities:

- We are fully involved in the provincial emergency response, at all levels in the province. The **Provincial Emergency Coordination Centre (PECC)** has been opened up and is taking calls at 10 a.m. Our Director, Emergency Programs, Peter Prendergast, and Renée Mounteney attend.
- A **Joint Information Centre (JIC)** has been implemented; our very own Kathleen Mounteney is leading this work for government. There are also daily calls with the Government of Canada Communications network.
- Our ministry **Business Continuity Plans** have been updated and are ready to be implemented.
- Our Chief Engineer, Ian Pilkington, together with Peter, is leading our ministry's emergency response coordination in concert with our transportation sector partners (BC TransLink, BC Ferries, BC Bus North, etc.).
- Renée Mounteney, myself, and other members of the executive are taking part in cross-government committees to plan and coordinate our path forward and ensure that the ministry has the latest information.
- There are daily calls (sometimes more) with Minister Trevena where we take turns to brief the Minister on our ministry activities. The Minister is leading the emergency communications with key stakeholders throughout the transportation sector.

More generally, and as a good foundation to understand the Public Service's approach to monitoring, planning and responding to the virus, if you have not yet had the chance, I encourage you to read [the email sent to all staff last Friday by Don Wright, Deputy Minister, to the Premier, and Head of the Public Service](#).

In addition, the Public Service Agency (PSA) has also developed informative documents including an overview of the BC Public Services response to COVID-19 and a compendium of Frequently Asked Questions. These range from general information about the virus to workplace measures, exposure due to travel, and other important topics. These documents are excellent sources of information and can be found through the PSA website [here](#) and are also available through the Information and Resources bulletin board on the **TRANnet** site. We will use our TRANnet site to house all the latest information available for you, and provide links to valuable, reliable resources and sites. If you have questions that are not addressed in the available information resources, please:

- seek advice through the MyHR service or raise your questions with your supervisor.
- In the case of a genuinely urgent workplace safety emergency, you can also call 952-0911.
- If you or a family member are experiencing symptoms, or need medical advice, call 811 immediately, call 811. The Province has also launched an online symptom checker.

(<https://covid19.thrive.health/>). If you think you might have symptoms, but an online symptom checker is a useful tool before calling 811.

- For all non-clinical questions on COVID-19, including the latest travel restrictions, distancing, and provincial and federal programs, call 1-888-COVID-19. Services are available 7 days/week, from 7:30am – 8pm in multiple languages. Of course, the Centre for Disease Control is also a definitive source of excellent, easy-to-understand information at www.bccdc.ca.

Your supervisor and the ministry Executive are here to support you and hear your questions you might have. We are tracking these questions, and if we can't provide an immediate answer, or direct you to a reliable source, will seek to provide you with an answer as quickly as possible. As this situation continues to evolve, I will ensure you are kept in the loop either through these communications or through the leadership in your work-unit. I hope you can appreciate that this is a fluid and rapidly changing environment; things will change at any time.

In closing, your health and well-being as employees is first and foremost on our minds as we provide critical services to British Columbians, ensuring the safety and security of our province and our provincial transportation network. We should all be proud of each other in this ministry, and continue to support one another, as we do every day. A heartfelt thank you for your commitment to continue to provide excellent public service while we work to contain and limit the spread of COVID-19. Thank you again to those who are actively contributing to the ministry response, and to all of you for your cooperation, understanding and patience during this challenging time as we continue to work through this together.

To conclude, and to quote Dr. Bonnie Henry from her news conference today – “Be kind, be calm, and be safe”. Thank you again.
