"I am very pleased that after talks with BC Ferries, passenger service between West Vancouver and Nanaimo has been reinstated. Because of the pandemic, the Province and BC Ferries negotiated temporary service reductions which are due to expire on June 3rd.

"We have been working closely with BC Ferries to get service back to levels that people need. Since the Premier announce the gradual reopening of our economy, we have seen increased interest in travel, which is why this service is resuming.

"We need to match the increase confidence of British Columbians using our transportation network, with the appropriate level of service. Transport Canada regulations, which limit passenger capacity to 50 percent, are still in effect.

"We are still urging everyone to avoid non-essential travel, and not to visit other communities, to prevent the spread of COVID-19.

"The reinstated service is good news for essential travel and helps support supply chains. People trust our transportation network and we are providing the service they need to travel safely.

Kevin and Geoff,

Thank you for your proposed approach to address TransLink's challenges, which have resulted from COVID-19 and an associated decline in revenues. We both acknowledge that TransLink's revenue impacts are significant and that reductions in TransLink's essential services are not in the interests of the Lower Mainland communities or the Province as a whole. Accordingly, we need to work together within the context of these objectives to support TransLink to manage the COVID-19 response and recovery phases and meet the organization's 10-Year Investment Plan.

Common principles underlying this approach include:

- Recognition that TransLink is an essential service that is critical for the recovery of the Lower Mainland and British Columbia and it is not in the public interest that TransLink reduce services at a time when the province is working to recover from COVID.
- Support for a solution to TransLink's challenges requires the involvement of all levels of government along with TransLink.

- Acknowledgement that the transit environment in the Lower Mainland is uncertain, through the COVID-19 recovery phase, and this will continue to impact on TransLink's operations and finances.

We appreciate the significant work and information sharing that TransLink has provided the Province. This information is critical for our understanding of TransLink's circumstances and we believe that more time is needed to adequately analyze TransLink's challenges and opportunities, particularly as we transition into a restart of the economy and expect the factors impacting TransLink's finances will shift. As such, both parties need more time to come up with a Memorandum of Understanding, based upon a collaborative approach, that defines solutions for all of the parties involved and enables staff to return to their decision-makers.

Thank you for sharing your proposed principles for framing the challenges and how we can agree to move forward. We propose the following amendments:

1. The Province of B.C. and TransLink agree that transit service in Metro Vancouver will be key in British Columbia's transition and recovery success.
2. The Province and TransLink continue to work in good faith to find short and long-term solutions to address the major financial impacts that TransLink has already incurred and will continue to incur due to the COVID-19 crisis.
3. The Province of B.C. agrees that TransLink's financial stability is critical for delivering the services and mobility the region needs to rebuild and prosper in the coming months and years, and that achieving this stability includes working with all levels of government to resolve pandemic related financial impacts.
4. As a first step, the Province and TransLink agree that the transit service reductions and associated layoffs planned for May 18 should be suspended so that the first stage of the BC Restart Plan that begins on May 19 will be supported with sufficient levels of transit service in Metro Vancouver.

7. The Province of B.C. and TransLink agree that this agreement is a first step to support the first stage of the BC Restart Plan, while the Province of B.C. and TransLink develop a more formal agreement, such as an MOU, to facilitate the execution of these terms.

Canadians from coast-to-coast-to-coast have come together to fight COVID-19. The pandemic has impacted millions of hard-working people on the frontline, neighbours, friends and family across our country.

Our core responsibility, as Transportation Ministers for the provinces with Canada's largest transit systems, is to ensure that our residents can get to the people and places they need to and that the important goods we rely on arrive in our stores and at our ports on time. Affordable, accessible and effective public transit systems are important to our communities.

Our public transit agencies are facing an unprecedented financial challenge as a result of the COVID-19 pandemic. Significant drops in ridership have had a devastating impact on operating revenue for transit agencies across the country, with millions of dollars being lost every month. We acknowledge our role in tackling this issue, but no individual level of government can solve this critical challenge alone.

We appreciate our ongoing partnership with the Federal Government on the response to the COVID-19 pandemic.
