Good morning Claire

I write to you extremely frustrated with BC Ferries. They have recently changed their assured loading process and made it too expensive and too intensive to be usable by patrons such as myself who must travel s.22 I will explain shortly. I have attempted to post a complaint to the BC Ferries web site and each time it errors out and makes me re-enter my complaint by retyping it in full. I am (as are all people who complain) disallowed a copy/paste function. It seems a good way to frustrate complaints, frankly. Calling Ferries head office is equally frustrating. I spent twenty minutes on the phone listening to scheduling and booking information in which I wasn't interested, only to get to a message that it would be another 90 minutes before an agent would be available. Excellent! That is GREAT customer service.

I also understand the need of the Ferry Corporation to control abuse of the Assured Loading system but frankly, the people I know who have used it in the

past, myself included, have been very circumspect in pulling out the paperwork.^{s.22}
