SUMMARY:

 The Integrated Transportation and Development Strategy (ITDS) will support the province's economy, affordability and social equity initiatives, climate action, and strengthen community resilience.

 The Ministry of Transportation and Infrastructure (TRAN) is accountable for the overall delivery of the ITDS and responsible for the transportation related inputs. The Ministry of Municipal Affairs is responsible for land use and community planning components as well as supporting TRAN in the delivery of the ITDS.

BACKGROUND:

With B.C.'s population expected to grow by another million people by 2035, integrated transportation and development planning is necessary to support the province's economy, affordability, work on climate action, and strengthen community resilience. An integrated systems approach to planning is required to meet these objectives.

The Minister of Transportation and Infrastructure's mandate letter states that the Minister is responsible to "lead work on the Integrated Transportation and Development Strategy to ensure greater alignment between transportation and land-use planning". The Minister of Municipal Affairs' mandate letter states that the Minister is responsible to "support the Minister of Transportation and Infrastructure to work on the Integrated Transportation and Development Strategy to ensure greater alignment between transportation and land-use planning."

DISCUSSION:

The Ministry of Transportation and Infrastructure (TRAN) is accountable for the overall delivery of the ITDS and is responsible for the transportation related inputs, including, but not limited to engagement with transportation stakeholders. In addition to supporting the TRAN minister in the delivery of the ITDS, the Ministry of Municipal Affairs is responsible for the land-use and community planning components including engagement with community stakeholders such as local governments, and the Union of British Columbia Municipalities (UBCM). TRAN is also responsible for ensuring the participation of other ministries, including Jobs, Economic Recovery, and Innovation, Attorney General (Housing), and Environment and Climate Change Strategy, which are critical to the successful development of the ITDS.

Based on the mandate letters of the Ministers of Transportation and Infrastructure and Municipal Affairs a roles and responsibilities matrix has been proposed (Appendix B).

At the initiation of the project, success depends on the articulation of project objectives and the implementation path, as well as project governance structure including roles and responsibilities. SUMMARY:

- BCTA has concerns that a greenhouse gas (GHG) reduction sector target directed at Heavy-Duty Vehicles may not be achievable.
- BCTA is involved in the Drayage industry and represent 62 companies (out of 77 licensed companies).

BACKGROUND:

GHG Emission Targets

CleanBC has established GHG emission reduction targets for the Province and by March 31, 2021 the Province has committed to establishing sectoral targets.

The Climate Action Secretariat (CAS) in December 2020 released a discussion paper to key stakeholders on developing these targets. To establish draft sectoral targets, CAS is combining this feedback with data from its GHG modeling. These draft targets will be discussed at the ADM Working Group on Climate Action on February 26th and PPC on March 4th.

The BCTA has concerns over the ability to meet any targets that are directly applied to heavy-duty vehicles. Their concern is based on the current lack of Zero-Emission heavy-duty vehicles available to purchase and the length of time it will take to turn over the fleet to Zero-Emission vehicles.



Drayage Status and Limitations

Since its establishment in 2015, the British Columbia Container Trucking Commissioner (OBCCTC) has been active in auditing and enforcement of the regulated rates, labour conditions and setting rates by order. The OBCCTC uses contracted auditors, investigators and a contracted confidence line to support compliance monitoring and enforcement activities.

Licensing

In 2020, the OBCCTC issued a new license framework and rolled out an updated truck tag policy.

On July 6, 2020 the OBCCTC issued a release to open the application process for the 2020 Container Trucking Services (CTS) license. On September 9, 2020 the OBCCTC issued conditional approval letters to companies stating the number of truck tags to be issued effective December 1, 2020.

Following conditional approvals, 20 companies applied to seek a judicial review of the license application process. Therefore, these companies will continue operating under their 2018 CTS License pending the results of the judicial review process. Timing for outcomes of the judicial review is unknown.

The Commissioner assigned truck tags to licensees based upon an assessment of an applicant's historic fleet efficiency, compliance history and submitted business case.

The Commissioner prioritized removing truck tags that were already vacant or were severely underutilized over several years. The licensing process began with a pool of 1,618 truck tags. Following the formal review of applications, a total of 1,557 truck tags were conditionally approved to 78 companies.

Off-Dock Regulation

In May of 2020, the Province and the OBCCTC commissioned a study to better understand off-dock truck trips that support containerized shipping throughout the lower mainland.

The report was released publicly in September and the Commissioner actively sought feedback from stakeholders over the Fall. The Commissioner has provided a draft set of recommendations to the Province which is currently being reviewed.

Electronic Logging Devices (ELDs)

ELDs are a piece of equipment or software which synchronize with the engine to automatically record driving time and other duty statuses of drivers. The devices help ensure compliance with hours of service regulations because drivers are less able to record false data regarding the length of time they have been driving.

As of June 12, 2021, commercial vehicles that cross provincial borders will be required to be equipped with an ELD. s.13

Transport Canada has established a third-party accredited certification body for ELDs, it is anticipated that the first devices will obtain certification later this month.

PAST INTERACTIONS:

- Ministry staff have a good working relationship with BCTA and regularly engage on variety of related topics.
- The Ministry has a partnered with the BCTA to administer the CleanBC Heavy-Duty Vehicle Efficiency Program on behalf of the Province. This 3-year program has an annual budget of \$1.4M (\$900,000 from CleanBC; \$500,000 from MOTI Climate Action budget).

ISSUE: Lower Mainland Container Trucking – Off-Dock Regulation

PURPOSE: To provide a briefing on potential actions Commissioner can take with regards to regulating

the drayage off-dock sector on March 2, 2021.

SUMMARY:

Under the Container Trucking Act, trucking companies requiring access to a marine terminal (on-dock)
must be licensed by the BC Container Trucking Commissioner and pay specific rates of pay to drivers.
Trucking companies without a licence do not have to pay the required rates.

- Unifor and the United Truckers Association (UTA) have raised concerns about unregulated off-dock activity and associated rate undercutting in the Lower Mainland container trucking sector.
- The Commissioner has developed draft recommendations regarding off -dock container trucking based on an off-dock report commissioned by the Commissioner and TRAN, and subsequent consultation with industry.

BACKGROUND:

Rate undercutting was a key issue of the 2014 work stoppage by truck drivers servicing Port of Vancouver container terminals. In 2014 the Provincial and Federal governments, Unifor and United Truckers Association agreed on a plan (Joint Action Plan) to address several issues including rate undercutting.

The provincial government introduced the *Container Trucking Act*, *Container Trucking Regulation* and a licensing regime in response and created the Office of the BC Container Trucking Commissioner (OBCCTC) to enforce the regulatory regime. All trucking companies needing access to a Port of Vancouver marine terminal must be licensed by the OBCCTC and follow all requirements of the regulatory regime, including paying minimum rates (hourly or per trip).

Stakeholders identified a loophole to avoid paying the required off-dock rates by using drivers at unlicensed trucking companies (some of which are owned by licensees) to perform off-dock work. As a result, Unifor and UTA members, working for licensed companies have been losing off-dock work to drivers at unlicensed companies who are paid lower rates.

In May of 2020, the Province and the Commissioner commissioned a study to better understand off-dock truck trips that support containerized shipping throughout the Lower Mainland. The report was released publicly in September and the Commissioner has actively sought feedback from stakeholders including labour groups who provided written responses.

PAST INTERACTIONS:

- The Minister met with the UTA on February 2, 2021
- The Ministry provided a container trucking update to members of the Surrey Caucus on February 22, 2020.



DISCUSSION:

There is an opportunity for the Province and the Commissioner to take steps to affect positive changes for the industry in response to concerns raised by stakeholders. The off-dock report identified several important insights that could inform potential amendments to the scope of the Regulation, rates and CTS licenses.

The Commissioner has considered all stakeholder input and the findings of the off-dock report and developed potential options. Each option discussed below has been developed with a view to ensure that minimum rates, enforced by the Commissioner are applied to each container move intended to be regulated. It is not proposed that the Commissioner enforce rates of pay for moves never intended for regulation.

Any recommended changes to rates and regulations should be considered through the lens of the established core principles for container trucking (fairness, stability, efficiency, and competitiveness). It is preferable but unlikely that all stakeholders will agree on a specific solution.

The recommendations have been grouped into the following three options:








ISSUE: Lower Mainland Container Trucking Update

PURPOSE: Background information for Surrey Caucus container trucking briefing on February 17, 2021

PROPOSED KEY MESSAGES:

 Fairness in the trucking industry is important to our government. We have listened and consulted with industry to promote a healthy, stable and balanced sector.

- Under the Container Trucking Act, the Office of the BC Container Trucking Commissioner (OBCCTC)
 issues licences to trucking companies, enforces regulatory compliance, sets trucking rates, and enforces
 them.
- The Commissioner is developing recommendations regarding off -dock container trucking, which will be submitted to government in early 2021. Recommendations are based on a report on Off-dock commissioned by the OBCCTC and MoTI, and subsequent consultation with industry.

BACKGROUND:

The OBCCTC is responsible for regulating the industry, issuing licenses to companies requiring access to Lower Mainland ports and enforcing rates through audits and decisions. The established core principles for the OBCCTC are fairness, stability, efficiency and competitiveness.

There have been three previous work stoppages by truck drivers servicing Port of Vancouver container terminals (1999, 2005, 2014).

The key issues of the 2014 stoppage included:

- Rate undercutting
- Poor labour practices (driver abuse, underpayment, immigration fraud etc.)
- Port terminal inefficiencies (wait times for drivers/reservation system issues)

In 2014 the Provincial and Federal governments, Unifor and United Truckers Association agreed on a plan to address issues (Joint Action Plan):

- o Stabilize rates and end unscrupulous labour practices
- Reform industry and licence newly reformed industry (Fed/Port & Province)
- End wait times and fix terminal efficiency/reservation issues (Fed/Port)
- The OBCCTC was created to enforce legislation



Licensing

From September 2019 to the end of February 2020 the OBCCTC conducted stakeholder engagement on proposed reforms to the Container Trucking Services (CTS) licensing process and the truck tag policy, including updated information requirements and clear evaluation criteria for companies seeking licenses to perform container trucking services to and from Lower Mainland ports and off-dock services.

On July 6, 2020 the OBCCTC issued a bulletin to open the application process for the 2020 CTS license. Applications were due to the OBCCTC by August 4, 2020. On September 9, 2020 the Office of the British Columbia Container Trucking Commissioner (OBCCTC) issued conditional license approval letters to companies outlining the number of truck tags to be assigned to each license effective December 1, 2020.

Off-Dock

In May of 2020, the Province and the OBCCTC commissioned a study to better understand off-dock truck trips that support containerized shipping throughout the lower mainland.

The report was released publicly in September and the Commissioner has actively sought feedback from stakeholders including labour groups who provided written response. The commissioner's report and recommendations are expected in early 2021.

PAST INTERACTIONS:

 The Ministry and OBCCTC provided a container trucking update to members of the Surrey Caucus on July 10, 2020.

DISCUSSION:

Licensing

Within the licensing process, the Commissioner prioritized removing truck tags that were already vacant or were severely underutilized over several years. The licensing process began with a pool of 1,618 truck tags. Following the formal review of applications, a total of 1,557 truck tags were assigned to 78 licenses/companies. Truck tags were assigned to licensees based upon an assessment of an applicant's historic fleet efficiency, compliance history and submitted business case.

The purpose of the licensing reform process was to enhance compliance and to ensure that appropriate amount of truck tags were assigned across the licensed fleet. The process was meant to ultimately benefit drivers by better matching the number of drivers with available on-dock work.

Following conditional approvals, 22 companies as well as the Port Transportation Association sought a stay of the licensing process and applied to seek a judicial review of the license application process. The courts granted the stay application; therefore, these companies continue to operate under their 2018 CTS Licenses pending the results of the judicial review. Timing for outcomes of the judicial review is unknown.

Off-Dock

There is an opportunity for the Province and the Commissioner to take steps to affect positive changes for the industry in response to concerns raised by stakeholders in this off-dock report. The report identified several important insights that could inform potential amendments to the scope of the Regulation, rates and

Any recommended changes to rates and regulation should be considered through the lens of the established core principles for container trucking (fairness, stability, efficiency and competitiveness), and all stakeholders including licensees, industry associations and labour representatives must work together on viable solutions.

APPENDIX A: Questions and Answers

1. What do we mean by licensed and unlicensed off-dock?

- Licensed off-dock work is done by companies that are licensed through the Office of the British
 Columbia Container Commissioner (OBCCTC) and performed by trucks that have been allocated
 truck tags by a licensed company. Trucking companies are required to adhere to the rate structure
 set by the Commissioner. There are currently 79 licensed companies and 1632 truck drivers of
 which 832 are Independent Owner-Operators (I/O) and 800 are company drivers.
- Unlicensed off-dock work is done by companies that are not licensed through the OBCCTC and may
 be doing various types of off-dock work (e.g. moving non-marine containers that are not directly
 related to on-dock container moves).
- Unlicensed companies do not fall into the purview of the current OBCCTC's regulatory authority and so cannot be compelled to pay rates set by the Commissioner.

2. Why is it so difficult to enforce off-dock rates?

- The extent of the Commissioner's regulatory jurisdiction and enforcement of off-dock rates extends
 only to companies that possess a Container Truck Services License which is required to access a
 port. The Act and Regulation does not apply to companies without a license and as a result they are
 not accountable to the regulated off-dock rates.
- This can be challenging to enforce as some licensed companies have been found to be affiliated with unlicensed companies who conduct off-dock work on their behalf to avoid paying set off-dock rates.
- The drayage sector handles approximately 1.75 million containers annually, made up of:
 - 1 million on-dock container moves; 50/50 split between imports and exports.
 - Approximately 750,000 off-dock container moves, with the majority of moves between container storage facilities and logistics/transload facilities.
 - It is estimated that of the 750,000 off-dock moves, upwards of 40% is being moved by unlicensed operators, who either are directly affiliated or have a business partnership with a licensed company.
 - There are reported to be hundreds of off-dock facilities in the lower mainland.
 (*Note these figures are based on a combination of several data sources including container volume information from the Port of Vancouver and survey / interview data collected during stakeholder engagement for the off-dock report*)

3. What are stakeholder concerns with the current regulatory structure?

Some labour groups representing drivers view the Commissioner's regulatory jurisdiction as
insufficient, and believe companies operating outside the CTS license system are working around the
rules by underpaying drivers and by extension taking work away from drivers working for CTS
licensed companies, particularly I/O drivers who must be paid relatively higher rates for off-dock
trips.



- Licensed companies without affiliates who are paying the regulated rates are losing business to companies that are working around the regulations.
- Licensed companies with affiliates are benefiting by not paying the regulated rate.
- Licensed drivers are losing out on work to unlicensed drivers who are paid less.

4. How could these concerns be addressed?

The Commissioner's preliminary views on off-dock policy options are focused on expanding rate regulation to restore a competitive balance in the sector for licensees while increasing the amount of work available for licensed drivers. In doing so, the Commissioner is focused on ensuring that drayage remains cost competitive by removing the current trip rate/hourly rate structure that has been driving up costs, encouraging non-compliance and destabilizing the sector.

5. What will be the economic impact to the gateway by increasing regulation?

The Commissioner will consider steps to mitigate the economic impact to the gateway through his recommendations. The Commissioner has indicated that these will include the introduction of an all hourly rate payment model for the sector. The Commissioner believes that this will increase work opportunities (with a corresponding increase in earnings) for drivers, encourage greater industry compliance with the Act and honour the spirit of the Joint Action Plan by applying a minimum regulated rate to the movement of all containers in the Lower Mainland being used for the marine transportation of goods..

6. In preparing recommendations what tools have been used for evidence decision making? The Commissioner has a variety of data sources that will be used to inform his recommendations. These include the findings of the third-party off-dock report, feedback from extensive stakeholder consultation, data generated from the Port of Vancouver's truck performance monitoring program and container volume data collected by the Port of Vancouver. This is in addition to the data already collected during the 2018 Rate Review and through OBCCTC audits.

7. What are the commissioner's expected timelines for implementing these recommendations?

In 2021, the Commissioner will present his recommendations to government. An implementation plan will then be developed by the province which could include the s.13 s.13



APPENDIX B: MELT and ELD Bullets

Electronic Logging Devices (ELDs)

- ELDs are a piece of equipment or software which synchronize with the engine to automatically record
 driving time and other duty statuses of drivers. The devices help ensure compliance with hours of
 service regulations because drivers are less able to record false data regarding the length of time
 they have been driving.
- The benefits gained from ELDs will positively affect drivers, carriers, inspectors and auditors due to
 more efficient roadside inspections and audits, reductions in administrative costs associated with
 completing and monitoring hours of service (HoS), and reductions of costs resulting from unsafe
 driving attributed to driver fatigue and HoS violations.
- As of June 12, 2021, commercial vehicles that cross provincial borders will be required to be equipped with an ELD.s.13

 ELDs were mandated in the US in 2018.

- There were delays for Transport Canada establishing a third-party accredited certification body. As of February 10, 2021, there are no certified ELD devices and it is understood that it will take the certification body six to eight-weeks to certify an ELD. It is anticipated that the first devices will obtain

certification in the coming months.

 B.C will need to undertake industry-specific consultation with industries that are provided specific HoS rules (i.e. logging, oil & gas, motion picture industries), as well as with the accreditation bodies, to better understand whether these HoS rules can be included in the certification process.

Mandatory Entry Level Training (MELT)

- The December 2018 Auditor General report on Commercial Vehicle Safety in B.C. recommended considering MELT as part of evaluating licensing strategies.
- Implementing MELT in B.C. would demonstrate that B.C. is aligned with other Canadian and U.S.
 jurisdictions including the federal government who, through the Canadian Council of Motor Transport
 Administrators, have developed national guidelines for an entry level standard that will be included
 in the National Safety Code.
- Canadian jurisdictions that have now implemented Class 1 MELT include Ontario, Saskatchewan,
 Alberta and Manitoba. The European Union introduced a mandatory training/testing model in 2014,
 while the United States must be compliant with US Federal MELT requirements by 2022 for all
 commercial driver's licence (DL) classes.
- The Ministry of Transportation and Infrastructure, Ministry of Public Safety and Solicitor General and ICBC have developed pre-licensing training requirement which could be implemented to ensure better-trained drivers and safer roads.
- Stakeholder consultation occurred in the summer and fall of 2019 including: BC Trucking Association, All Nations Driving School, Private Motor Truck Council of Canada, WorkSafeBC and the Industry Training Authority.
- During industry consultations, Class 1 training schools requested a six-month lead time to implement MELT to allow their students to complete training courses they are actively in, and to enable schools to prepare and transition to delivering the new curriculum.
- The proposed B.C Class 1 MELT considers aspects of the other provincial programs and is tailored to B.C.'s unique geography (traversing mountain passes, chain up requirements, etc.).
- Provincial legislation to support the introduction of B.C.'s Class 1 MELT program was passed in August 2020 in Bill 2, the *Motor Vehicle Amendment Act*, 2020. This legislation enables government to develop regulations requiring pre-licensing training for any class of DL. s.12; s.13 s.12; s.13
- There are currently 101,000 B.C. drivers hold a Class 1 DL; on average 3,000 new Class 1 licenses are issued annually. In 2019, the year MELT consultations were annualled, BC had an increase to 5,000 new Class 1 licenses, which returned to 3,000 in 2020.
- A final decision on implementing an entry-level training requirement in BC will be determined by government in the near future.

SUMMARY:

- Fairness in the trucking industry is important to our government. We have listened and consulted with industry to promote a healthy, stable and balanced sector.
- Under the Container Trucking Act, the Office of the BC Container Trucking Commissioner (OBCCTC)
 issues licences to trucking companies, enforces regulatory compliance, sets trucking rates, and enforces
 them.
- The Commissioner is developing recommendations regarding off -dock container trucking, which will be submitted to government in early 2021. Recommendations are based on a report on Off-dock commissioned by the OBCCTC and MoTI, and subsequent consultation with industry.

BACKGROUND:

The OBCCTC is responsible for regulating the industry, issuing licenses to companies requiring access to Lower Mainland ports and enforcing rates through audits and decisions. The established core principles for the OBCCTC are fairness, stability, efficiency and competitiveness.

There have been three previous work stoppages by truck drivers servicing Port of Vancouver container terminals (1999, 2005, 2014).

The key issues of the 2014 stoppage included:

- Rate undercutting
- o Poor labour practices (driver abuse, underpayment, immigration fraud etc.)
- Port terminal inefficiencies (wait times for drivers/reservation system issues)

In 2014 the Provincial and Federal governments, Unifor and United Truckers Association agreed on a plan to address issues (Joint Action Plan):

- Stabilize rates and end unscrupulous labour practices
- Reform industry and licence newly reformed industry (Fed/Port & Province)
- o End wait times and fix terminal efficiency/reservation issues (Fed/Port)



The OBCCTC was created to enforce legislation

Licensing

From September 2019 to the end of February 2020 the OBCCTC conducted stakeholder engagement on proposed reforms to the Container Trucking Services (CTS) licensing process and the truck tag policy, including updated information requirements and clear evaluation criteria for companies seeking licenses to perform container trucking services to and from Lower Mainland ports and off-dock services.

On July 6, 2020 the OBCCTC issued a bulletin to open the application process for the 2020 CTS license. Applications were due to the OBCCTC by August 4, 2020. On September 9, 2020 the Office of the British Columbia Container Trucking Commissioner (OBCCTC) issued conditional license approval letters to companies outlining the number of truck tags to be assigned to each license effective December 1, 2020.

Off-Dock

In May of 2020, the Province and the OBCCTC commissioned a study to better understand off-dock truck trips that support containerized shipping throughout the lower mainland.

The report was released publicly in September and the Commissioner has actively sought feedback from stakeholders including labour groups who provided written response. The commissioner's report and recommendations are expected in early 2021.

PAST INTERACTIONS:

• The Ministry and OBCCTC provided a container trucking update to members of the Surrey Caucus on July 10, 2020.

DISCUSSION:

Licensing

Within the licensing process, the Commissioner prioritized removing truck tags that were already vacant or were severely underutilized over several years. The licensing process began with a pool of 1,618 truck tags. Following the formal review of applications, a total of 1,557 truck tags were assigned to 78 licenses/companies. Truck tags were assigned to licensees based upon an assessment of an applicant's historic fleet efficiency, compliance history and submitted business case.

The purpose of the licensing reform process was to enhance compliance and to ensure that appropriate amount of truck tags were assigned across the licensed fleet. The process was meant to ultimately benefit drivers by better matching the number of drivers with available on-dock work.

Following conditional approvals, 22 companies as well as the Port Transportation Association sought a stay of the licensing process and applied to seek a judicial review of the license application process. The courts granted the stay application; therefore, these companies continue to operate under their 2018 CTS Licenses pending the results of the judicial review. Timing for outcomes of the judicial review is unknown.

Off-Dock

There is an opportunity for the Province and the Commissioner to take steps to affect positive changes for the industry in response to concerns raised by stakeholders in this off-dock report. The report identified



several important insights that could inform potential amendments to the scope of the Regulation, rates and CTS licenses.s.13 s.13

Any recommended changes to rates and regulation should be considered through the lens of the established core principles for container trucking (fairness, stability, efficiency and competitiveness), and all stakeholders including licensees, industry associations and labour representatives must work together on viable solutions.

APPENDIX A: Questions and Answers

1. What do we mean by licensed and unlicensed off-dock?

Licensed off-dock work is done by companies that are licensed through the Office of the British Columbia Container Commissioner (OBCCTC) and performed by trucks that have been allocated truck tags by a licensed company. Trucking companies are required to adhere to the rate structure set by the Commissioner. There are currently 79 licensed companies and 1632 truck drivers of which 832 are Independent Owner-Operators (I/O) and 800 are company drivers.

Unlicensed off-dock work is done by companies that are not licensed through the OBCCTC and may be doing various types of off-dock work (e.g. moving non-marine containers that are not directly related to on-dock container moves).

Unlicensed companies do not fall into the purview of the current OBCCTC's regulatory authority and so cannot be compelled to pay rates set by the Commissioner.

2. Why is it so difficult to enforce off-dock rates?

The extent of the Commissioner's regulatory jurisdiction and enforcement of off-dock rates extends only to companies that possess a Container Truck Services License which is required to access a port. The Act and Regulation does not apply to companies without a license and as a result they are not accountable to the regulated off-dock rates.

This can be challenging to enforce as some licensed companies have been found to be affiliated with unlicensed companies who conduct off-dock work on their behalf to avoid paying set off-dock rates.

The drayage sector handles approximately 1.75 million containers annually, made up of:

- 1 million on-dock container moves; 50/50 split between imports and exports.
- Approximately 750,000 off-dock container moves, with the majority of moves between container storage facilities and logistics/transload facilities.
- It is estimated that of the 750,000 off-dock moves, upwards of 40% is being moved by unlicensed operators, who either are directly affiliated or have a business partnership with a licensed company.
- o There are reported to be hundreds of off-dock facilities in the lower mainland.
 - (*Note these figures are based on a combination of several data sources including container volume information from the Port of Vancouver and survey / interview data collected during stakeholder engagement for the off-dock report*)

3. What are stakeholder concerns with the current regulatory structure?

Some labour groups representing drivers view the Commissioner's regulatory jurisdiction as insufficient, and believe companies operating outside the CTS license system are working around the rules by underpaying drivers and by extension taking work away from drivers working for CTS licensed companies, particularly I/O drivers who must be paid relatively higher rates for off-dock trips.



Licensed companies without affiliates who are paying the regulated rates are losing business to companies that are working around the regulations.

Licensed companies with affiliates are benefiting by not paying the regulated rate.

Licensed drivers are losing out on work to unlicensed drivers who are paid less.

4. How could these concerns be addressed?

The Commissioner's preliminary views on off-dock policy options are focused on expanding rate regulation to restore a competitive balance in the sector for licensees while increasing the amount of work available for licensed drivers. In doing so, the Commissioner is focused on ensuring that drayage remains cost competitive by removing the current trip rate/hourly rate structure that has been driving up costs, encouraging non-compliance and destabilizing the sector.

5. What will be the economic impact to the gateway by increasing regulation?

The Commissioner will consider steps to mitigate the economic impact to the gateway through his recommendations. The Commissioner has indicated that these will include the introduction of an all hourly rate payment model for the sector. The Commissioner believes that this will increase work opportunities (with a corresponding increase in earnings) for drivers, encourage greater industry compliance with the Act and honour the spirit of the Joint Action Plan by applying a minimum regulated rate to the movement of all containers in the Lower Mainland being used for the marine transportation of goods.

6. In preparing recommendations what tools have been used for evidence decision making?

The Commissioner has a variety of data sources that will be used to inform his recommendations. These include the findings of the third-party off-dock report, feedback from extensive stakeholder consultation, data generated from the Port of Vancouver's truck performance monitoring program and container volume data collected by the Port of Vancouver. This is in addition to the data already collected during the 2018 Rate Review and through OBCCTC audits.

7. What are the commissioner's expected timelines for implementing these recommendations?

BRIEFING NOTE FOR DECISION

ISSUE: Electronic Logging Devices (ELDs)

PURPOSE: Decision to^{s.13} in British Columbia for all drivers who are currently

required to record hours of service.

RECOMMENDED OPTION:

s.13

BACKGROUND:

Commercial vehicle drivers in Canada and the U.S. are required to track their work/rest hours of service (HoS). ELDs are expected to improve on-road safety by reducing potentially high-risk situations where drivers may operate while fatigued. ELDs are also an effective compliance tool to reduce fraud by decreasing the likelihood of a driver reporting incorrect HoS data. They also increase the efficiency of verifying HoS for carriers and enforcement personnel.

In B.C. the existing HoS regulations came in to force in 2007 with all carriers being subject to the same HoS regulations regardless of where they operate. Alberta took a different approach and enforces HoS under two separate regulations, one federal and one provincial.

Commercial Vehicle Safety and Enforcement (CVSE) staff have been involved in the development of the Canadian ELD Technical Standard. As of June 12, 2021, commercial vehicles that cross provincial borders will be required to be equipped with an ELD. B.C., along with other provinces and territories, must determine whether ELD use for commercial vehicles operating solely within their respective jurisdictions will be mandatory or voluntary. ELDs were mandated in the US in 2018.

CVSE staff support the need for a federal solution that ensures a level playing ground for all carriers. This level playing field will also ensure that B.C. sees the full safety benefits of ELDs use since approximately 70-80% of B.C. based carriers would likely be defined as provincial carriers.

The basic HoS regulations are not changing in relation to the number of hours a driver can drive, be onduty, or the off-duty time required to ensure drivers are not operating while fatigued.

The federal regulations require a third-party body to ensure ELD functionality meets the Technical Standard. The regulations provide specific direction on how to maintain HoS if an ELD malfunctions, and the Technical Standard takes privacy concerns into account by ensuring that the vehicle location data recorded is not precise and only records location data at the beginning and end of a period of personal use.

A 2016 cost benefit analysis published by TC concluded the benefits of ELDs outweigh the costs by a 2:1 ratio. s.13

The benefits gained from ELDs will positively affect drivers, carriers, inspectors and auditors due to more efficient roadside inspections and audits, reductions in administrative costs associated with completing and monitoring HoS, and reductions of costs resulting from unsafe driving attributed to driver fatigue and HoS violations.

DISCUSSION:

There have been significant delays for Transport Canada establishing a third-party accredited certification body. As of February 10, 2021, there are no certified ELD devices and it is understood that it will take the certification body six to eight-weeks to certify an ELD. It is anticipated that the first devices will obtain certification in the coming months.

The Yukon's ELD regulations will come into force June 12, 2021 because they are written by reference to the federal Commercial Vehicle Drivers HoS Regulations and automatically update when the federal regulations are updated. However, other jurisdictions are considering extended timelines on implementation and enforcement.

Saskatchewan and Manitoba are over a year away from adopting the ELD mandate.

While the federal regulations in-force date of June 12, 2021, remains unchanged, alignment would impose unfair hardship on B.C. carriers. Industry will need enough time to be able to purchase and install certified ELDs and train their staff to use them during a pandemic. s.13 s.13

Mandating ELDs for all carriers in B.C. would most closely align with B.C.'s current HoS regulations which do not differentiate between federal and provincial carriers. B.C. does not enforce federal regulations and instead only uses provincial regulations that are found in MVAR Division 37. B.C.'s current exemption from HoS for non-passenger vehicles with a GVW of 11,794 kg and below that only operate within B.C. is intended to be maintained. This would mean that any B.C. based carrier who currently needs a paper daily log to record HoS would need an ELD in the future.

B.C will need to undertake industry-specific consultation with industries that are provided specific HoS rules (i.e. logging, oil & gas, motion picture industries), as well as with the accreditation bodies, to better understand whether these HoS rules can be included in the certification process.
