- The development of the Integrated Transportation and Development Strategy (ITDS) will consider efficient transportation networks that support affordable, livable communities.
- While the challenges such as congestion are acute in Metro Vancouver, the Province recognizes ITDS can
 enable growth across the province and especially in areas like Prince Rupert, where significant investments
 are being made by the Port of Prince Rupert and private sector partners.
- Recognizing the benefits of a robust transportation network to BC's economy, the Province is investing in Nanaimo Port Authority's berth expansion and Prince Rupert's Ridley Island Export Logistics Park.
- ITDS also provides a platform to examine levers beyond transportation infrastructure investments and
 optimize those investments with innovative project such as short sea shipping and the rail crossing
 information system as well as improved data collection and sharing to improve the network's efficiency.
- The Ministry will continue to engage Transport Canada's regional staff, as we have during the initiation of the Fraser Valley study.

Background

- Mandate Commitment: With support from the Minister of Municipal Affairs, lead work on the ITDS to ensure greater alignment between transportation and land-use planning.
- Transport Canada, through the National Trade Corridor Fund, has funded a number of projects at the Port of
 Prince Rupert, including the Ridley Island Export Logistics Park, the Zanardi Bridge replacement project, the

ISSUE Safe Restart Funding

PURPOSE: The \$644 million provided to TransLink for Safe Restart funding is for relief from

severe revenue declines, and for incremental costs to respond to COVID-19.

SUMMARY:

• The federal and provincial governments have provided significant funding to TransLink to make sure essential transit services are there when people need them.

- TransLink identified a number of cost-saving measures as part of its service continuity plan
 which were considered under the Safe Restart Agreement.
- The agreement requires TransLink to verify expenditures over the term of the agreement and proposed savings will be reviewed to ensure TransLink continues to fulfill their commitments.
- Our government is working with TransLink to help it manage the COVID-19 response, meet the organization's 10-Year Investment Plan and support B.C.'s economic recovery.
- Maintaining adequate service levels in Metro Vancouver is key to ensuring that British Columbians can safely return to work and help restart the economy.

BACKGROUND:

TransLink has experienced severe fiscal impacts since mid-March 2020, due to the COVID-19 pandemic's effect on travel demand. Low travel demand has significantly reduced TransLink's primary revenue sources (transit fares, fuel tax, and parking tax). Total boardings across the conventional system decreased by 85% in April 2020 compared to the same period in 2019 and plateaued at 40% of it's pre-pandemic levels from November 2020 and into January 2021.

Recognizing the key role of transit in B.C.'s successful recovery, the Province, TransLink and the Mayors' Council entered into a Memorandum of Understanding (MOU) in June 2020. This MOU outlined a process for the parties to explore options that would ensure that TransLink could continue to deliver essential transit service, during and after the pandemic period. An important condition was that TransLink would do this while avoiding service cuts that are not in the public interest and do not align with B.C.'s Restart Plan.

The MOU states that TransLink is seeking senior government support in three priority areas:

- 1. Address the immediate pandemic emergency and help keep transit services operating in Metro Vancouver to support BC's Restart Plan;
- 2. Address the direct operating financial impact (e.g. primarily revenue loss) on TransLink through the pandemic and recovery periods, in order for TransLink to remain solvent and fiscally sustainable; and



 Address funding requirements, including increasing the federal government cost-sharing formula for major and new capital projects and programs that could help to stimulate the economy.

In addition, the MOU recognizes the critical role the region plays in ensuring its transit system's short, medium, and long-term recovery.

DISCUSSION:

In April 2020, in response to increasing financial pressure as a result of the impacts of the COVID-19 pandemic, TransLink announced a series of cost saving measures along with a commitment from the Province to provide support that would reverse layoffs and return to near-regular operations in time for back-to-school in September. TransLink's cost-saving measures included:

- Implementing further suspension of transit services on Bus, SkyTrain, SeaBus, and West Coast Express;
- Issuing temporary layoff notices to 1,492 employees working in various positions at TransLink, Coast Mountain Bus Company, and British Columbia Rapid Transit Company;
- Reducing senior executive salaries and Board remuneration by 10%;
- Reducing organizational costs and program expenditures, including:
 - Deferral of the 2020 Major Road Network operations, maintenance and rehabilitation program funding to municipalities.
 - Deferral of 2020 service expansions; and
- Spending cash reserves to sustain essential service operations through to the end of 2020.

However, on May 8, 2020 TransLink announced that it would rescind layoff notices that were issued to the approximately 1,500 employees and cancel planned service cuts. In order to maintain appropriate and responsive service levels, TransLink's service levels cannot be less than 100% of pre-COVID levels even if ridership is only between 60-70% of pre-COVID levels due to Provincial Health Officer mandated capacity limits on TransLink vehicles.

Following TransLink's agreement to rescind layoff notices and keep service levels at 100%, the Province signed on to the MOU with TransLink and the Mayors' Council and worked with the federal government to secure one-time emergency operating funding for B.C.'s transit agencies, including TransLink.

As part of this process, TransLink was required implement cost saving measures over 2020 and 2021, as outlined below and in Table 1.

- Deferring planned service expansions;
- Corporate and other non-critical operations budgets reduced; and
- Capital projects deferred including Major Road Networks (MRN).

This immediate relief for TransLink in the short-term has allowed TransLink to set their budget and service levels for 2021 and maintain service levels that adapt to changing demands while minimizing service reductions or pass-up trends as much as possible.

Next Steps

Provincial and TransLink staff are working closely to report out on the status of the agency's operations and finances as they relate to COVID-19 impacts and recovery, mitigation strategies and outcomes and other commitments set out in the MOU. This issue will be examined further as part of that process.

If the Province determines that TransLink's failing to pursue and obtain approval of the 10% reduction in executive and Board renumeration is in contravention of Safe Restart Agreement, there may be near-term opportunities for the Province to require TransLink to follow through on this cost-saving measure.

In updated modeling from TransLink, the agency states that anticipated fuel tax revenue for 2020 and 2021 will be almost \$30 million less for the combined years than was projected in the Safe Restart agreement. TransLink also estimates that lower than projected ridership will result in approximately \$108 million less in fare revenue for the 2020 and 2021 combined years.

Staff from the Ministries of Transportation and Infrastructure and Finance are also working with TransLink to develop a suitable range of potential regional funding tools for the near-, medium- and long-term to help contribute to sustainable and predictable revenue sources. This working group will analyze options through the first half of 2021, and then bring forward options for consideration by policymakers.

APPENDIX 3: Safe Restart Funding Allocations

On Sept. 18, 2020, the federal and provincial governments confirmed that TransLink, BC Transit and BC Ferries would share more than \$1 billion under the federal-provincial Safe Restart Agreement, which is cost shared 50-50 by both governments.

Contribution agreements with each agency have been finalized. \$1.038 billion in Safe Restart funding will be allocated as follows:

TransLink:

TransLink is receiving one-time funding of \$644 million. This not only helps ensure the people of the Lower Mainland have access to transit when they need it, but also that fares will be kept affordable.

- \$600 million will help cover expected 2020 and 2021 calendar fiscal year operational losses caused by the COVID-19 pandemic and help continue transit services as part of BC's Restart Plan.
- \$44 million will help ensure TransLink can limit average annual fare increases to 2.3% until the end of 2024.

BC Ferries:

BC Ferries is receiving one-time funding of \$308 million:

- \$280 million will help cover expected 2020-21 and 2021-22 fiscal year operational losses caused by the COVID-19 pandemic and help continue core ferry service levels as part of BC's Restart Plan.
- \$24 million to will help ensure BC Ferries can limit average annual fare increases to 2.3% until March 31, 2024, in line with the rate caps established by the BC Ferries regulator prior to the onset of the pandemic.
- \$4 million to help ensure continuation of discretionary sailings (those above contract levels that may
 have been discontinued due to COVID-19) on the minor and northern routes over the next three years.
- Where appropriate, BC Ferries will aim to provide ridership capacity at 20% above anticipated demand on all routes (other than northern routes) to minimize sailing waits during peak times.

BC Transit:

BC Transit will receive \$86 million to help support municipal partners that depend on fare revenues as part of the provincial-municipal partnership to deliver BC Transit services throughout the province. They, too, have been impacted by the pandemic.

- The full contribution will help cover expected municipal partner losses in the near term caused by the COVID-19 pandemic, which include added operational costs to maintain safe transit services.
- The contribution will help municipal partners to limit average annual fare increases to 2.3% until March 31, 2024.
- BC Transit will support BC's Restart Plan by maintaining essential service levels in all its service areas, including BC Bus North.

- BC's recovery plan provides supports for many of the areas identified by UBCM including economic diversification, public transit, rural connectivity, and emissions reductions.
- The ministry is supporting the economic recovery of the Province through the delivery of s.17 in infrastructure investment to improve access to remote communities and increase the resilience of the transportation network.

BACKGROUND:

Enhanced federal funding for capital projects

There is a need for augmented investment to facilitate long-term sustained economic recovery.

- Initial focus should be on smaller-scale investments that can put people to work quickly and highway rehabilitation projects that can support short term stimulation.
- Next focus should be larger-scale investments directed at enhancing trade, supporting tourism, responding to climate change, and getting people back to transit.
- Key strategic priorities in BC include major trade corridors such as the George Massey Crossing and Highway
 1 through the Fraser Valley, economic tourism generators such as the Bellville Ferry Terminal in Victoria,
 electrification of marine and bus fleets to reduce green house gas emissions, and supporting public transit by
 extending SkyTrain to Langley and advancing Phase 3 of the Mayors' Council Transportation Vision.

Trade corridors and market access

On BC's commitment to competitive trade corridors (included in speaking notes for CoM):

- As part of StrongerBC, B.C.'s Economic Recovery Plan, B.C. recently announced a provincial investment of \$25 million that will improve and expand operations at the Port of Prince Rupert.
- This investment builds on the \$49.8-million federal contribution through the National Trade Corridors Fund and will project support B.C. and Canadian exporters' competitiveness and opportunities in international trade.
- The project, led by the Prince Rupert Port Authority, will improve and expand infrastructure at the Ridley Island Export Logistics Platform by creating a platform to enhance the port's capacity for transloading B.C. and western Canadian natural resource products for containerized export by sea to international markets.

Below was shared as background/ discussion points previously with AB/ SK/ MB some months ago, as part of a discussion on areas of potential collaboration amongst western provinces. The discussions didn't culminate in any conclusive action – but these topics were raised as areas of shared interest:

These bullets don't call for recapitalization of the fund, however as discussed don't think it's something we'd necessarily prioritize advocating for at this time.

Updates to NTCF

- In January 15, 2019 the National Trade Corridors Fund put out its second call for proposals, with a focus on improving the fluidity / performance of the transportation system in order to increase existing or generate new overseas exports.
- Up to now, provinces have worked independently when prioritizing trade enabling infrastructure. The same can be said for NTCF applications although many of the projects put forward have the potential to benefit multiple provinces.
- Although the benefits of trade enabling infrastructure projects support the national interest, under the
 current funding formula (50% federal contribution with balance funded by partners) the financial burden
 falls disproportionally to partner province and/ or municipality.
- There is a need to revisit the funding formula for infrastructure projects, removing the burden on partner provinces / municipalities and increasing the federal ratio given that these projects provide national benefit.

Another topic that may be relevant is low carbon trade corridors – again here's background that was shared previously with AB/ SK/ MB as part of the discussion on interprovincial collaboration some months back: Low Carbon Trade Corridors

Transportation systems around the world have begun to adopt new technologies and lower carbon alternative fuels. New alternatively fueled vessels (e.g. LNG), vehicles (e.g. electric/ hydrogen) and equipment are examples of efforts to reduce carbon footprint. A range of potential infrastructure and investment solutions could help accelerate the adoption of alternative fuels for vehicles, vessels, and trains as well as land-based operations; these could include initiatives in various modes such as:

- Road Assess infrastructure and financial barriers to alternative fuel vehicle adoption;
- Rail work with industry to accelerate alternative fuel adoption;
- Terminals Explore opportunities to support conversion of container terminals equipment to alternative fuels; and
- Marine Examine the opportunity, and specifically the required distribution infrastructure, for B.C. to support alternative fuels vessels.

I'm wondering if you can share with me the final package of materials submitted by JERI to Minister Robinson for the COVID funding programs the teams have been designing, both the OMNIBUS proposal for the 21/22 budget and the near-term year-end funding for critical sector partners who are struggling to provide service to remote and underserved communities.

Also, while we're moving forward with the Lady Rose, we also need to act quickly on the intercity bus/motor coach plan. So, I would like to see our specific proposal and how quickly we can action funding. As I understand it, the urgency is increasing and we will need to take action well before the end of the fiscal year and more like before the end of this month. I also expect it is likely that we will need to establish a granting program with service conditions that will likely extend beyond the fiscal year and into June or so (or until we can anticipate a shift in travel restrictions and other COVID orders).

I'd like to suggest that we bundle the proposals for funding as well as insurance relief (or anything else we propose) and check in on those in the next day or so, and plan to report back to the Minister by Thursday (ideally).

Let me know if you have questions or want to discuss. For the purposes of time, we could leverage some of the time Steve and I already have booked this week.

Hi All,

We now have a bit more clarity on the ask from yesterday. Two things we're looking for by Wednesday if at all possible:

- 1. Identification of StrongerBC programs in your Ministry that are over-subscribed or where your ministry modelling indicates demand will exceed the funding currently available for this FY. This could include existing TB subs you've submitted or are in the process of developing.
- 2. Identification of gaps where the StrongerBC programming isn't meeting it's intended policy objectives. Examples could include the exclusion of non-profits from programming, exclusion of businesses that were too large, funding amounts not being sufficient to meet industry need, eligibility requirements that may be barriers etc. The intent is to identify where changes could be made to existing programs or where there are wholesale gaps in programming.

Next Steps:

- JERI will roll up the info and test it Friday with decision makers to make sure we're on the right track.
- We'll be sending around a template later this week to get more details on the programs you identify for Wednesday. Template will look at a few things including how much funding is needed and a few scaling scenarios and what changes can be made to existing programming.
- Also a note, we're doing a roll up of everything in the spreadsheet for Thursday which will likely be shared with our Minister who we expect will share it with his colleagues. Flagging as we want to make sure we don't miss updates that your respective ministers may expect to see included in that package.
