



Currently Highway 91 westbound is fully closed at the Highway 91A offramp due to an MVI involving two commercial vehicles resulting in lumber being scattered across the westbound lanes.

Westbound traffic queuing is over both the Queensborough and Alex Fraser Bridges. Detours are available via other major crossings, however, there are no local detours.
