Location: 2950 Jutland Road and surrounding buildings, Victoria.

Circumstances: Kill The CGL Drill - Demo at BCOGC. Organizers are encouraging participants to wear black and to make signs, and are assembling at 2950 Jutland. Organizers do have volunteers to act as liaisons with police, civil servants, and to de-escalate if required. The group is targeting the BC Oil and Gas Commission and associated entities as the groups permitting Coastal GasLink.

There is likely to be disruption to traffic in the area of the demonstrations. Consideration should be given to the potential for some demonstrators to attempt to gain entry to government buildings. There is also the potential for staff and clients to be confronted and engaged by demonstrators.

Dear Minister of Land, Water and Resources and Minister Responsible for Fisheries, Honorable Josie Osbourne, Minister of Energy, Mines and Low Carbon Innovation, Honourable Bruce Ralston, and Minister of Environment and Climate Change Strategy, Honourable George Heyman:

Firstly, your collective experience appears to be an excellent 'fit' for your roles in the BC government - degrees in law and history, social, environmental and labour activism and fisheries biologist for the Nui-chat-nulth Council as well as executive director of an environmental education non-profit organization. Concerned Canadians can hope that with your involvement and leadership, portfolios will level the lobby playing field for the rights of Treaty 8 Nations, as well as the UNDRIP for BC Nations on (unceded lands) and BC will significantly lead Canada in environmental climate change.

I have six main issues for which I seek your input to better understand:

- i) the colonial injustice and disrespect towards the hereditary Wet'suwet'en chiefs and many clan members on their unceded land by both federal and provincial governments allowing this project to proceed. How can varying levels of government be more involved in nation to nation agreements beyond the colonially structured tribal councils with the Crown, to include the hereditary systems of governance? Can one hope that your offices will step in like with the Blueberry Nation?;
- ii) the reported blasting by CGL industries near salmon spawning watersheds which I believe is an issue for all of your mandates, and which according to the federal DFO legislation is illegal. Why is this not being halted and prevented from reoccurring by allowing Wet'suwet'en chiefs to oversee their own lands without restrictions? Surely the safe keeping of wild salmon for generations to come can continue to be entrusted to the Wet'suwet'en hereditary chiefs as they have done for millennia?;
- iii) the planned hefty provincial and federal funding directed to CCUS as well as fracking (eg. in the Mountney Formation) that infringes on Treaty 8 and other Nations as well as by far gives the giant trillion dollar profit making fossil fuel companies like Woodfibre LNG (Skwxwú7mesh land) and the Pathways Alliance unnecessary public purse handouts when they are not matching this level of investment for wind, solar, wave, geo thermal and biofuel combined. Pathways Alliance invested over 20 billion dollars in R & D in 2020 (StatCan) yet is only investing 16.5 billion in CCUS until 2030. Moreover, what they are capturing is no where near what they could be if they put more money into R & D. Shell just announced double the profits for the past two quarters of \$11.5 billion, well after COVID recovery (GlobalNews). Clearly they are taking advantage of political offerings to do the minimum while taxpayers carry the burden of climate change efforts. Furthermore, clear scientific data shows existing plants like the Shell Boundary Dam 3 in Saskatchewan are actually have more emissions than they are capturing (7.5 million tonnes vs 4..5 million tonnes) and failing to meet capturing targets, even when drastically lowered (promised 90% to 65%) (The TYEE). Nor is Shell and other fossil fuel companies accountable for the emissions of climate and waterway damaging methane gas due fracking under the guise that it is

'cleaner' than coal and that we need to 'transition'. This is really about money, big profit money and creating enough spin-doctor 'smoke' in the media to make them look like they are doing more than due diligence when indeed they are doing less. Will you reduce and influence the federal affiliates to reduce fossil fuel 'incentives' for CCUS and fracking to an industry that can pay several times over, increase the windfall and carbon taxes for these companies that will force them to find their profit differently, and invest in those geographical areas with hereditary chief agreements to longer term solutions with the greenest technology that is already proven itself in net zero emissions? - Scotland, Japan and France have made outstanding breakthroughs in these fields;

iv) the erroneous 'green' label given to wood pellet industries that are going seemingly unchecked and are responsible for significant clear cutting (which I have seen in real time with my own eyes), without Nation stewardship or sufficient remuneration to the latter for what is being taken from their lands. Will you give stewardship and land back profit rights to First Nations to oversee pellet industries and adjust current legislation to ensure legitimate use of wood scrap occurs vs clear cutting and that the pellets are being purchased for green solutions not to run carbon-emitting British plants in place of coal and gas?;

v) the crises facing the Great Bear Sea and Northern Shelf Bioregion due to overuse and climate change. Will you act vigorously to ensure unbiased MPA network survey results turn into safeguarding this 'marine protected area'?;

and vi) cruise ship access to sensitive coastal waters en route to Alaska where they can and are dumping their waste in Canadian waters as well as causing distress to marine life such as whales and sharks because BC and federal legislation allows it. Will you change the 'voluntary' component of the relevant BC legislation that would restrict ships from dumping, as Washington State and the US have done and revisit cruise ship and large tanker accessibility?

These tasks in front of you are daunting, just like finding justice for residential and welfare system Indigenous families yet the BC government is just about to take a decent, courageous legislative step on that! Bravo!

I would have faith in your experience, passion and mandate, that things can and will change over time...yet the problem is the clock is ticking - climate change won't wait and action needs to be as immediate as possible..

You have the support of many Canadians, not just those who live in your fine province, and we truly look to you for hope, moving forward in a good way, and for a better, greener future.
