ISSUE: Update on the development of a B.C. Biodiversity and Ecosystem Health

Framework and next steps

KEY POINTS:

 The attached draft B.C. Biodiversity and Ecosystem Health Framework (the Framework) has been updated since it was presented to the Deputy Minister Committee on Natural Resources (DMCNR) in May 2023 based on review and feedback from select advisors.

BACKGROUND:

- Engagement with First Nations and multi-sectoral partners (i.e., Union of B.C. Municipalities (UBCM), Council of Forest Industries (COFI), industry sectors, Environmental Non-Government Organizations (ENGOS), and academics) was conducted in collaboration with Ministry of Forests (FOR) from January to May 2023. This included broad forums, regional sessions and virtual focused sessions on the Biodiversity and Ecosystem Health Framework.

- Internal engagement across Ministries has been ongoing and is now focused on operational aspects of the Framework (how will it affect operations across Natural Resource Sector Ministries).
