Mill closures – Houston & Quesnel

Advice and Recommended Response:

- My sympathies go to the workers and their families affected by these two closures.
- I understand the companies are taking steps to address workers' needs either through
 offering jobs elsewhere in the companies, or providing assistance in searching for other
 employment. Provincial and federal assistance is also available for workers affected.
- Unfortunately, given the mountain pine beetle infestation, this is not unexpected. This government has invested over \$884 million to mitigate the beetle's economic and environmental impacts, which includes supporting regional beetle action coalitions and economic diversification funding through the Northern Interior Development Initiative Trust.
- As well, both areas are seeing an increase in mining activity.

KEY FACTS REGARDING THE ISSUE:

On Oct. 24, 2013, Canfor announced it would be closing its Quesnel mill, affecting 209 employees, and West Fraser announced that it would be closing its Houston mill, affecting 225 employees. The mill closures are being attributed to the declining timber supply in the Interior due to the mountain pine beetle infestation. The closures will take effect March 17, 2014. At the same time, the companies announced they would be transferring forest licences to each other, subject to regulatory approvals.

In announcing the closure of the Houston mill, West Fraser also summarized its \$350 million in capital investments from 2012-2014, including major upgrades during 2014 for its sawmills in Smithers and 100 Mile House.

Houston impacts – About 3,600 people live within Houston's municipal boundaries with another 2,000 in surrounding areas. Canfor operates the other lumber mill in town. There is also a pellet plant (Houston Pellet Limited Partnership) and Pleasant Valley remanufacturing. The Huckleberry mine recently expanded, extending the life of the mine until 2021 and supporting 260 existing jobs and creating 70 new jobs. West Fraser has indicated that it has openings for about 70 employees in other operations and will provide short-term job search assistance for those who need to find employment elsewhere.

Quesnel impacts – About 10,000 people live within Quesnel's municipal boundaries with another 13,000 in surrounding areas. Other lumber mills in Quesnel are operated by Tolko, C&C Wood Products and Tolko. There are also two pulp mills (Cariboo Pulp & Paper Co. Ltd. and Quesnel River Pulp), a pellet mill (Pinnacle), a veneer/plywood and panel plant (West Fraser) and log home manufacturers. However, mining activity in the area is picking up, at Barkerville Gold Mine's Bonanza's ledge, Taseko's development of its Gibraltar Copper Mine and lots of exploration activity near Nazko.

Quesnel TSA

The Quesnel TSA has one of the largest proportions of pine and has been extremely hard hit by the mountain pine beetle. The current AAC, last set in June 2011 is 4 million cubic metres. Timber supply modelling shows that can be maintained until 2019, which it would then need to drop to 3.6 million cubic metres for five years before falling to 1.15 million cubic metres – as compared to a pre-beetle AAC of about 2.3 million cubic metres.

West Fraser currently has two replaceable forest licences totalling 575,020 cubic metres/year and holds another 216,667 cubic metres in short-term non-replaceable forest licences. s.13, s.17

Tolko has a replaceable licence of 259,704 cubic metres per year. Another 11 licensees hold over 1.8 million cubic metres in short-term licences.

Separate from the TSA, West Fraser's TFL 52 has an AAC of 918,014 cubic metres/year near Quesnel.

In a few moments, Canfor CEO Don Kayne will announce the permanent closure of our sawmill in

Quesnel, British Columbia, effective March 2014. Canfor will also be announcing an agreement to exchange our tenure rights in Quesnel for a portion of West Fraser's tenure rights in Houston, British Columbia.

There is simply not enough fibre in the Quesnel area to support all of the mills in the community. Since Canfor re-opened the Quesnel mill in June 2010, this facility had been able to produce lumber from some of the most heavily mountain pine beetle impacted fibre in British Columbia, 100% of which was shipped to China. We are extremely proud of what was achieved at this mill, and are saddened to see it come to an end.

Canfor has 209 employees at the Quesnel facility, all of whom will be offered a position elsewhere in the company. For those that prefer to remain in the community, we will be working with our regional competitors and other employers to find positions for as many of our Quesnel employees as possible. Labour demand in BC's forest industry remains high and we are confident that our people will be placed quickly.

We are extremely appreciative of all that the Ministries of Forests, Jobs and International Trade have done to support the BC forest industry in the wake of the mountain pine beetle. Your agencies have taken all possible steps to address the impacts of the mountain pine beetle epidemic while developing new offshore markets and ensuring a forest policy framework that allows our industry to be globally competitive. That our industry had the China market to support our companies, workers and communities through the US housing market collapse was largely the result of government policy and market development work of a decade ago. We think it is critical that this work continue.

Following the public announcement at 3:00 p.m. today, I would ask that you pass this e-mail on to other Ministry officials that should receive it. Canfor appreciates that there will be dimensions of this announcement that you may wish to discuss with us in further detail. We would be pleased to arrange a conference call or briefing within the next week.
