BRIEFING NOTE Pleasantvale Groundbreaking

BACKGROUND

- Pleasantvale is a 50-unit housing development for low-income seniors built in the mid-1950s by the Rotary Club of Kelowna.
- In June 2011, the Pleasantvale Homes Society transferred ownership of the property to BC Housing and the City of Kelowna provided additional land to expand the development.
- In Sept. 2013, BC Housing led a competitive process to select a non-profit housing society to lead the redevelopment and operate the affordable housing, once complete. The successful proponent was the Society of Hope, a non-profit that has been providing quality, affordable housing to low-income residents in the Central Okanagan since 1989.
- In July 2014, following an extensive public consultation process led by BC Housing, Kelowna City Council approved the rezoning for the project.
- The redevelopment will see the 50 aging units replaced and 20 affordable rental homes for families added to the site.
- Construction is scheduled to be completed by spring 2016.
- The total capital cost of this project is approximately \$14.8 million.
 - The B.C. government arranged approximately \$12.4 million in construction financing and provided the land, originally donated by Pleasantvale Homes Society and the City of Kelowna, valued at \$2 million.
 - The Governments of Canada and B.C. provided a combined investment of over \$5.6 million towards the purchase of the 20 affordable rental townhomes for families with low to moderate income. The purchase will take place upon building completion.
 - In addition to the land contribution, the City of Kelowna credited \$154,070 in development cost charges and granted \$273,171.
- **Note** there is one holdout property owner on site. The City of Kelowna is working with the property owner with the goal of purchasing the land.

Housing Investments in Kelowna:

- Last year, the B.C. government invested over \$10.6 million to provide subsidized housing and rent supplements for approximately 3,000 households in Kelowna. This includes providing support for more than 1,500 senior households.
- Since 2001, nearly 740 units of affordable housing have been developed or preserved in Kelowna.
- The provincial government provided over \$5 million last year to support more than 560 housing units for people who were homeless or at-risk of homelessness in Kelowna.

QUESTIONS AND ANSWERS

What is happening?

The Governments of Canada and B.C. provided a combined investment of over \$5.6 million towards the purchase of the 20 affordable rental townhomes for families with low to moderate income.

When will the new development be complete?

Construction is scheduled to be completed by spring 2016.

What will happen to existing tenants during construction?

During construction, many tenants have been provided with alternate accommodation at the same rent they pay now. BC Housing will cover any additional rent costs during the transition, plus moving expenses.

Those residents will have the first option to move back into a new unit once the building is complete.

Other resident have been able to remain on site in their existing unit which will be demolished once tenants are able to move into the new building.

Both on-site and off-site tenants are being provided with regular updates as the construction progresses.

The B.C. government provides support to **more than 1,500** seniors' households in Kelowna through a range of housing options, including:

- More than 700 households receive Shelter Aid for Elderly Renters (SAFER) benefits. The program was expanded in 2006 and enhanced in 2014 to better meet the needs of low-income seniors. With the new enhanced benefit the average monthly payment is expected to increase from approximately \$150 to \$190.
- More than 210 seniors live in supportive and assisted living units in Kelowna.
- There are more than 620 affordable homes for independent seniors in Kelowna.
- The <u>Home Adaptations for Independence</u> program offers financial assistance for home adaptations to help eligible low-income seniors and people with disabilities improve accessibility and safety in their home.

More than 380 new units of housing for seniors and people with special needs have been built in Kelowna since 2001.

The B.C. Government provides support to **nearly 770** low-income families in Kelowna through a range of housing options, including:

- There are over 15 provincially-funded spaces available for women and women with children who are at risk of violence.

Over 100 units for families have been created in Kelowna since 2001.

New Affordable Housing

• Since 2001, nearly 740 units of affordable housing have been developed or preserved in Kelowna.

Homeless Supports Overview

Last year, over \$5.3 million was provided to support over 560 housing units for the homeless or those at risk of homelessness in Kelowna, including:

- Approximately 80 year-round homeless shelter spaces are provided through the <u>Emergency Shelter Program</u>; more than 400 subsidized or supportive units for homeless or at risk individuals; and approximately 80 homeless rent supplements.
- Additional shelter spaces are available during extreme weather.
- <u>Homeless outreach</u> and shelter workers in Kelowna connected people who are homeless or at risk of homelessness to housing, income assistance and a range of support services.

The B.C. government partnered with the <u>City of Kelowna</u> to build new supportive units for those who are homeless or at risk of homelessness. All three developments - Tutt Street Place (39 units), Willowbridge (40 units) and New Gate Apartments (49 units) - are open.

Nearly 250 units have been developed or preserved to house homeless or at risk individuals in Kelowna since 2001.

Aboriginal Housing

There are **approximately 95** units of designated Aboriginal housing in the City of Kelowna.
