We have another query on a request that I need some guidance and a response on. This one was sitting with Dr. Emerson; however, FOI Ops are wanting a response this week.

For context:

· The request we received was:

- All records of requests for reconsideration made to the Provincial Health Officer regarding provincial health orders from March 2020 - April 21, 2021. (Date Range for Record Search: From 3/20/2020 To 4/21/2021) Date Format is MM/DD/YYYY
- Back in May 2023, we had submitted a fee estimate, as the search is broad and had produced a large number of records to review. The Applicant didn't want to pay the fee and had submitted a fee waiver, advising the information is in public interest. The fee waiver was denied and signed off by the Deputy Minister's office, with the reasoning highlighted below.
- The applicant has responded with the following:
 - o My argument is this is public interest because, PHO relied upon the high volume of requests to make this suspension/variance of section 43 of the health act. Therefore it is in the interest of the public to review these request to ensure transparency, there is no expiry date on this order which gives the health officer extraordinary power. One thing the health officer may do is delegate under section 43 here: (8) If a health officer is unable or unavailable to reconsider an order he or she made, a similarly designated health officer may act under this section in respect of the order as if the similarly designated health officer were reconsidering an order that he or she made. The PHO has not designated another health officer to review these application for reconsideration and could suspend this section of the health act indefinitely. This is unreasonable, as the situation has evolved and there may be critical information that was not available at the time. These request for reconsideration directly relate to the order to suspend section 43 of the health act, that may place undue unknown hardships on British Columbians who would like to apply for reconsideration, and who have applied and are not being reviewed by anyone.
