This report provides the number of emergency department visits over a number of fiscal years. The report shows unscheduled visits by CTAS (triage) level, or whether the patient left without being seen. Data is reported at the Health Authority level and includes all providers that report emergency department visits in the province; this includes Acute Care Hospitals, Health Centres and Diagnostic & Therapeutic Centres. Primary Care Centres are excluded. Data used to compile the report comes from the Operational Administrative Support Information System (OASIS)/Health Authority Management Information System (HAMIS) data warehouse.
