## **BACKGROUND:**

**Zhang Yanming**, Director General of Henan Provincial Department of Commerce is leading a delegation of 16 government and business representatives to Canada in November to officially open the Henan Investment Promotion Bureau Representative office in Vancouver.

This is intended as a courtesy meeting with Mr. Zhang to discuss how BC and Henan can work together to support two-way trade and investment. It is Mr. Zhang's second visit to BC in his role as Director General of Henan Provincial Department of Commerce.

**Henan Province** is the 5<sup>th</sup> largest economy in China (2017 GDP), with a population of 100 million. Traditionally, agriculture and mining are the province's two pillar industries. Recent development has been focused on transforming Henan into a transportation hub in Central China.

**Welcome Lunch** - A welcome lunch for DG Zhang Yanming's delegation was organized upon their arrival in Vancouver on November 27<sup>th</sup> by the Canada-China Society of Science and Technology (CCSST), the Canadian Community Service Association (CCSA), and the Henan Business Association of Canada (HBAC). (Backgrounder on host organizations are attached) An opening ceremony for the new Representative Office of Henan Investment Promotion Bureau in Canada was held during the luncheon. Zhengzhou, the capital city of Henan has a sister-city relationship with Burnaby- and Burnaby City Councillor James Wong attended the welcome lunch.

CCSST was established in 1993 to promote exchange and cooperation between Canada and China in the field of science and technology. Over the past 25 years, CCSST has grown into an organization of 2,000 members, most of which have master and doctoral degrees across all fields of scientific research, industry, commerce and education. Currently Jerry Li is the President of CCSST.

CCSA was established in 2002 to serve the Chinese community in BC, promote equality and unity in Canada's multicultural society, as well as facilitate cultural and economic exchanges between China and Canada. Currently the Association has over 20,000 members and Niu Hua is the President of CCSA.

HBAC was established in 2009 to assist immigrants from Henan to settle in Canada, build business connections with BC, and strengthen people to people ties between Henan and BC, Currently HBAC has 2,000 members. Rose Yang is the President of HBAC.

## **DISCUSSION:**

## **Transportation & Logistics**

- Henan aims to establish the province as a national transport and logistics hub by taking advantage of the Belt and Road Initiative and free trade zone policies.
- Henan currently has 29 international airfreight routes, including a direct flight between Vancouver and Zhengzhou, launched in November 2016.
- Vancouver International Airport (YVR) recently started its multi-year expansion plans (75 major projects with a budget of \$9.1 billion) to enhance YVR's competitive position as a world-class connecting hub.
- YVR's expansion provides opportunities to work with Henan in attracting more cross-border traders, as Henan aims to become an international air logistics centre.

## **Agrifood**

- BC produces and exports high quality food and beverage products that are in demand by Chinese and Henan consumers.
- China is B.C.'s second largest market for agrifood and seafood products, with over \$407 million in exports in 2016. That represented 10.6 percent of the \$3.8 billion worth of agrifood and seafood products B.C. exported that year.
- Henan-based Harvest land International trade Co., Ltd, sourced 50 tons of blueberries and 100 tons of cherries from BC in 2017.
- Henan-based CAC Natural Foods Inc, as the exclusive distributor of Webber Nature supplements, expects to sell over<sup>s.21</sup> of Webber Natural products in 2018.

## Technology & Innovation

- BC is home to a growing commercial technology sector with global firms like Microsoft Corporation, Intel, IBM, Broadcom, 3M, Oracle, Honeywell.
- BC has the right conditions to attract technology innovation and investment, we are pleased to welcome companies like Richway to establish business here in BC.
- As a result of a mission organized by Henan Medical Device Chamber of Commerce to BC in 2014, Henan-based Zhenghe group signed an agreement with Ondine Biomedical to form a joint venture partnership in China.

 Henan Capital Construction Science Experiment Institute Co., Ltd. signed an MOU with BC company Stratocom in April 2018 to promote Stratocom's meter reading and infrastructure hazards detecting technology in China.

## SUGGESTED KEY MESSAGES:

- The rapid expansion of e-commerce in China presents great business opportunities for BC exporters - including with Henan Province. BC companies are well-positioned to take advantage of the growth in Chinese online commerce.
- I would like to congratulate Henan on the opening of your Investment Promotion Bureau's Representative Office in Vancouver.
- The BC Government welcomes overseas investment from China. We strongly
  encourage and support Henan companies to explore business opportunities in
  BC, from agrifood products export to China to establishing technology
  partnerships in BC.
- Our ministry staff are keen to facilitate Chinese business expansion in BC, while our Trade and Investment Representative Office in Shanghai will continue to work closely with Henan Department of Commerce to enhance trade and investment activities.
